**V&AC, CC-I Cr.No.9/AC/2017/CC-I u/s 7 and 13(2) r/w 13(1)(d) of Prevention
of corruption Act 1988, FIR details**

Based on the order of Director, DVAC in PE 329/17/MED/CSU-I, Dated
4.10.2017, a Preliminary Enquiry was conducted in DVAC, CSU-I unit, The
Preliminary enquiry in PE 329/17/MED/CSU-I reveals as follows :-

Dr.K.Sridhar who is now under suspension from 28.09.2017 worked
as Director and Superintendent, Regional Institute of Ophthalmology And
Government Ophthalmic Hospital, Chennai had demanded and obtained bribe of
Rs 500/- , for issuing eyefitness/blindness certificate.

Based on the Whatsapp video uploaded in the Social Network
Preliminary enquiry is conducted. In the whatsapp video available in the Social
Network, it was alleged that Dr. Sridhar who is working as Director and
Superintendent, Regional Institute of Ophthalmology And Government
Ophthalmic Hospital, Chennai had demanded and obtained Rs. 500, for the
purpose of issue of eyefitness/blindness certificate to the partially impaired
person.

Dr. Geetha, who is working as Additional Director of Medical Education,
(H&D), Directorate of Medical Education, Kilpauk, Chennai-10, had conducted
an enquiry along with Dr.P. Vasanthamani, Dean, Kilpauk Medical college
Hospital, Chennai, based on the instruction of Director of Medical Education.
She further stated that she had conducted an enquiry on 26-9-2017. The enquiry
report prepared by Dr. Geetha on 26-9-2017 is collected.

At the time of enquiry Dr. Sridhar accepted that he used to receive Rs 100 or 200 from the beneficiaries at the time of issue of blindness certificate/eyefitness certificate. Further, she had stated that on 26-9-2017, she had prepared a enquiry report along with Dr.P. Vasanthamani , in that enquiry report Dr. Sridhar had accepted receiving of bribe and had signed in the enquiry report. This statement of Dr. Sridhar is corroborated by Dr. Vasanthamani also.

Further, as per the statement of Dr. Geetha, there is no need for Dr. Sridhar to collect money from the beneficiaries. If at all money has to be collected, then it is the duty of Tr. Jothi Ramalingam, who is working as Assistant in O/o the Director and Superintendent, Regional Institute of Ophthalmology And Government Ophthalmic Hospital, Chennai to collect money and issue acknowledgement.

In this regard Dr. Geetha had sent a special report to Director of Medical Education, Kilpauk on 27-9-2017, in that report, she had stated as follows :-

It is ascertained that there are two types of Medical Boards that are functioning in the hospital which are;

- 1) **Regional Medical Board ;-** Where the persons are referred from other office and the persons are tested by a single Medical Officer and for which a sum of Rs. 60/- is being collected and Rs. 30/- is paid to the Medial Officer.
- 2) **Another Special medical Board is also being constituted in the Institution for the persons who are referred by the other offices where three Medical Officers are verifying the patients and Rs. 200/- is collected from the persons. Out of which Rs. 50/- is paid to the three medical officers of board.**

On being shown the video, Dr.K. Sridhar, Director Regional Institute Ophthalmology and Government Ophthalmic Hospital, Chennai accepted that the person in the video is him but he stated that he doesn't remember demanding Rs. 500/- for issuing the certificate. However, he has also stated that the voice is overlapping and it does not resemble his voice.


On enquiry, Director and Superintendent, RIO & GOH, Chennai himself has accepted that usually he charges Rs. 100-200 for issuing eye fitness and other certificates and he has also informed that he is not maintaining any record for issuing such certificates.

From his statement in writing and on enquiry, it is evident that he usually charges Rs. 100-200 for issuing fitness including blindness and other certificates. Considering the evidence at hand we conclude that there is a prima facie case against the individual.

Hence, from the above and from the video clippings which is said to have been taken from 18.09.2017 to 23.09.2017, it is evident that there is enough evidence against Dr. Sridhar, for his demand of bribe from the beneficiaries.

Hence, the allegation that Dr.K. Sridhar, who is working as Director and Superintendent, Regional Institute of Ophthalmology And Government Ophthalmic Hospital, Chennai, a public servant, that he had demanded and obtained Rs. 500/- as gratification other than legal remuneration, as a motive or reward for issuing blindness certificate/eye fitness certificate from the beneficiaries and as a public servant committed criminal misconduct by corrupt or illegal means, obtained for himself Rs.500/- as pecuniary advantage for issuing blindness certificate/eye fitness certificate from the beneficiaries is held as substantiated. Tamil Nadu Vigilance Commission in Letter No 3914/VC-1/2017-1, Dated:31.10.2017 has accorded permission to the Directorate of Vigilance and Anti-Corruption to register a Regular case against Dr.K. Sridhar, Director and Superintendent, Regional Institute of Ophthalmology and

Government Ophthalmic Hospital, Chennai(now under suspension). Based on that permission Director, DV&AC through his letter dt:09.11.2017 instructed to register a Regular case against Dr.K. Sridhar, Director and Superintendent, Regional Institute of Ophthalmology And Government Ophthalmic Hospital, Chennai, now under suspension. Hence, I registered a Regular case against Dr.K. Sridhar, Director and Superintendent, Regional Institute of Ophthalmology and Government Ophthalmic Hospital, Chennai(now under suspension) vide Cr.No.9/AC/2017/CC-I u/s 7 and 13(2) r/w 13(1)(d) of Prevention of corruption Act 1988 on 21.11.2017 at 12.00hrs and took up investigation. The original FIR along with order of Director of DVAC to register PE 329/17/MED/CSU-I, dated 04.10.2017 (original), copy of PE registration report, copy of PE final report, copy of Tamil Nadu Vigilance Commission letter No.3914/VC-I/2017-1, dated 31.10.2017, original Memorandum of Director, DVAC in No. PE 329/2017/MED/CSU-I, dated 9.11.2017 is sent to the court (Sd) 21.11.2017, F.Joy Dayal, Inspector of Police, City Special Unit-I, Vigilance and Anti Corruption, Chennai-16.
