ATTACHMENT TO COLUMN No.12 OF FIRST INFORMATION REPORT IN VIGILANCE AND ANTI-CORRUPTION, ERODE DETACHMENT CRIME No.01/AC/2018:

ACCUSED (s):

A1- Tr.A. Thangavelu, Formerly Deputy Superintendent of Police, Anti Land Grabbing Special Cell, Erode District. Presently Additional Supdt. of Police, Prohibition Enforcement Wing, Perambalur District.

A2-Tr.S.M.Moorthy, S/o.S.R.Malaiyanna Gounder, 71/1-Gandhiji Street-III, Rajiv Nagar, Karur Bye Pass Road, Erode. The accused Tr.A.Thangavelu (A1) was previously working as Deputy Superintendent of Police, Anti Land Grabbing Special Cell(ALGSC), Erode District, during the period from 24.12.2011 to 12.03.2013 and now working as Additional Supdt. of Police, Prohibition Enforcement Wing, Perambalur District. Tr.A.Thangavelu (A1) is a public servant as defined u/s 2(c) of the Prevention of Corruption Act, 1988.

The accused Tr.S.M.Moorthy (A2) is a private individual and a friend of the A1 and he used to be in the Anti Land Grabbing Special Cell office, Erode District, during the relevant period.

A detailed enquiry was conducted with respect to the credible information about the corrupt activities of A1 & A2, and basing on records, the following facts were known:

One Tr.Dhanabalan had given a petition against Tr.Suresh Babu and 4 others at ALGSC office in connection with a land dispute and it was registered as petition number 645/2011, dated 23.08.2011. It was enquired by SI Tr.Muthusamy and it was closed as civil in nature. In this connection, Tr.Dhanabalan used to constantly visit ALGSC office, Erode and at that time accused (A2) Tr.Moorthy, who is a friend of (A1)Tr.Thangavelu approached him and ascertained the reasons. (A2)Tr.Moorthy told him that the problem can be solved through (A1)Tr.Thangavelu and demanded to pay Rs 5 lakhs in advance to him and insisted to pay a further 5% on the rate of the property after his problem was solved.

About three days Prior to 28.03.2012, Tr.Dhanabalan paid Rs 2,00,000 to (A2) Tr.Moorthy at Sivaranjani Hotel, Erode. Further, on the next day Tr.Dhanabalan paid Rs 3,00,000 to (A2) Tr.Moorthy in the same Hotel, for taking up the petition for enquiry by A1.

Then, as per the direction of (A2) Tr.Moorthy, Tr.Dhanabalan prepared a fresh petition addressed to the Superintendent of Police and on 28.03.2012, both Tr.Dhanabalan and (A2) Tr.Moorthy met DSP Tr.Thangavelu(A1). Then, (A2)Tr.Moorthy gave the petition of Tr.Dhanabalan to A1 and A1 made oral enquiries with Tr.Dhanabalan. The petition was registered as Petition No. 81/2012 by the A1.

While conducting enquiries on this petition, A1 and A2 induced the counter petitioners Tr.Suresh babu and Tr.Velusamy under threat, to deliver a property located near Hopes College, Peelamedu, Coimbatore which stood in the name of Tmt.Kavitha w/o Suresh Babu on 29.03.2012 to Tr.Dyes Thangavel & Gandhimathi, in which the A1 derived a sum of Rs 32,00,000 from Tr.Dyes Thangavel, through Tr.S.M.Moorthy(A2), on the same day and accordingly the property was delivered vide document number 3569/2012 of Singanallur Sub-Registry on 30.03.2012 to Tr.Dyes Thangavel & Gandhimathi.

When corrupt activity of the A1 came to light, as per the directions of A1, negotiations were made with Tr.Dyes Thangavel to retransfer the title of property. Then, after receiving Rs.32 lakhs along with bank interest from the close associates of A1, Tr.Dyes Thangavel retransferred the title of the property on 30.04.2012 to the name of Tmt.Kavitha. Further, in the course of the same transaction, during the period between 25.05.12 and 19.06.2012, the A1 framed incorrect petition disposal slip and caused destruction of the compromise statement of Tr.Suresh Babu and Tr.Velusamy and furnished false informations to ADSP (Crime) / Public information officer with respect to the reply to be given to Tr.Velusamy under Right to information Act.

The above facts clearly discloses that there are prima facie materials available for commission of cognizable offences punishable under section 109, 120(B), 167, 177, 201, 420 IPC and 13(2) r/w 13(1)(d) of PC Act 1988.

Hence, based upon the outcome of the detailed enquiry, I am registering a case in Erode V& AC Cr.No.01/AC/2018 u/s 109, 120(B), 167, 177, 201, 420 IPC and 13(2) r/w 13(1)(d) of PC Act 1988 against accused A1 and A2.

Original FIR is submitted to the Hon'ble Chief Judicial Magistrate and Special Judge, Erode, a copy of FIR is submitted to the DSP, V&AC, Erode for investigation and a copy of FIR is submitted to the Director, Vigilance and Anti-Corruption, Chennai, for information.
