There was an information that Tr. P. Murugesa Boopathy, s/o Palanimuthu, Native of Thiruvandipatti, Salem District now residing at R-30A, 190/1, Green Field Apartments, Anna Nagar West Extension, Chennai-101, former Special Personal Assistant to the former Minister for Agriculture, Government of Tamil Nadu and former Vice Chancellor of Tamil Nadu Agriculture University, Coimbatore from 01.06.2006 to 31.05.2009 acquired and was in possession of pecuniary resources and property in his name and in the name of his family members which are disproportionate to his known sources of income.

## Continuation of contents in FIR in Cr.No. 01/2018/AC/HQ:-

Upon this information, a detailed enquiry was conducted and it disclosed the following information.

Tr. P. Murugesa Boopathy has worked as Special Personal Assistant to the former Minister for Agriculture, Government of Tamil Nadu during the period between 01.02.1989 and 31.01.1990 and again during the period between 15.5.1996 to 14.05.2001 and from 01.06.2006 to 04.06.2009 and was former Vice Chancellor of Tamil Nadu Agriculture University, Coimbatore In between 04.06.2009 and 03.06.2012. Hence, he was a public servant during the relevant period within the purview of Section 2(c) of the Prevention of Corruption Act 1988.

Tr.P.Murugesa Boopathy is a native of Thiruvandipatty, Kozhikal Natham Post (Via) Sankagiri Taluk, Salem District. He hails from a middle class agriculture family. His father Tr.P.Palanimuthu was an Ex-Village Munsif. His mother is a house wife. He has three younger brothers and one elder sister and one younger sister. Tr.P.Murugesa Boopathy married Tmt.S.Jansi Rani D/o Tr.Subbarayan, Kalyanagiri Village, Pethanayakan Palayam, Athur Taluk, Salem District. Tmt.M.Jansi Rani is a house wife. They have one son by name Tr.M.Dhinesh Kumar. He is a dentist. He married Dr.L.Krithika. She is also a dentist.

Tr.P.Murugesa Boopathy was enlisted as Agriculture Officer, Horticulture Department, Pethanayakan Palayam, Coimbatore on 26.07.1972. He was appointed as Assistant Professor on 01.02.1989 in the Tamil Nadu Agriculture University. He was later promoted as Professor. During his tenure, he has served thrice as the Special Personal Assistant to the Minister for Agriculture, Government of Tamilnadu for the period from 01.02.1989 to 31.01.1990, from 15.5.1996 to 14.05.2001 and from 01.06.2006 to 04.06.2009. On 04.06.2009, before attaining his superannuation he was appointed as the Vice Chancellor of Tamilnadu Agriculture University by the Governor of Tamilnadu and served in that post till 03.06.2012.

For the purpose of quantifying the disproportionate assets, the check period has been fixed to run between 01.06.2006 and 31.05.2009.

The above named accused as on 01.06.2006 was found in possession of movable and immovable properties in his name and in the name of his wife Tmt.M.Jansi Rani, in the name of his son Tr.M.Dinesh Kumar and in the name of Tmt.Krithika W/o Tr.M.Dinesh kumar to the tune of Rs.33,88,771/-.

Whereas, the above named accused as on 31.05.2009 was found in possession of movable and immovable properties in his name and in the name of his wife Tmt.M.Jansi Rani, in the name of his son Tr.M.Dinesh Kumar and in the name of Tmt.Krithika W/o Tr.M.Dinesh kumar to the tune of Rs.1,17,66,710/-. Thus, during the above said check period, the accused and his family members acquired movable and immovable properties to the value of Rs.83,77,939/-.

During the check period the accused and his family members had derived income from salary, agriculture income and from other resources to a total amount of Rs.26.75.183/-.

During the check period, the accused and his family members had spent a sum of Rs.11,98,983/- towards family consumption expenditure, payment of stamp fee, registration fee, payment of LIC premiums and other expenses. Thus, during the above said check period, the accused and his family members might have possessed a saving of Rs.14,76,200/-.

According to the above said calculation, the accused as on 31.05.2009 was in possession of movable and immovable properties to the tune of Rs.69,01,739/- in his name and in the name of his wife Tmt.M.Jansi Rani, in the name of his son Tr.M.Dinesh Kumar and in the name of Tmt.Krithika W/o Tr.M.Dinesh kumar and the said properties are disproportionate to the known sources of the income of Tr.P.Murugesa Boopathy, for this the accused Tr. P. Murugesa Boopathy is not able to account for satisfactorily. It is reliably learnt that the accused Tr.P.Murugesa Boopathy had acquired the above said properties with his illegal means of income.

The aforesaid facts reveals a suspicion of commission of a cognizable offence by the accused Tr. P. Murugesa Boopathy.

The above acts of accused constitute a suspicion of commission of a cognizable offence punishable u/s 13 (2) r/w 13 (1)(e) of the Prevention of Corruption Act, 1988 and hence I am registering a case in V&AC HQRS Cr No.01/2018 for the above said offence committed by Tr.P.Murugesa Boopathy.

The original FIR is submitted to the Hon'ble Special Court for cases under the Prevention of Corruption Act 1988 Chennai and other copies are sent to the officers concerned and investigation copy is submitted to Tr. M.E.Ramachandramoorthy. DSP, V&AC, Vellore.
