SUBMITTED: The Preliminary Enquiry conducted by Tr. V. Baskaran, Inspector of Police, City Special Unit-III, Vigilance and Anti-Corruption, Alandur, Chennai-16 in PE/376/2016/EDN/HQ, against Dr. A. Amuldoss, Director of Physical Education, Thiruvalluvar University, Serkkadu, Vellore District (then Registrar (Additional Charge), Thiruvalluvar University, Serkkadu, Vellore District) revealed the following facts;

1. Dr. A. Amuldoss, while working as Registrar (Additional Charge) in Thiruvalluvar University from 21.09.2015 to 27.07.2016 committed irregularities misuse of power by issuing appointment order to the waiting list candidate Dr. G. Venkatesan and forced the selected candidate Dr. P. Bama to resign the post of Principal of Thiruvalluvar University College of Arts and Science, Tirupattur.

Preliminary enquiry reveals as follows:

2. Fifty two (52) applications were received for the post of Principals, Thiruvalluvar University Constituent Colleges of Arts and Science at Thennangur, Thiruvannainallur, Kallakurichi, Tirupattur, Tittagudi and Arokkonam. After scrutinizing all the applications, the scrutiny committee certified that 39 applications were eligible and recommended them for the interview/oral examinations.

3. Out of the Thirty nine (39) candidates called for interview/oral examinations, eleven (11) candidates were absent and the remaining twenty eight (28) candidates attended the interview/oral test.

4. Based on the qualifications and experience of the candidates and their performance in the interview, the Selection Committee unanimously selected the candidates for the posts of Principals, Thiruvalluvar University Constituent colleges of Arts and Science at Thennangur, Thiruvannainallur, Kallakurichi, Tirupattur, Tittagudi and Arokkonam on the basis of merit. The list of selected candidates and wait listed candidates are given below;

5. The minutes of the Selection Committee for the appointment of Principals in University Constituent Colleges of Arts and Science placed before the before the 68th Syndicate held on 27.02.2016 and resolved that the minutes of the Selection Committee for the appointment of Principals in University Constituent Colleges of Arts and Science of this University as shown below be approved and confirmed.

6. During the Enquiry it was ascertained that Dr.Amuldoss, Registrar i/c of Thiruvalluvar University was not issued the appointment order to the Selected Candidate Dr.P.Bama, instead he had written letter (vide TVU/R/Esst./Apptmt. of Principal/Report/2016/2855 Dated 29.02.2016) to the Principal, Thiruvalluvar University College of Arts and Science, Tirupattur. In the letter he mentioned that the Syndicate of this University has appointed Dr.Venkatesan as Principal in Thiruvalluvar University College of Arts and Science, Tirupattur in a permanent vacancy with effect from 27.02.2016 and requested the Principal to hand over the charge to the newly Principal Dr.Venkatesan.

7. In this connection Dr.P.Bama, Principal, Thiruvalluvar University College of Arts and Science, Tirupattur was enquired and ascertained that Dr.P.Bama was selected as a suitable

candidate for the post of Principal on the basis of merit by the Selection Committee and same was approved by the Syndicate.

8. On 29.02.2016 she received a call from the university asking her to come to the University and collect her appointment order. When she went to Thiruvalluvar University, Vellore to collect her appointment order, she was informed by Dr. A. Amuldoss, then Registrar (i/c) of Thiruvalluvar University that she would not be given the appointment order there is no chance for her to get the posting. When she heard this reply, she was devastated, due to the disappointment and she was hospitalized. When she was in the hospital Dr.A.Amuldoss forced her and asked letter to the effect that she is unable to join the post of Principal due to her poor health condition. But she refused to do so. On March 2nd 2016, at 7.00 am she received the phone calls and SMS from Dr.P.Amuldoss. In the message it is mentioned that she is selected for the post of Principal in the constituent colleges of Thiruvalluvar and received the appointment order via email. On the same day, she joined duty as Principal in Thiruvalluvar University College of Arts and Science, Tirupattur.

9. The act of Dr.P.Amuldoss, then Registrar i/c Thiruvalluvar University by trying to appoint the waiting list candidate Dr.G.Venkatesan in the place of selected candidate Dr.P.Bama with ulterior motive with malafide intention. Dr.P.Amuldoss furnished false information to Dr.C.Dhandapani, Principal, Thiruvalluvar University College of Arts and Science, Tirupattur that the Syndicate of Thiruvalluvar University has appointed Dr.Venkatesan as Principal in Thiruvalluvar University College of Arts and Science, Tirupattur in a permanent vacancy with effect from 27.02.2016.

10. Thus the accused Dr. A. Amuldoss, then Registrar i/c Thiruvalluvar University, who is Public Servant, is the authority to issue intimation to the concerned colleges and selected candidates about the resolution of University, by abusing his official position dishonestly and fraudulently created false document written letter (vide TVU/R/Esst./Apptmt. Of Principal/Report/2016/2855, Dated 29.02.2016) which is against the minutes of syndicate of Thiruvalluvar University. He created false document by stating that one waiting list candidate Dr. G. Venkatesan is appointed as Principal in Thiruvalluvar University College of Arts and Science, Thirupattur in a permanent vacancy w.e.f. 27.02.2016 and requested the Principal of Thiruvalluvar University College of Arts and Science, Thirupattur Dr. C. Dandapani to handover the charge to the newly appointed principal as and when he joins duty. This forged letter was sent to the Principal, Thiruvalluvar University College of Arts and Science, Thirupattur for the purpose of cheating Dr. C. Dandapani and the original selected candidate for the post of

Principal, Thiruvalluvar University College of Arts and Science, Thirupattur Dr. P. Bama and used the above mentioned forged letter as genuine.

11. Since the information discloses cognizable offence, I registered a case against Dr. A. Amuldoss, Director of Physical Education, Thiruvalluvar University, Serkkadu, Vellore District (then Registrar (Additional charge), Thiruvalluvar University, Serkkadu, Vellore District) in Vigilance and Anti-Corruption, Vellore Detachment Cr.No.01/2018 u/s 15 r/w 13(1)(c) r/w 13(2) of PC Act 1988 and u/s 465, 468, 471 IPC on 17.01.2018 at 12.00 Hrs.

12. The original FIR is submitted to the Hon'ble Chief Judicial Magistrate-cum-Special Judge, Vellore and other copies of FIR are sent to the officers concerned.
