Continuation of F.I.R in Krishnagiri V&AC Cr.No.2/AC/18 u/s 13(2) r/w 13(1)(e) of the Prevention of Corruption Act, 1988 r/w 109 IPC.

During collection of sources, the following information have come to light against the Accused 1 and 2 noted in the margin. The Accused Officer No.1. Tr.S.Maheswaran is serving as Assistant Administrative Officer at the office of the Executive Engineer, TANGEDCO, Krishnagiri

from 23.01.2016 and he is a Public Servant as defined under section 2(c) of the Prevention of the Corruption Act, 1988. The Accused No.2.Tmt.N.Anitha, is the wife of Accused No-1 Tr.S.Maheswaran and she is a Private individual.

There is reliable information that the Accused Officer No-1 Tr.S.Maheswaran had acquired and in possession of immovable assets and other pecuniary resources in his name and in the name of his wife accused No-2 Tmt.N.Anitha within a short period, which are disproportionate to their known sources of income. In this regard, a Preliminary enquiry was conducted to ascertain as to whether any cognizable offence is made out against them and it has become known that the accused officer-1 Tr.S.Maheswaran had acquired properties of house sites and pecuniary resources in his name and in his wife's name during the period from 01.04.2010 to 31.03.2015, which is disproportionate to the known sources of his income. During the above period he had been working as Administrative

Supervisor in the office of the Executive Engineer, TANGEDCO, Krishnagiri

It is gathered that

 The AO-1 and AO-2 were in possession of assets before the commencement of Check Period as on 31.03.2010 for a value of Rs.7,02,687/-

b) AO-1 Tr.Maheswaran acquired assets in his name and in the name of his wife Tmt.Anitha(AO2) during the Check Period from 01.04.2010 to 31.03.2015 to the value of

Rs.2,06,16,637/-

c) During the Check Period, the total income derived by the accused-1 Tr.S.Maheswaran from his known sources i.e the pay and allowances, through selling properties and through Loan obtained from Banks, have been tentatively assessed as Rs.1,02,61,048/-

d) The total expenditure incurred by the accused-1 Tr.S.Maheswaran and his family members during the period between 01.04.2010 and 31.03.2015 has been tentatively assessed as

Rs. 48,16,661/-

e) Likely savings of the AO-1 Tr.Maheswaran during the Check Period.

Rs. 54,44,387/-

f) Disproportionate assets possessed by the AO-1 and AO-2 during the Check Period

1,51,72,250/-

Therefore, during the period between 01.04.2010 and 31.03.2015 the accused-1 Tr.S.Maheswaran, found to have acquired pecuniary resources and properties to the extent of Rs. 1,51,72,250/- in his name and in the name of his wife accused-2 Tmt.N.Anitha. The accused-2,

in whose name a substantial portion of the aforesaid properties is found to have been acquired, is not found to have any independent source of income commensurate with the properties and pecuniary resources found acquired in her name. There are reasonable grounds to believe that the aforesaid assets are far beyond and disproportionate to the known sources of income of the accused-1 Tr.S.Maheswaran and his family members for the said period to the extent of Rs. 1,51,72,250/-, which is 147.8% of his total income, for which both the accused cannot satisfactorily account. The above information makes out a cognizable offence u/s 13(2) r/w 13(1)(e) of Prevention of Corruption Act 1988 against the AO-1 Tr.S.Maheswaran and u/s 109 IPC r/w 13(2) r/w 13(1) (e) of Prevention of Corruption Act 1988 against AO-2, Tmt.N.Anitha.

Therefore, today on 13.02.2018 at 14.30 hrs, I registered a case in Krishnagiri Vigilance and Anti-Corruption Cr.No.2/AC/18 u/s 13(2) r/w 13(1)(e) of Prevention of Corruption Act 1988 against r/w 109 IPC.

The original FIR is submitted to the Honourable court of Special Judge/ Chief Judicial Magistrate, Krishnagiri and a copy of FIR was submitted to the Deputy Superintendent of Police, Vigilance and Anti-Corruption, Dharmapuri for investigation and other copies were submitted to the officers concerned.
