## Chennai V&AC, Chennai City-III, Cr.No. 3/AC/2018/CC-III FIR continuation

## (Colum-12):-

Today on 02.04.2018 at 16.00 hrs when I was in my office at Room No. 101, First Floor, Railway Station Road, Alandur, Chennai-16, as per the instruction of Directorate of Vigilance and Anti Corruption, a case was registered in Chennai V&AC, Chennai City-III, Cr.No. 3/AC/2018/CC-III, u/s 409 IPC and u/s 13(2) r/w 13 (1) (c) of the Prevention of Corruption Act, 1988 against Tr.T.Balamurugan and u/s 409 IPC r/w 109 IPC and u/s 13 (2) r/w 13(1) (c) of the Prevention of Corruption Act, 1988 r/w 109 IPC against Dr.U.Arivaruliyar. The detail of the case runs as follows:-

A Detailed Enquiry vide DE 21/2017/REV/CC-III dt. 23.02.2017 was conducted by me against Tr.T.Balamurugan, formerly Tahsildar, AmbathurTaluk, Thiruvallur District, to enquire into certain allegations regarding that he colluded with the Management of Pakuruli Pasumpon Arul Aacini Trust's Higher Secondary School of Ambattur for pecuniary advantages by giving building license (Form D) in his tenure between 10.09.2015 and 30.08.2016 by violating the norms in Government land allotment orders to run the above said school at Ambathur and thereby caused loss to the Government.

The Detailed Enquiry reveals the following facts:-

The accused Tr.T.Balamurugan was working as Tashildar between 10.09.2015 and 30.08.2016 at AmbatturTaluk, Thiruvallu District and hence he is a public servant as defined U/s 2(c) of the Prevention of Corruption Act, 1988 at the relevant period of occurrence.

The accused Dr.U.Arivaruliyar S/o Udayappa is one of the trustee of Pakkurali Pasumpon Aacini Arul Trust and Managing Director of Arul Aacini Higher Secondary School situated Panneerselvam Street, Ambattur and he is a private individual.

That the Pakkuruli Pasumpon Aacini Arul Trust, a registered Trust running a school at Ambathur in the name and style of "Aachini Matriculation Higher Secondary School" had requested the Government to allot land for school purposes and believing their representations to be true the Government has allotted lands measuring about 2050 sq.mts. in S.No.616/2A of Ambattur village vide G.O.Ms.No.614Revenue (T3) Department dated 7<sup>th</sup> July 1993 for school purposes on a minimum cost with conditions stipulating that the land must be used only for the purpose of school and should not be given on lease, rent, mortgage, sale etc., and the trust took control over the said property under their domain upto11.09.2014.

Then the present Managing Director, Dr.U.Arivaruliyar S/o Udayappa of M/s. Pakkuruli Pasumpon Aacini Arul Trust, which is running Arul Aacini Higher Secondary School Panneerselvam Street, Ambattur, Chennai-53, had violated the conditions under which land was allotted by Government by entering into a lease agreement for a period of 33 years from 01.06.2015 to 30.05.2048 with M/s. Ravindra Bharathi Educational Society of Nellore District, Andhra Pradesh represented by its President Sri.Mannuru Subramanyam vide D.No. 12698/2014 dated 12.09.2014 to run a CBSE School in the name and style of "Ravindra Bharathy Global School" for a monthly rent of Rs. 4.300/- with 5% annual increase and the lessor Mr.Mannuru Subramaniam took possession of the land, constructed a building and started running Narayana e-Techno School. The value of the land was calculated to the tune of Rs.50,28,999/- for the purpose of letting lease by Dr.U.Arivuaruliyar (A2) to Tr.Mannuru Subramaniam for the purpose of running Naravana e-Techno School and subsequently a cancellation deed was registered vide D.No.11329/2015 on 11.08.2015 to make others to believe that the lease deed already registered was cancelled and apparently making it to believe that no violation of condition under which land was granted by the Government. Dr.U.Arivaruliyar (A2) obtained building license on 12.08.2016 from Tr.T.Balamurugan for Arul Aacini Higher Secondary School even though the Narayana e- Techno School is continuing in the premises till date. Tr.T.Balamurugan, formerly Tahsildar, AmbatturTaluk Office, Thiruvallur District who has granted building permission with the active connivance and abetment of the said Trust Managing Director, Dr.U.Arivuarulivar, without considering the rules, regulations and conditions of land allotment by the Government to Pakuruli Pasumpon Arul Aacini Trust's Higher Secondary School and knowingly violated the direction of law prescribing the mode in which such trust is to be discharged which resulted in conversion of property for the benefit of others with the active participation and connivance of public servant.

The act of the accused Tr.T.Balamurugan, formerly Tahsildar of Ambattur Taluk constitutes a suspicion of commission of cognizable offence U/s 409 IPC and u/s 13(2) r/w 13 (1) (c) of the Prevention of Corruption Act, 1988 and the act of the accused Dr. U.Arivaruliyar constitute a suspicion of commission of cognizable offence under r/w 109 IPC and u/s 13 (2) r/w 13(1) (c) of the Prevention of Corruption Act, 1988 r/w 109 IPC.

Hence, I register a case u/s 409 IPC and u/s 13(2) r/w 13 (1) (c) of the Prevention of Corruption Act, 1988 against Tr.T.Balamurugan and u/s 409 IPC r/w 109 IPC and u/s 13 (2) r/w 13(1) (c) of the Prevention of Corruption Act, 1988 r/w 109 IPC against Dr.U.Arivaruliyar on this 2nd day of April of 2018 at CC-III.
