Submitted I have received the information pertaining to this registration of FIR today 21.2.2018 at 13.00hrs, while attending the office works from DVAC chennai-16 as per the instruction in memorandum no PE/190/2017/pol/KK DT 15.2.18 of the Director of Vigilance and Anti-corruption, Chennai and registered a case in Nagorecoil Vigilance and Anti-corruption er no 3/2018 v/s 7, 13C & r/w 13 (1) (c) of PC Act and 120B, 294(b), 323, 506(1), 409, 167, 211 gpc and 4 of Tamil Nadu Prohibition of Harassment of Women Act as under Trt. S vs. W/O To. Thappa Sunita

13. Action taken : Since the above report reveals commission of offence(s) u/s as mentioned at item No.2 registered the case and took up the investigation / directed Rank to take up the Investigation / Refused Investigation / transferred to PS on point of jurisdiction.

is residing at 4/3 Shambagam Road, Nallur post along with her family. She is having two daughters and three sons. Both daughters are married and two younger Sons T8. Varatharajan and T8. Kesavasajan are unmarried. They are running a mobile shop in the name of R. mobiles at chettikulam Junction, Nagorelil. On 1.5.2017 at about 12.30 hrs TMT-SUSI along with her son Tr. Varatharajan and Tr. Kesavasajan were proceeding towards Nagorecoil in their own Maruthi wagon R. car bearing registration number TN-01-U 9425 at Elayangayinarkulam & working in suchindram p.s. lnt. The accused A-1 T8. Esakkiraja, Training sub-inspector of police without police uniform way laid and asked Tr. Varatharajan to produce the documents of the vehicle. Tr. Varatharajan had produced the copy of the documents. The accused A-1 T8. Esakkiraja had instructed to produce the original vehicle documents. But Tr. Varatharajan had replied that the original RC book was at chennai and it would be available only after one week. Hence the accused A-1 demanded illegal gratification Rs 5000/- from Tr. Varatharajan otherwise he will not let them to go from that place. Tr. Varatharajan replied that he was ME. graduate and his brother was studying Law. Even though A-1 demanded above amount Tr. Varatharajan refused to give demanded bribe amount and hence A-1 had uttered filthy language and asked "how dare are you to argue with me" and forcefully picked the car key and caught hold the shirt of T8. Varatharajan and Tr. Kesavasajan. At that time the accused A-1 & Tr. Bharathalingam, SI of police suchindram p.s was on that way by his bike and asked A-1 regarding the occurrence. A-1 narrated the occurrence and

immediately A-1 and A-2 told that if they will be subjected to beating the amount will come automatically. In pursuance of the same A-1 assaulted with hands and legs on the body of Tr. Varatharajan and Tr. Kesavarajan. And also, A-2 joined with A-1 assaulted with Tr. Varatharajan and caused injuries on the head, neck, chest and mouth and also Tr. Kesavarajan sustained on the head, neck, upper lip, lower lip left shoulder, back, lower abdomen and legs. The accused A-1 and A-2 informed this matter to Inspector and the Inspector T/S. Samson came to the occurrence place and picked up Tr. Varatharajan and Tr. Kesavarajan and brought them to Suchindram p.s Station, leaving SVSI at the incident spot and the SI Tr. Bharathalingam in imitating her if she disclose the matter to any body she would not be alive. At that, they forcefully obtained a false complaint & obtained from one Tr. Kamal, S/o T/S. Haritharan on the basis of the false complaint, and on the instruction of Inspector Samson a case on Suchindram p.s crno 168/17 v/s 341 294(b) 323, 506(1) gpc was registered by Tr. Tamil Mohan Chandhi, SS/ against Tr. Varatharajan and Tr. Kesavarajan on 01.5.2017 at 13.00hrs. After that Varatharajan were arrested and remanded to judicial custody. Again at 18.30 hrs they have returned the articles and jewels which were seized from Varatharajan and Kesavarajan to their father except the gold chain weighing 4 sovereigns more by Varatharajan, when they questioned about the 4 sovereigns gold chain with A-1 and A-2 they answered that if they give the demand about Rs 5000/- then only they will return the Gold chain. Hence it is ascertained that on 1.05.2017 at 18.30hrs during the course of police vehicle check A-1 E sakthi and A-2 Tr. Bharathalingam

had assaulted Tr. Kesavarajan and his brother Tr. Varadharajan with hands and legs on their head, neck, chest and mouth and also beat and made them difficult to pass urine, by uttering filthy word "Gangnam style", and also threatened them to their life for the purpose of the demanded bribe Rs 5000/- net given to them. They also brought the victim to police station by leaving the mother of victim Tmt. Susi lonely at the occurrence spot of Elayananinagar Kulam turnings. Again in order to conceal their above illegal activities they forcefully obtained a false complaint from one Tr. Kamal against Tr. Varadharajan and Tr. Kesavarajan and registered a case in Suchindram P.S. cr no 1681/2017 v/s 344, 294(b) 323 and 506(1) Gp falsely. The accused A-1 Tr. Esakkiraja and A-2 Tr. Bharathalingam, the Inspector Tr. Samson and SS1 Tr. Tammil Nathan Chinnai being public servant were parties to a criminal conspiracy having agreed among themselves to frame incorrect records by falsely creating complaint with the help of Tr. Kamal and former incorrect records and also with intention to cause injury to Varadharajan and Kesavarajan constitutes criminal proceeding against them knowing that there is no just or lawful grounds for such proceedings. Hence the above criminal acts of the accused persons disclose the commission of offences v/s 7, 13(2) 8/W13(1)(c) of PC Act and 180B 294(b), 323, 506(1), 409, 167, 211, SPC and 4 of Tamil Nadu Prohibition of Harassment of Women Act. Hence I am registering a case against the accused in Nagorel VdAC cr no 3/2018.
