S. V. S. I. w/o T. Thangal

13. Action taken : Since the above report reveals commission of offence(s) u/s as mentioned at item No.2 registered the case and took up the investigation / directed Rank to take up the investigation / Refused Investigation / transferred to PS on point of jurisdiction.

Continuation of FIR vs Kanyakumari V/Ac CrNo 3/2018

is residing at 4/3 Shenbagam Road, Nallur post along with her family. She is having 6 daughters and three sons. Both daughters are married and two younger sons to Varatharajan and to Kesavaarajan are unmarried. They are running a mobile shop in the name of R. mobiles at chettikulam Junction, Nagercoil. On 1.5.2017 at about 12.30 hrs Tmt. Susi along with her son to Varatharajan and to Kesavaarajan were proceeding towards Nagercoil in their own Maruthi Wagon R. car bearing registration number TN-01-V925 at Elayanayinarikulam turning to Suchindram p's limit. The accused A-1 to Esakkiraja, Training Sub-inspector of police without police uniform way laid and asked to Varatharajan to produce the documents of the vehicle. To Varatharajan had produced the ~~copy~~ copy of the documents. The accused A-1 to Esakkiraja had instructed to produce the original vehicle documents. But to Varatharajan had replied that the original Re book was at Chennai and it would be available only after one week. Hence the accused A-1 demanded illegal gratification Rs 5000/- from to Varatharajan otherwise he will not let them to go from that place. To Varatharajan replied that he was M.E. graduate and his brother was studying Law. Even though A-1 demanded above amount. To Varatharajan refused to give demanded bribe amount and hence A-1 had uttered filthy language and asked "how dare are you to argue with me" and forcefully picked the car key and caught hold the shirt of to Varatharajan and to Kesavaarajan. At that time the accused A-1 to Bharathlingam, SI of police Suchindram p's was on that way by his bike and asked A-1 regarding the occurrence. A-1 narrated the occurrence and

immediately A-1 and A-2 told that if they will be subjected to beating the amount will come automatically. In pursuance of the same A-1 assaulted with hands and legs in the body of Tr. Varatharajan and Tr. Kesavarajan. And also A-2 joined with A-1 assaulted with Tr. Varatharajan and caused injuries on the head, neck, chest and mouth and also Tr. Kesavarajan sustained in the head, neck upper lip, lower lip, left shoulder, back, lower abdomen and legs. The accused A-1 and A-2 informed this matter to inspector and the Inspector Tr. Samson came to the occurrence place and picked up Tr. Varatharajan and Tr. Kesavarajan and brought them to Suchindram P.S. Station, leaving S/S I at the incident spot and the S.I. Tr. Bharathlingam intimidating her if she disclose the matter to any body she would not be alive. After that, they successfully obtained a false complaint obtained from one Tr. Kamal, S/O Tr. Haritharam on the basis of the false complaint, and on the instruction of Inspector Samson a case in Suchindram P.S. Cr.No 168/17 U/S 341 294(b) 323, 506(1) gpc was registered by Tr. Purni Mathan Hanthi, S.S.I against Tr. Varatharajan and Tr. Kesavarajan on 01.5.2017 at 13.00hrs. After that Varatharajan were arrested and remanded to judicial custody. Again at 18.30 hrs they have returned the articles and jewels which were seized from Varatharajan and Kesavarajan to their father except the gold chain weighing 4 Sovereigns wore by Varatharajan. When they questioned about the 4 Sovereigns gold chain with A-1 and A-2 they answered that if they give the demand about Rs 5000/- then only they will return the Gold chain. Hence it is ascertained that on 1.05.2017 at 12.30hrs during the course of p.p.t vehicle check A-1 E sekharaja and A-2 Tr. Bharathlingam

had assaulted Tr. Kesavarajan and his brother, Tr. Varadharaj with hands and legs on their head, neck, chest and mouth and also beat and made them difficult to pass urine, by uttering filthy word "Chingun Linn", and also threatened them to their life for the purpose of the demanded bribe Rs 5000/- not given to them. They also brought the victim to police station by leaving the mother of victim Tmt. Suisi lonely at the occurrence spot of Elayanaminar Kulam turning Agum in order to conceal their above illegal activities they falsely obtained a false complaint from one Tr. Karanagi nbt Tr. Varadharajam and Tr. Kesavarajan and registered a case in Suchindram P.S. Crno 168/2017 U/S 341, 294(b) 323 and 506(1) IPC falsely. The accused A-1 Tr. Esakkiraja and A-2 Tr. Bharathilingam, the inspector Tr. Samson and SSI Tr. Tamil Nathan Gramaki being public servant were parties to a criminal conspiracy having agreed among themselves to frame incorrect records by falsely inserting complaint with the help of one Karanagi and framed incorrect records and also with intention to cause injury to Varadharajam and Kesavarajan institutes criminal proceeding against them knowing that there is no just or lawful grounds for such proceedings. Hence the above criminal acts of the accused persons disclose the commission of offences u/s 7, 13(2) r/w 13(1)(c) of PC Act and 180B 294(b), 323, 506(1), 409, 167, 211, IPC and 4 of Tamil Nadu prohibition of Harassment of Women Act. Hence I am registering a case against the accused in Nagercoil VdAC Crno 3/2018.
