On 23.07.2018 at 15.00 hrs, I am Inspector of Police, Vigilance and Anti-Corruption, Nagapattinam Detachment received as per the Instruction of the Memorandum dated 27.03.2018 of Directorate of Vigilance and Anti-Corruption, Chennai through Detailed Enquiry Report in DE.103/2015/ AGRI/NP perused and registering of the Regular Case. The fact of the case as follows.

Based on a credible information collected by an officer of the Vigilance and Anti-Corruption Department through source that the A1 to A6 colluded together and misappropriated government money, involved in corrupt practices, committed series of malpractices and irregularities in the implementation of Seed village programme in Thiruvarur District, made false entries in the records and committed criminal breach of trust and hence a Detailed Enquiry was conducted and the Enquiry revealed the following facts.

A1. Tr.G.Manikandan, worked as an Assistant Agriculture Officer, Nannilam, Nannilam Taluk, Thiruvarur District at the relevant period of occurrence.

A2. Tr.V.Rajakumaran, worked as an Assistant Agriculture Oficer, Pavattakudi, Nannilam Block, Thiruvarur Dt., I/o Depot Manager, Pavattakkudi AEC Now: Asst. Agriculture Officer, Srivanjiyam, Nannilam Block, Thiruvarur District at the relevant period of occurrence.

A3. Tr.S.Duvaraganathan, worked as an Assistant Agriculture Officer, Rettakudi, Nannilam Block, Thiruvarur District, I/c Depot Manager, Peralam AEC at the relevant period of occurrence.

A4. Tr.S.Palanivel, worked as Assistant Agriculture Officer, Srivanjiyam, Nannilam Block, Thiruvarur Dt., at the relevant period of occurrence now Assistant Agriculture Officer, Koradacherry Block.

A5. Tr.B.Karunanithi, worked as Depot Manager (Gr.III), I/c Depot Manager, Nannilam AEC, Thiruvarur Dt., at the relevant period of occurrence now Depot Manager at Pavattakuddy.

A6. Tr.G.Rajendran, worked as Assistant Agriculture Officer, Peralam, Nannilam Block, Thiruvarur District at the relevant period of occurrence.

A1 to A6 are public servants within the meaning of Section 2(c) of the Prevention of Corruption Act, 1988.

It is revealed that based on the proposal of the Director of Agriculture, Chennai for implementation of Seed Village Programme, the Government of India, Ministry of Agriculture, Department of Agriculture and Co-operation, New Delhi Sanctioned the release of Grants –in-aid amounting to Rs.1288.242 lakhs to the Government of Tamil Nadu for implementation of Seed Village Programme in the Sub-Mission on Seeds & Planting Material under National Mission on Agricultural Extension & Technology (NMAET) for Kharif season during 2014-15. The Director of Agriculture, Chennai has requested the Government to sanction an amount of Rs.1288.242 lakhs for implementation of Seed village Programme during 2014-15 and accordingly the Government has accorded administrative approval and sanction for an amount of Rs.1288.242 lakhs as 1st installment for implementation of the said programme. It is revealed that the Director of Agriculture, Chennai had allotted 450 MTs of paddy seeds for Thiruvarur District with 50% subsidy as financial aid which is to the tune of Rs.45,00,000/- and instructed the Joint Director of Agriculture to ensure implementation of the scheme without any deviation from the Government of India Guidelines and issued some guidelines for distributing seeds in Seed village programme 2014-15. The Joint Director of Agriculture, Thiruvarur communicated to all the Assistant Director of Agricultures, Thiruvarur District and issued go ahead orders by mentioning the block-wise target under the said seed village scheme 2014-15 and allotted 45 MTs of paddy seeds to the Assistant Director of Agricultural, Nannilam Block with a total 50% subsidy as financial aid which is to the tune of Rs.9,30,000/-.

It is revealed that during the period between 01.07.2014 to 30.04.2015, A1 to A4 and A6 have worked as Assistant Agricultural Officers under the control of Assistant Director of Agriculture of Nannilam Block during the period from 01.07.2014 to 30.04.2015 and they indentified the farmers and prepared seed village scheme applications for the period 2014-2015, in the name of the farmers in the villages and such names are fictitious and the person are nonexisting in that village and forged their signatures in the application forms and used the forged applications as genuine and recommended to issue 20 Kg of Paddy seeds with 50% subsidy amount to each farmer. Further, A2 and A3 were also the i/c Depot Manager of Pavattakudi and Peralam respectively and A5 who was the Depot Manager of Nannilam Depot entered the farmers names in the subsidy register of the concerned depot as in Seed Village Scheme application forms for 2014-2015 for the non-existing persons of that villages and forged their signatures in the subsidy register and prepared forged bills in the names of the said non-existing farmers and forged their signatures in the bills and willfully, with intent to defraud falsified the books and entered in the registers as if they distributed 50% subsidy paddy seed to the farmers and swindled in the name of the said non-existing farmers and the said A1 to A6

committed and abetted each other and fraudulently misappropriated the subsidy paddy seeds allotted by the Government to the farmers in Seed Village Scheme 2014-15 and sold 46,040 Kgs. of paddy seeds which have 50% subsidy amounting to Rs.7,34,366/- to the private paddy seed dealers and to the private persons for an unknown cost and misappropriated the 50% subsidy amount of Rs.7,34,366/- by averting the real farmers to avail the benefit of the seed village scheme.

The above information collected during Detailed Enquiry, discloses suspicion of commission of cognizable offences by A1 to A6 u/s 167,468,420,409,471, 477-A IPC r/w 109 IPC and U/s 13(2) r/w 13(1) (c) of the Prevention of Corruption Act 1988.

Hence, a Regular Case in Nagapattinam V&AC Cr.No.4/2018 u/s 167,468,420,409,471,477-A IPC r/w 109 IPC and U/s 13(2) r/w 13(1) (c) of the Prevention of Corruption Act 1988 against A1 to A6 is registered by me on 23.07.2018 at 15.00 hrs.
