Based on the vigilance report originated from the confidential allegation of enquiry, the of commission criminal misconduct of marginally noted accused by misusing / abusing their official position AEE/Civil, TNEB is revealed. confidential The enquiry reveals described the facts hereunder.

Accused -4

Tmt. M. Sumitha, W/o Tr.T.Kumar (A2), 16/10, F1, Mathura Apartments, Gopalakrishnan Street, Ganesh Nagar, Guindy, Chennai-600032. (Private Individual)

Accused -5

Tr.S.Kumarapandian S/o Tr. Shanmugapandian 15/17, Panagal II nd Street, Mathichiyam, Madurai-625020. (Private Individual)

Tr.U.Umashankar, S/o Tr.Uthirapathy who was working as AEE/Civil TANTRANSCO, Guindy, Chennai is a Public Servant as defined U/s 2 (c) of P.C. Act 1988.

Tr. K.Kumar S/o A.Kannabiran who was working as AEE/Civil O/o the SE/CDC/ TANGEDCO (EE/Civil) Mount Road, Chennai is a Public Servant as defined U/s 2 (c) of P.C. Act 1988.

Tmt. K.Selvapriya W/o Tr.U.Umashankar (A1) Partner "M/s Trinity contracts and services", with registered office at No. 6, Adirayar Street, Umayalpuram, Chrompet, Chennai-44 is a private individual.

Tmt.M.Sumitha W/o Tr.K.Kumar (A2) Partner "M/s Trinity contracts and services", with registered office at No. 6, Adirayar Street, Umayalpuram, Chrompet, Chennai-44 is a private

individual. Tr.S.Kumarapandian S/o Tr.Shanmugapandian, residing at 15/17, Panagal II nd Street, Mathichiyam, Madurai – 625020 partner of M/s Trinity contracts and services with registered office at No.6, Adirayar Street, Umayalpuram, Chrompet, Chennai-44 is also a private individual.

Confidential enquiry further revealed the facts given hereunder:-

Prior to 03/03/2014, Tr.U.Umasankar, AEE/Civil, TANTRANSCO, Guindy, Chennai and Tr.K.Kumar, AEE/Civil O/o the SE/CDC, TANGEDCO, (EE/Civil) Mount Road, Chennai Tmt.K.Selvapriya and Tmt.M.Sumitha entered into a Criminal conspiracy to commit and abet the offences of criminal misconduct and criminal breach of trust. In pursuance of the said criminal conspiracy, they committed and abetted each other in the following acts which constitutes commission of offences described hereunder:-

The marginally noted accused A1 and A2 floated a partnership firm in the name and style of "M/s Trinity contracts and services", with registered office at No. 6, Adirayar Street, Umayalpuram, Chrompet, Chennai-44 (i.e) on 03/03/2014 and made their wives as the partners of the firm (i.e) Tmt.K.Selvapriya W/o (A1 accused) Tr.U.Umasankar and Tmt.M.Sumitha W/o (A2 accused) Tr.K.Kumar and Tr.S.Kumarapandian S/o Tr.Shanmugapandian without intimating to the superior officers about the formation of partnership company in their wives names.

The enquiry further reveals that the accused A1 and A2 made their wives to give an application to TANGEDCO on 03/03/2016 and to TANTRANSCO on 04/03/2016, to register their partnership firm in TANGEDCO and TANTRANSCO as class – 1 contractors and registered their partnership firm vide SE/CD and HP/ 004/ 2016. Thus the accused A1 and A2 made registration of the firm in TANGEDCO, TANTRANSCO as class - I contractors (State Level) to carry out civil, electrical and mechanical works to the value upto and above Rs.75 lakhs. The registration is valid for the period of five years up to 03/03/2021.

The enquiry reveals further that the accused A1 and A2 made their wives to be participate in tenders for the following two works 1). Labour Charges for erection to tower, stringing and supply of tower extension parts for the proposed erection of 110 KV SC line on DC towers form the existing periyaplayam 110/33-11 KV SS to the proposed, Thervaikandigai 110/33 KV SS Location 1 to 30 (Reach 1) LOA dated 16/09/2016. 2) Reconstruction of collapsed compound wall with pipe and RCC wall in northern and eastern side of KITS park and 230 Kv substation at Sholiganallur, LOA dated 30/06/2017.

Thus the Accused A1 and A2 involved their wives and one S.Kumarapandian to enter into an article of agreement with Tamil Nadu Transmission company Limited on 18/03/2017 to the value of Rs.1,11,64,258 and Rs. 1,29,59,905/- respectively.

Thus the Accused A1 and A2 have violated Tamil Nadu Electricity Board Employees conduct Rules. 14(1) (a) 14 (1) (b) and

rule 22. The accused A1 and A2 who have been entrusted with the main duty as AEE/Civil is to prepare project estimation details electrical and mechanical works and to assist EE/SE in tender process and in the execution of works given in the form of tenders to register Class I contractors of TANGEDCO and TANTRANSCO and having misused their official position in violation of direction of Law, floated a partnership firm in the name and style of "M/s Trinity Contracts and Services" with their wives Tmt. Selvapriya and Tmt.Sumitha respectively and one Tr.S.Kumarapandian as partners thereby indulging into the above described criminal misconducts, thereby allowing A3, A4 and A5 accused to obtain pecuniary advantage. Under the above circumstances, there is a suspicion that the accused A1 and A2 have committed criminal conspiracy, criminal breach of trust and criminal misconduct by public servants which are punishable U/s 120 (B), 409 IPC, and 13(2) R/w 13(1)(c) and 13 (1) (d) of Prevention of corruption Act 1988 and A3, A4, A5 suspected to have committed offences punishable u/s 109 of IPC and 13 (2) R/w 13 (1) (c) and 13 (1) (d) of Prevention of Corruption Act 1988 and 109 of IPC R/w 409 IPC.

Hence, I register a case against A1 Tr.U.Umashankar, A2 Tr.K.Kumar U/s 120 (B), 409 IPC, and 13(2) R/w 13(1)(c) and 13 (1) (d) of prevention of corruption Act 1988 and against A3, A4 and A5 accused u/s 109 of IPC and 13 (2) R/w 13 (1) (c) and 13 (1) (d) of Prevention of Corruption Act 1988 and 109 of IPC R/w 409 IPC, vide Cr.No 5/AC/2018/CC-I on 22.03.2018 at 12.00hrs and took up investigation. The original FIR along with Permission letter of Tamil Nadu Vigilance Commission vide Letter

No.4761/VC-I/2017-1, Dated:13.02.2018, original Memorandum of Director, DVAC in VR. No. 31804/2017/TANGEDCO/CSU-1, dated 05.03.2018 is sent to the Hon'ble Special Judge, Special Court for PC Act Chennai. (Sd) 22-3-2018, F.Joy Dayal, Inspector of Police, City Special Unit-I, Vigilance and Anti Corruption, Chennai-16.
