The A1, Dr.T.Sureshbabu, Chief Civil Surgeon, Government Head quarters Hospital, Dindigul, native of Koodal Nagar, Aanaiyur, Madurai hails from a middle class family. He got appointment in the Government Medical Service as Assistant Surgeon on 01.11.1990 and later promoted as chief Civil Surgeon on 26.01.2011 and till now working at Head Quarters Hospital, Dindigul as Chief Civil Surgeon.

The A1 had married Tmt.R.Srinivasa Preetha (A2), 518/8, Agraharam Road, Dindigul in the year 1994 and they have two son's. The elder son Tr.S.Pranav completed his MBBS degree at Chettinadu Medical College, Chennai and practicing house surgeon. The Younger son Tr.S.Pinkash Raj is studying 1 st year MBBS at Chettinadu Medical College, Chennai.

A2 Tmt.R.Srinivasa Preetha has completed Hospital Management Course and she is running Sathya Suba Hospital at New Agraharam, Palani Road, Dindigul as her own from the year 2000.

## First Information Report of Dindigul Vigilance and Anti-Corruption, Cr.No.6/2018 continues:

It is reliably learned, A1 who was having only one property as ancestral property from his father, had accumulated immovable properties in the name of his wife Tmt.R.Srinivasa Preetha which are suspected to be disproportionate to his known sources of income for the purpose of verification, an enquiry was contemplated to find out the details of the assets acquired and possessed by A1 on verification it was found that A1 had accumulated properties which are disproportionate to his known sources of income, are found only in the name of his wife A2 besides holding in his own name.

The check period was determined as between 01.01.2007 to 02.09.2011 By scrutinizing 1. The IT returns filed by the accused officer A1 and A2 2. Bank accounts operated in the name of A1 and A2, 3. Documents collected from the various department (i.e.,) the movable and immovable properties purchased in the name of A1 and A2 the check period is fixed as 01.01.2007 to 02.09.2011 considering the events which took place during the course of employment of A1 and the income of his wife at Sathya Suba Hospital, Dindigul.

A1 was found in possession of only one house site ancestral property and certain movable and immovable properties which was purchased worth about Rs.17,59,788 at the beginning of the check period.

The assets that stood to the credit of A1 as on 02.09.2011 i.e., at the end of the check period which are in the name A2 are valued as Rs. 3,87,69,996/-. Further, it was found that A1 has acquired landed properties of about 11 items (81.77 acres of land ) at Kambiliampatty, Alagupatty, Sirumalai, Bodikamanvadi and Poolathur Village at Dindigul District for a total value of Rs.36,82,667/- between 19.02.2007 to 02.12.2010 in the name of A2, and a house site at Kodaikanal (14 Cents) on 14.06.2007 in the name of A2 for a total value of Rs.9,74,760/- and Six house plots at Thotanoothu Village in Dindigul District in the name of A2 on 08.11.2010 worth of Rs.8,20,365/-. An Apartment in the name of A2 was purchased on 08.02.2010 at kannanendhal, Madurai for a value of Rs.40,52,855. The total cost for the purchase of this properties of landed properties during the year 18.02.2007 to 08.02.2010 has been worked out as Rs.95,30,647. Apart from this A1 has constructed house at Kodaikanal at the cost of Rs.53,65,930 during the year of 2010 and 2011 and Dindigul at the cost of Rs.37,12,657 during the year 2007 to 2011. A1 purchased a Maruthi Swift Desire car in the name of his wife (A2) on 02.02.2011 for the worth of Rs.7,02,583 and A2 purchased generator's and other equipments for hospital during the year 2007 to 2011 for the value of Rs. 40,25,620/- as per IT returns.

Approximate Percentage of Disproportion = <u>2,42,59,739.81</u> X 100 = 52% 4,65,28,984.08 There is acredible information, A1 with the marriage of A2 received 800 grams of gold gifted by A1's father-in-law for his daughter's marriage. A1 and A2's income and expenditure have been calculated.

Therefore A1 while holding the post of public servant abused his position as public servant and accumulated and possessed pecuniary resources and properties mostly in the name of A2 which were suspected to the disproportionate to his known sources of income to the extent of Rs.2,42,59,739/- for which A1 has not satisfactorily accounted for which is an offence of criminal Misconduct punishable u/s 13(2) r/w 13(1)(e) of prevention of corruption Act 1988.

As most of the properties were purchased and found in the name of A2 wife of A1 who as abettor in the concealment of ill-gotten money held by A1 and by giving consent by way of hold properties in her name have committed the offence of abetment punishable u/s 109 IPC r/w 13(2) r/w 13(1)(e) of PC Act 1988.

Thus, there are prima facia materials available on record for taking up the investigation against A1 and A2 for the aforesaid offence.

Therefore, I am registering this case in Cr.No.6/18 u/s 13(2) r/w 13(1)(e) of prevention of Corruption Act 1988 r/w 109 IPC r/w 13(2) r/w 13(1)(e) of Prevention of Corruption Act 1988.

Hence, vide order dated:31.05.2018 from the Directorate of Vigilance and Anti-Corruption, Chennai in DE 113/2014/MED/DL, a criminal case in V&AC., Dindigul Detachment Cr.No.6/2018, u/s 13(2) r/w 13(1)(e) of prevention of Corruption Act 1988 r/w 109 IPC r/w 13(2) r/w 13(1)(e) of Prevention of Corruption Act 1988 has been registered against A.1 Dr.T.Sureshbabu, Chief Civil Surgeon, Government Head quarters Hospital, Dindigul and A-2 Tmt.R.Srinivasa Preetha (A2), W/o. Dr.T.Sureshbabu, 518/8, Agraharam Road, Dindigul by Tmt.R.Geetha, Inspector of Police, Vigilance and Anti-Corruption, Dindigul on 10.07.2018 at 16.30hrs. The F.I.R.
