Accused No.1 Tr.G.Kumar was the Administrative Officer (Admn.), District Police Office, Madurai District. He was nominated as incharge of Nodal Team for the Physical Efficiency Test conducted at Armed Reserve Ground, Madurai for the recruitment of Gr.II Police Constables, Fireman and Prison Constable in the year 2017. Accused No.2, Tr.Balamurugan was the Junior Assistant in District Police Office, Madurai District who was nominated as Nodal staff under AO-1 for the Recruitment of Gr.II Police Constables, Fireman and Prison Constable in the year 2017. Accused No.3, Tr.V.Muralitharan was the Office Assistant in District Police Office, Madurai District, who was also nominated as Nodal staff under AO-1 for the Recruitment of Gr.II Police Constables, Fireman and Prison Constable in the year 2017. Accused No.4, Tr.N.Murugesan was Gr.I constable Ist Platoon, Madurai District, who was nominated as the cameraman in AR ground during the recruitment process and all the accused are public servant within the ambit and purview of Section 2(c) of Prevention of Corruption Act, 1988.

On receipt of credible information through sources which reveals relating to the commission of malpractices and irregularities in the process of said recruitment conducted between 27.07.2017 and 08.08.2017 at Armed Reserve Ground, Madurai for conducting Physical Efficiency Test for Men. Seven male Candidates namely 1) P.M.Sathishkumar (2420194) 2) K.Dineshbabu (2421567), 3) M.Muthukumar (2418938), 4) P.Suresh (2415689), 5) G.Giri (2415256), 6) V.Balakrishnan (2401132) and 7) Vignesh (2407117) who were absent on 04.08.17, 05.08.17 and 07.08.17, reported for the test only on 08.08.2017. The appearance of the absented candidates on 08.08.2017 was not informed to the Chairman of Sub-Committee, i.e. the Deputy Inspector General of Police, Madurai Range intentionally by AO-1.

The said recruitment was conducted in Madurai under the head of the Chairman, the Deputy Inspector General of Police, Madurai Range and five Board

members. In this recruitment process, candidates who satisfy the pre-requisite conditions of age and educational qualifications were called for written test. Physical Measurement test was conducted for the candidates who have come out successfully in the written test. The candidates qualified in physical measurement were allowed to undergo Physical efficiency test. In the physical efficiency test, rope climbing was compulsory event for men and long jump for women.

After completing the first Phase of the recruitment process namely Physical Measurement Test the selected candidates were allowed to the second phase of the recruitment namely Physical Efficiency Test for Men held between 04.08.2017 and 08.08.2017.

AOs 2 to 4 and others were posted under Nodal Officer (AO-1) Tr.Kumar. Nodal Committee members were entrusted with duties and fixed responsibilities during the recruitment process.

As directed by AO-1, the applications and Coding Sheets of the above said seven candidates were handed over to one Tr.Saravanan, Junior Assistant with instruction to hand over the said records to the staff at Rope-I. As such the said 7 absentees were taken to Rope-I and their OMR coding sheets and call letters were handed over to AO-2 Tr.Balamurugan and AO-3 Tr.Muralitharan which were acknowledged by AO-2 Tr.Balamurugan. On receipt of the OMR coding sheets and call letters of the above said seven candidates, AO-2 Tr.Balamurugan and AO-3 Tr.Muralitharan had made entries in the incoming register as usual. But, they kept aside the coding sheets of first three candidates 1) Tr.P.M.Sathishkumar (2420194), 2) Tr.K.Dineshababu (2421567), 3) Tr.M.Muthukumar (2418938). They sent the remaining absentees of 4 candidates to Rope-2.

Further 12 candidates from the 6th counter for the verification of certificates were escorted by PC 388, Tr.Matchenthran to Rope-II, but he was diverted by AO-4 Tr.Murugesan, Gr.I.PC.694 and told that there was instruction that the candidates should be produced in Rope -I. AO-4's nephew

Tr.Surya was one of the candidate in the batch of 12 candidates brought to Rope -I. The OMR coding sheets and call letters of the above 12 candidates were also received in Rope-I and acknowledged by AO-3 Muralitharan. Being abetted by AO-4 Tr.Murugesan, AO-2 Tr.Balamurugan and AO-3 Tr.Muralitharan managed to take the OMR coding sheet of Tr.Surya (2430145) and kept along with the already concealed three Coding sheets.

AO-1's bounden duty was to inform about the appearance of the absentees before the Chairman. But AO-1 deliberately failed to inform the appearance of 7 absentees on 08.08.2017 before the Chairman of Sub-Committee, TNUSRB i.e. the Deputy Inspector General of Police, Madurai Range.


AO-2 Tr.Balamurugan and AO-3 Tr.Muralitharan have entered into criminal conspiracy with each other and agreed to do illegal Act and illegal means and conspired with other AOs with intent to defraud made fraudulent entries in the Mark Result Sheets of the above 4 candidates and shaded in the respective boxes of the coding sheet of the candidates as qualified in rope climbing, as if the candidates climbed rope up to 6 meters and obtained 2 stars and five marks each without actually climbing the rope and thereby created false records by bringing into existence of the facts and produced the same before the Sports Officer Tr.Thavaputhalvan. AO-4 Murugesan, in connivance with AO-2 and AO-3 induced them to make fraudulent entry of 5 marks for the rope climbing for the candidate Tr.Surya, who is his nephew without actually climbing the rope.

From the above facts brought through sources would disclose that Accused Officers 1 to 4 being public servants and while holding their respective posts, hatch up a criminal conspiracy with each other to commit fraud by creating false records so as to use the same as genuine for the purpose of cheating in the matter of selection of candidates by resulting a loss to the Government so as to get pecuniary advantages for themselves and thereby

AOs 1 to 4 committed the offences punishable u/s 120-B, 420, 467, 468, 471 IPC and 13(2) r/w 13(1) (d) of PC Act 1988.

Hence, I am registering a case today on 06.03.2018 in Madurai Vigilance Anti-Corruption Crime No. 07/2018 at 1700 hrs.

The original FIR is submitted to the Special Judge, Trial of Cases under Prevention of Corruption Act, Madurai and copies were sent to the officers concerned.
