## First Information Report of Dindigul Vigilance and Anti-Corruption, Cr.No.8/2018 continues:

staff No. 62438. He served in various places and worked as Cashier in Dindigul- III Branch during the occurrence. The A-2 Tr.S.Vellaichamy (Senior Superintendent) is a native of Thoonganampatti, Vedasandur Taluk, of Dindigul Disrict. He entered in Tamil Nadu Transport Corporation on 08.06.1982 as Junior Assistant having Staff No.30286. He served in various sections and has worked as Senior Superintendent, Dindigul –III Branch Accounts Department and has retired from his service on 30.06.2017.

The A-3 Tr.Balusamy (Branch Manager, TNSTC (MDU) Itd Dindigul-III Branch) is a native of Palani .He entered in Tamil Nadu Transport Corporation Department on 21.08.1989 as Junior Engineer. He served in many places and Dindigul-III Branch from 28.11.2015 to 24.10.2017 and has been in Palani Bus Stand from 27.10.2017 to till date. As such A1 to A3 were public servants within the meaning of Section 2 (c) of Prevention of Corruption Act, 1988 at the relevant period of occurrence

The Enquiry revealed that the Ministry of Finance, Department of Economic Affairs, Government of India S.O.3408(E) issued a notification dt 08.11.2016 declaring that the bank notes of existing series of denomination of the value of five hundred rupees and one thousand rupees shall cease to be legal tender on and from 9<sup>th</sup> November 2016 and further the Department gave certain exemptions in the notification for the convenience of the members of public and declared that the specified bank notes shall not ceased to be legal tender, for the period from the 9<sup>th</sup> November 2016 until the 11<sup>th</sup> November 2016, to the extent of certain specified transactions and all establishments referred therein shall maintain complete account of record of stock and sale transactions made with the specified bank notes during the period between 9<sup>th</sup> November 2016 and 11<sup>th</sup> November 2016.

The enquiry revealed that based on the exemption given in the notified of the Government of India, dt. 08.11.2016, the Tamil Nadu State Trance Corporation (MDU) Central Accounts department issued a circular on 09.112 mentioning that all the conductors of TNSTC (MDU) Division may recercise Rs.500/- and Rs.1000/- currency notes for the cost of tickets until 24.00 hrs 11.11.2016 (i.e., 12 O'clock midnight of 11<sup>th</sup> November 2016.) and make an entitient in the invoice and the said invoice is to be counter signed by Branch Manager.

The enquiry further revealed that the conductors collected only low denomination currencies like Rs.5/-,10/-,20/-,50/- and 100/- for the cost of tickets and handed over the same to the A1, who was the cashier and the said A1 was entrusted with the said sum of Rs.25,46,520/- Having dominion and control over the said sum of Rs.25,46,520/- converted the said denomination currency notes into his own use by violating the direction and changing the said denomination of currency notes into denominations of Rs.500/- and Rs.1000/-, i.e the currencies of the said denominations were not collected for the cost of tickets but A1 deposited the said sum of Rs.20,80,000/- in the denominations of Rs.500/- and Rs.1000/- and along with other actual collections as if the same were collected by the conductors, into the OD account of TNSTC in Canara Bank Account and cheated the Public exchequer during the period between 14.11.2016 and 18.11.2016 by corrupt practices.

The enquiry further revealed that the A2 and A3 who were the Accounts Senior Superintendent and Branch Manager of the said TNSTC, Madurai, Dindigul Region respectively during the above said period abetted the A1 in the commission of the offence of Criminal Breach of Trust in respect of the said sum of Rs.20,80,000/- by facilitating the A1 to deposit the illegal money and in order to cover up their acts, forged the vouchers and statements and used the same as genuine and further made false entries in the account book and other relevant books and records.
