Based а petition on received from Dr. H.S. Shiek Ibrahim, Keelkattalai. Chennai-117 dated: allegations 23.01.2017 containing that the accused Tr. Kalimuthu formerly worked as Zonal Deputy Madurai Tahsildar, North Taluk. Madurai during the period from 10.11.2006 to 09.04.2008 as being a public servant as per section 2(c) of the Prevention of Corruption Act 1988 the conspired with marginally noted accused 1. Tr. Anwar Basha,

2. Tr. P. Senthil Kumar and 3. Tmt. Razia Beham and issued patta to the private parties knowing that the said property is Government Inam Lands (Thennur Thanner Pandal Manibam lands) and facilitated the private individuals to convert the said Thanneer Pandal Manibam lands into housing plots in the name of Diamond Auto City and hence a preliminary Enquiry was registered in PE No.57/2017/REV/MU dated: 24.07.2017 and the enquiry revealed the following facts.

The lands in survey numbers 7/1, 11/1, 11/2A, 11/2B, 11/3A, 11/3B, 11/3C, 11/3D, 11/3E, 11/4, 13/6, 27/1, 29/4, 34/2, 26/1 measuring 33.54 acres of Thenur Bit-I village of Madurai North Taluk, Madurai District. TD No. 1128 are water Pandalmanibam lands of the Government given during the British period to the shareholders of Dabbedar Shandai. It is a Dharmadayam grant and the above lands are inalienable. The shareholders of the said land even from the year 1863 elected suitable persons as managers for the time being for the purpose of management of the property and to look after a Shandai in Survey No. 7/1 (Dabbedar Shandai) located 3 Km away from Samayanallur on Madurai Dindigul Highway and used to pay tax for the Thanneer Pandal Manibam Lands.

It is further revealed that after the abolition of Inam, many shareholders wanted a ryotwaripatta for the Inam Lands. In the court of settlement Thasildhar (M-1) Madurai-2 ER 16M1 Act/MDU/66 dated 22.04.72 Ryotwaripatta was granted under section 11 read with section 8(2) (i)(b) of Tamil Nadu Minor Inams (Abolition and conversion into Ryotwari) Act, 1963 (Act 30/63) and because of the condition of restriction nobody opted for the Ryotwaripatta and hence the lands remained as Thennur Thanneer Pandal Manibam Lands with TD No. 1128 and till 2010 the 33.54 acre lands were never sold or registered because they are Thanneer Pandal Lands and inalienable.

It is further revealed that in pursuance of the their criminal conspiracy, the accused Tmt. Razia Begam, applied for a separate patta in her name for the lands measuring about 0.71 cents in S.No. 11/3A and about 0.75 cents in S. No. 11/3C. The accused Tr. Kalimuthu who was working as Zonal Deputy Thasildhar, Madurai North Madurai during the period from 10.11.2006 to 09.04.2008 dishonestly concealed the fact that the land is only Thennur Thanneer Pandal Land and knowing that the same is inalienable in nature and based on the recommendation of the then Village Administrative Officer, Thennur Village, Late H. Ajmalkhan issued a proceeding vide RTP 4189/06 dated: 03.06.2007 for patta No. 172 in the name of "Thennur Tanneer Pandal M. Raziah Begam W/o Moinudeen Sahib the manager for the time being" and facilitated the said Tmt. M. Razia Begam to gain wrongfully by causing wrongful loss to the Government.

It is further revealed that the lands in S.No. 26/1 along with some other lands were originally granted to the fore-fathers of the accused M. Anwar Basha for rendering Thanneer Pandal services as Dharmadayam Inam under TD No. 1138 which are not alienable and was issued with a patta No. 49 in favour of Thanneer Pandal, Manager for the time being M.Anwar Basha and the land was not saleable and they got only enjoyment right over those land. But concealing these facts the accused Tr. M.Anwar Basha executed a Power of Attorney as if he is the owner of the land and the same is his ancestral property in favour of the accused Tr. Senthilkumar and the

same was registered by Tmt. Loganayaki and Tmt. G. Saraswathi, Sub-Registrars of Sholavandan Sub-Registry, without verifying the revenue records or ownership deeds and facilitated the said accused Tr. Senthilkumar to convert the Thanneer Pandal Manibam Lands into plots in the name of Diamond Auto City and again Tmt. G. Saraswathi, Tr. Maurugesan and Tmt. Rajathilagam who were working as Sub Registrars of Sholavandan Sub-Registrar Office also, without verifying the revenue records or with the knowledge that the lands are Thanneer Pandal Manibam Lands registered the sale deeds presented by the said Diamond Auto City Housing Sites.

The accused Tr. Kalimuthu, who was working as the Zonal Deputy Tahsildar having dominion over the lands belong to the Government in his capacity of a public servant dishonestly disposed the property in violation of direction of law and implied contract and willfully suffered the other accused to covert the property in pursuance of their criminal conspiracy. Further the accused Tr. Kalimuthu transferred the patta which gave an authority to transfer the property by using the same as genuine for the purpose of cheating the Government and the public who were using the property as Thanneer Pandal and further allowed other person to convert the property which was under his control and thereby pecuniary advantage accrued in favour of number of persons without any public interest and facilitated the other accused to do so.

The above information collected during Preliminary Enquiry, discloses a suspicion of commission of cognizable offences Under section 120-B, 409, 467, 468, 471, 420 IPC and 13(2) r/w 13(1)(c) and (d) of the Prevention of Corruption Act, 1988.

Hence, I am registering a case in Madurai Vigilance and Anti-Corruption Police Station Cr. No. 09/2018 u/s 120-B, 409, 467, 468, 471, 420 IPC and 13(2) r/w 13(1)(c) and (d) of the Prevention of Corruption Act, 1988.

The Original FIR is submitted to the Special Judge for cases under Prevention of Corruption Act, Madurai and copies were sent to the officers concerned.
