Today on 22.04.2019 at 10.00 hrs when I was in my office Room No. 101, First Floor, Railway Station Road, Alandur, Chennai-16, as per the instruction of Directorate of Vigilance and Anti Corruption, a case was registered in Chennai V&AC, Chennai City-III, Cr.No. 3/AC/2019/CC-III, u/s 7, 13(2) r/w 13(1) (d) of PC Act 1988 against Tr.V.Chandrasekaran, formerly Thabedar, (Office Assistant), O/o Hon'ble Minister for Health, now Thabedar, Agriculture Department Secretariat, Chennai-9.

It is learnt that Tr.V.Chandrasekaran, formerly Thabedar, (Office Assistant), O/o Hon'ble Minister for Health, now Thabedar, Agriculture Department Secretariat, Chennai-9, involved into the allegations regarding that being a Government Servant he knowingly involved in bribe activities demand and accepted Rs. 13,00,000/- from the petitioner Tr.K.M.Jayaprakash.

....

It is learnt that the accused Tr.V.Chandrasekaran, formerly Thabedar, (Office Assistant), O/o Hon'ble Minister for Health and hence, he is a public servant as defined U/s 2(c) of the Prevention of Corruption Act, 1988 at the relevant period of occurrence.

The Facts of the case, one Tr.G.Senthilkumar, M/A-34/2018, S/o Tr.C.Gunasekaran, No.48/D, Pillaiyar Koil 1st Street, Narasingapuram, Athur, Salem District – 636 117 had received a interview card for the post of Assistant Engineer for Electrical Mechanical and Civil (Trainee) for the period of 3 months, and after successful and satisfactory completion of the training period, the concerned will be regularly appointed as Assistant Engineer in the time scale of pay Rs.10,100 - 35,800 in PB 2 with Grade pay of Rs. 4,600/-. Interview dated 25.04.2012 at 2 pm at the Chief Energy / Personnel, TANGEDCO, Head Quarters, No.44, Anna Salai, Chennai-2. He attended the interview but he was not selected.

One Tr.K.M.Jayaprakash, Kalleripatti, Aathur Taluk, Salem District and Tr.C.Gunasekaran were friends. They are neighboring villagers. After Tr.Senthilkumar not selected in his interview Tr.Gunasekaran met Tr.K.M.Jayaprakash and asked him to get any government job, for that Tr.K.M.Jayaprakash told for any government job money should be given. Based on the verdict of Tr.K.M.Jayaprakash and Tr.Gunasekaran deposited Rs. 1,00,000/- in Tr.K.M.Jayaprakash's account number 716010100005661 on 13.08.2012, Rs.1,10,000/- on 04.01.2013 at Axis Bank. Athur Branch, Salem District and had given Rs.1,00,000/- cash to Tr.K.M.Jayaprakash at Athur, as told / demanded by Tr.K.M.Jayaprakash to get a government appointment, as told by Tr.K.M.Jayaprakash. In this regard Tr.K.M.Jayaprakash told Tr.C.Gunasekaran that Rs.10,000/- was taken by him for his expense. Meant time Tr.Senthil Kumar Son of Tr.C.Gunasekaran of Narasingapuram, Athur, Salem District received a interview card for the post of Assistant Engineer in Electricity Board Department dated 23.11.2013. On knowing the above matter from Tr.C.Gunasekaran, Tr.Jayaprakash contacted Tr.V.Anandaraj, Section Officer (Retired) a friend of him and asked him to come to Secretariat, on narrating the interview matter, Tr.K.M.Jayaprakash requested Tr.V.Anandaraj to help in this regard, in turn Tr.V.Anandaraj introduced Tr.K.M.Jayaprakash to Tr.V.Chandrasekaran, at that time Tr.V.Chandrasekaran was working as (O.A), Thabedar to O/o the Health Minister, Secretariat, Chennai. Then Tr.V.Anandaraj never involved in this matter and the petitioner never called Tr.V.Anandaraj for any cost.

After the interview card of Tr.G.Senthil seen Kumar. Tr.Chandrasekaran, told that Personal Assistant to Electricity Board Minister, Tr.G.Senthil Kumar is close to me and further he told after contact with him he will convey the message. After some day, Tr.K.M.Jayaprakash met Tr.Chandrasekaran at Secretariat, Tr.Chandrasekaran conveyed to Tr.K.M.Jayaprakash that Tr.G.Senthil Kumar, P.A to Electricity Board Minister demanded Rs.13,00,000/- to made arrangements to get the post of Assistant Engineer. Tr.K.M.Jayaprakash conveyed the message to Tr.C.Gunasekaran

that Rs.13,00,000/- was demanded by Tr.V.Chandrasekaran to get the Assistant Engineer post at Electricity Board Department. Hence, he told to Tr C Gunasekaran, that you have already given Rs. 3,00,000/- in this regard, the remaining amount of Rs.10,00,000/- (Rupees Ten Lakhs) in addition to Rs. 3,00,000/- should be given and further he told Tr.C.Gunasekaran to deposit the amount in his account at Axis Bank, Athur Branch. Tr.C.Gunasekaran deposited the said amount of Rs. 10,00,000/- in the account of Tr.K.M.Jayaprakash's bank of Axis Bank, Athur Branch in account number 716010100005661 on 18.12.2013 (Rs.8,35,000/- and 20.12.2013) 1,65,000/-) through pay-in slips. The amount credited Rs. by Tr.C.Gunasekaran at Athur was taken by Tr.K.M.Jayaprakash in his account Axis Bank, Mylapore Branch with at along Tr.P.V.Rajendran. Tr.C.Gunasekaran had credited Rs. 12,10,000/- in the account of petitioner Tr.K.M.Jayaprakash in pay in slip. To get his son Tr.G.Senthil Kumar's appointment as Assistant Engineer in Electricity Board Department, as assured that Tr.K.M.Jayaprakash would got appointment from his source. But Tr.K.M.Jayaprakash could not be able to get the appointment through Tr.V.Chandrasekaran. The enquiry reveals that Tr.K.M.Jayaprakash told that he had given all the money got from Tr.C.Gunasekaran to Tr.G.Senthil Kumar, Personal Assistant to Electricity Board Minister. While enquired with Tr.G.Senthil Kumr, Personal Assistant to formerly Minister for Electricity Board, he totally denied the allegation, further he told that he never seen Tr.V.Chandrasekaran and further he added that Electricity Board had constituted a Selection Committee for every appointment in Electricity Board, since the decision was taken by the Selection Committee there was no chance for any recommendations. On the compulsion given over to Tr.K.M.Jayaprakash by Tr.C.Gunasekaran to return the money, in turn Tr.K.M.Jayaprakash compelled Tr.V.Chandrasekaran to return the amount (Rs.13,00,000/-, Rupees Thirteen Lakhs) received from him. Tr.V.Chandrasekaran after taking long time he turned Rs.5,00,000/- (Rupees Five Lakhs) to Tr.K.M.Jayaprakash on 25.02.2015 and in turn Tr.K.M.Jayaprakash settled Rs. 5,00,000/- to Tr.C.Gunasekaran. On the

complaint of Tr.K.M.Jayaprakash against Tr.V.Chanrasekaran before S-15 Selaiyur Police Station on 16.10.2018 with regard to the return of balance Rs. 10,00,000/- which was paid to Tr.V.Chandrasekaran to get Assistant Engineer post Electricity Board Department. Sub Inspector of Police, Tr.Ragupathy he registered the above petition and gave a CSR in 1651/2018 and enquired both parties. There V.Chandrasekaran on appearance before the Enquiry Officer, Sub Inspector of Police, there, Tr.V.Chandrasekaran agreed the above transactions and admitted that he had received Rs.13,00,000/- from Tr.K.M.Jayaprakash for the purpose of getting Government job to Tr.G.Senthil Kumar S/o Tr.C.Gunasekaran, since Tr.C.Chandraseskaran could not be able to get the Government job for Tr.G.Senthil Kumar he had paid Rs. 5,00,000/-. And further he gave two cheques, each for Rs. 4,00,000/-, unnamed, but guoted the amount in letter and figure. Cheque No. 7083 23 and 7083 24 SBI, Velachery Road, Selaivur, A/c. No. 30176639306, for that he had given a letter in writing in a Rs.20/bond paper all are on record. Tr.V.Chandrasekaran being a public servant falsely promised, that he will do favour to get an appointment order to Tr.G.Senthil Kumar, S/o Tr.C.Gunasekaran, he demanded bribe from Tr.K.M.Jayaprakash and accepted Rs. 13,00,000/-. Tr.V.Chandrasekaran accepted the said demand and acceptance of Rs. 13,00,000/- from Tr.K.M.Jayaprakash.

Tr.V.Chandrasekaran is a public servant as defined in section 2 (c) of Prevention of Corruption Act 1988. Since the offence is taken before the new amendment of PC Act 1988, AO is liable to be punished under section 7, 13(2) r/w 13(1) (d) of PC Act 1988.

Action Taken:

Since the above facts discloses a prima facie case against the said Tr.V.Chandrasekaran, formerly Thabedar, (Office Assistant), O./o Hon'ble Minister for Health, now Thabedar, Agriculture Department Secretariat, Chennai-9, I am registering a case in Chennai City-III Crime No. 3/2019/AC/CC-III, U/s 7, 13(2) r/w 13(1) (d) of PC Act at 10.00 hrs today (22.04.2019) against the accused for the aforesaid offence, for the purpose of investigation.
