It is a peculiar case wherein after the completion of the Preliminary Enquiry, complainant Tr.K.Duraisamy turned accused, Tr.V.Nambinathan arrayed as accused in complaint was found innocent. So the complainant is arrayed as 2nd accused in this case and Tr.V.Nambinathan is cited as witness in this case.

A-2 who was the petitioner of this case availed loans from Kandanvilai PACCS by furnishing false particulars. A-3 to A-8 are the accused who worked in the respective period as Officers at PACCS. Special Kandanvilai. A-1 Tr.D.Arul Raj, S/o David, Chithan Thoppu, Kandanvilai Post, Kanyakumari District and A-9 Tr. Issac was the sitting president and Vice President of Kandanvilai Primary Agricultural Co-Operative Credit Society from May-2013. A-10 to A-17 are the accused who are the Board Members of PACCS, Kandanvilai. A-2, A-9 to A-17 are Private individuals. At the time of commission of offence A-1 was the President of the above said society. Hence, he was also a public servant u/s 2(c) of PC Act 1988 (Act No.16 of Amendment) Act 2018. A-3 to A-8 are public servants defined u/s Prevention of Corruption (c) (Amendment) Act 2018.

Medium Term (Agriculture) Loan and Long Term (Farm Sector) Loan issued to the small and marginal farmers of the Co-operative Societies as 31.03.2016. The Society Bi-law and Society Act Sec. 23(1)(g) insists that, one person should not be a member of two same category of Society. On the records perusal Kandanvilai and Karancadu Primary Agricultural Co-Operative Credit Societies reveals that A-2 Tr.K.Duraiswamy having membership No.2340 with Kandanvilai PACCS and also having membership No.3355 and loan A/c No.2868 with Karancadu PACCS. As Bi-law per the Kandanvilai Primary Agricultural Co-Operative Credit Society a member of its jurisdiction should not be a another Primary member ofAgricultural Co-Operative Credit Society of same category. The A-2 Tr.K.Duraiswamy living jurisdiction of Karancadu PACCS has availed loans from Karancadu PACCS and availed the benefit of waiver in connection with the loan Karancadu PACCS. Being member of Karankadu PACCS A-2 has knowingly

admitted himself as "A" Class Member in Kandanvilai PACCS during the year 2003 and availed 16 numbers of loans from 2003 to 2016. The President, Vice President, Society Secretaries, Special Officers, Board members followed by Tr.Thomas and Tr.Subbiah Pillai (both expired), without perusing obtaining NOC from Tr.K.Duraisamy, had issued 16 loans to him. He is pertinent to state that Tmt.Ambika. the wife Tr.K.Duraiswamy, was working Kandanvilai PACCS during the period between 2003 to 2016. Hence, it is very clear that, there was a collusion and criminal conspiracy between the President, Vice President, Society Secretaries, Special Officers, Board members and Tr.Duraiswamy between 27.01.2006 to 16.07.2015. Whenever a loan issued to an 'A' class member of

the society, NOC from the nearest PACCS should be obtained every time before issuance of the loan. The marginally noted Special Officers, the board members and the Secretaries served in Kandanvilai PACCS well aware of the Jurisdiction of Kandavilai and Karancadu PACCS and with knowledge about the residence of A-2 Tr.K.Duraiswamy in Karancadu Jurisdiction have knowingly and willfully abused their power and issued 16 loans in Kandanvilai PACCS to A.-2 Tr.K.Duraiswamy from the period 2006 to till 2016. Tr.V.Nambinathan, Tmt.Christal Stella and Tr.Saravanan were nominated vide proceedings No.p.s.2634/2016, Options. dt.28.07.2016 of the Joint Registrar of Co-operative

Societies, Kanyakumari District for the 100% verification of loan availed by the small farmers and the marginal farmers those who availed loan. As per the above government order while the verification team prepared the 100% verification list, Tr.K.Duraiswamy was excluded from the waivers list of Kandanvilai PACCS, since his loan amount of Rs.40,000/- availed from Karancadu PACCS was already waived. Hence the act of excluding the name of Duraiswamy by witness Tr.V.Nambinathan, who is the member of the verification team, is correct as per society By-law. The Special Officers and the Secretaries, who sanctioned, recommended and issued Tr.K.Duraiswamy from 2006 to 2016 in Kandanvilai PACCS without obtaining and verifying the NOC from Karancadu are mentioned in details under the headings date of loan amount received, Loan Sanctioning authority and Loan Recommended by Secretary is 1) 27.01.2006/ Rs.66000+ 1045 Int. A-2 Tr.K.Duraiswamy in collusion with A-1, A-3 to A-17 knowingly that he was 'A' class member of same type of Karankadu PACCS concealed to get A-2 the membership at Kandanvilai PACCS during 2003 and Tr. Thomas (Expired), the then Secretary, knowingly issued the membership to Tr.K.Duraiswamy. Thus A-1 and A-3 to A-17 knowingly and willfully conspired together with A-2, recommended, sanctioned and issued 16 number of loans for the period between 2006 and 2016 from Kandanvialai PACCS to A-2 Tr.K.Duraiswamy with the knowledge that A-2 Tr.K.Duraiswamy is already a member of Karancadu PACCS and thereby caused monitory loss to the tune of Rs.2,21,025/- to Government. For this financial loss, 1.Tr.K.Duraiswamy, 2.Tr.Liakath Ali, 3.Tr.Chella Perumal, 4.Tr.S.Mony, 5.Tmt.Sulochana Bai, 6.Tr.John, 7.Tmt.Vijayalekshmi, 8.Tr.D.Arulraj, 9.Tr.Isac, 10.Tr.P.M.Justus, 11.Tr.V.Xavier 12.Tr.V.Subramanian, 13.Tr.T.Vijayakumar, Rai. 14.Tmt.T.Thires Mary, 15.Tr.A.Reslin Bindu, 16.Tr.Y.Yesther King, 17. Tr.S.Oliver all are responsible. Hence, the accused A-2 colluded with A-1 and A-3 to A-17 knowingly and willfully have indulged into criminal conspiracy with each other from the period 27.01.2006 to 31.05.2016 and thereby furnished false information and framed incorrect records and committed criminal breach of trust in respect of the amount entrusted to them for disbursing as loan to eligible members and have thereby cheated the authorities concerned by inducing them and made them to believe and to deliver the funds for the purpose of loan and dishonestly and fraudulently made use of the funds entrusted to them as a public servant for their own use and use of A-2 thereby committed Criminal Misconduct and caused financial loss to the Government to the tune of Rs.2,21,025/-.So the criminal act of A-1 to A-17 disclosed offences u/s 120-B, 167, 177, 409 and 420, IPC and u/s 13[2] r/w 13(1) (c) of Prevention of Corruption Act 1988. So I am registering a case in Nagercoil

Vigilance and Anti-Corruption Cr.No.03/2019 under the above section against the accused for investigation. I hereby send the original FIR to the Special Judge cum Chief Judicial Magistrate, Kanyakumari District @ Nagercoil and other copies to the officials concerned. and I handed over a copy of the F.I.R to Tr.J.Raju, Inspector of Police for further investigation.
