## 12. F.I.R. contents (Attach separate sheet if required):

Submitted: On 02.11.2018 there was some credible information that the Assistant Director and Staff of the office of the Assistant Director, Town Panchayat, Theni District used to receive money as gift for Deewali Festival from the officials of the Town Panchayat offices in Theni District. Therefore, a Joint Surprise Check was organised and conducted at the office of the Assistant Director, Town Panchayat, Theni District along with Tr.A.Ashokumar, Inspector, O/o the District Inspection Cell, Madurai and Police party between 18.00 hrs and 21.30 hrs on 02.11.2018. During the surprise check the suspected officials who all are mentioned in the Column No.7 on the FIR were present. During the surprise check in the said office 1) A Sum of Rs.23,000/- with white cover was found under the Plastic Chairs placed with the east side wall of the main hall of the said office, 2)Rs.30,000/- kept in a cloth bag printed as "Theni Anantham" was found on the slate stone table placed in the kitchen cum dining room, 3) Rs.27,200/- covered by a News Paper behind the main entrance door of the said office. Hence, the total amount of unclaimed Rs.80,200/- was seized as unaccounted money under suspicious circumstances through the mahazar prepared between 18.00 hrs and 21.30 hrs on 02.11.2018. When questioned about the said amount 1)Tr.S.Sethuraman, Assistant Director, Assistant Director of Town Panchayats, Theni Zone, Theni District, 2)Tr.K.R.S.Karuppiah, Assistant Executive Engineer, 3)Tr.V.Subramanian, Executive. Officer. (Admin), 4)Tmt.G.Murugeshwari, Assistant, 5)Tr.G.Raja, Junior Assistant,

Driver, Assistant Director 6)Tr.P.Krishnamoorthy, of Town Panchayats, Theni Zone, Theni District could not satisfactorily account for the same. The amount of Rs.80,200/- might have been received / collected from the officials of the Town Panchayat Offices in Theni District as undue advantage by the officials of the said O/o the Assistant Director, Town Panchayat, Theni District. Hence, the unclaimed abandoned money of Rs.80,200/- (Rupees Eighty thousand and two hundred only) was seized as unaccounted money under suspicious circumstances. In this connection after getting permission from the Director, Vigilance and Anti-Corruption, Chennai, a case in Theni Vigilance and Anti-Corruption Cr.No.03/2019 u/s 102 Cr.P.C. and 7(a) of Prevention of Corruption (Amendment) Act - 2018 was registered on 26.06.19 at 09.00 hrs. The proceedings prepared at the office of the Assistant Director, Town Panchayat, Theni Districted dated 02.11.18 and the original FIR were sent to the Chief Judicial Magistrate / Special Judge, Theni and the copies to the officials concerned.
