I am serving as Additional Superintendent of Police, Vigilance and Anti-Corruption, City Special Unit-III, Chennai-16.

In pursuant of the order of the Government of Tamil Nadu vide G.O.(Rt.) No.20 dated 13.02.2019 of Rural Development and Panchayat Raj Department, issued with regard to guidelines to be followed for award of one time special relief fund of Rs.2,000/- to the Below Poverty Line people of rural and urban areas, a reliable information was received that in the process of updating data such as bank account details, smart card, Aadhar card details of beneficiaries of such below poverty line people of Chennai Corporation limits especially Division-122, Unit-26, Zone-9, Greater Chennai Corporation situated at No.602, Anna Salai, Teynampet, Chennai-18, the corporation officials are receiving bribe

amount as undue advantage to perform their duties in updation work of applications of beneficiaries. Hence a joint surprise check was organised by the officials of Vigilance and Anti-Corruption, City Special Unit-III and the District Inspection Cell Officer, Chennai District. On visiting the office premises at No.602, Anna Salai, public crowd were found lined up for the purpose of updation of the details of beneficiaries at the office of the Conservancy Inspector, Division-122, Unit-26, Zone-9 of Greater Chennal Corporation.

The District Inspection Cell Officer with the officials of Vigilance and Anti-Corruption, City Special Unit-III, Chennal, entered inside the said Conservancy Inspector office on 19.02.2019 at about 15.30 Hrs. and when the District Inspection Cell Officer made enquiry with one of the beneficiary Tmt.K.Muthulakshmi, Age 65/2019, W/o.Kumar, No.9, 'H' Block, Dr.Thomas Road, Thyagaraya Nagar, Chennai-17, stated that she gave her particulars to be updated in the form and submitted to the Conservancy Inspector lady then known to be Tmt.Ramya, W/o.Ramesh Babu (Late), which Tmt.Ramya has demanded Rs.100/- to be paid for processing her application (Greater Chennai Corporation PIP/BPL Data Updation Format ID: 10/136/17758 BPL/PIP No.33010113600798) and when she gave Rs.100/- to Tmt.Ramya, she instructed to hand over the amount of Rs.100/- to her staff Tmt.Revathi and the District Inspection Cell Officer has recorded the statement.

The District Inspection Cell Officer has also enquired Tmt.Revathi,

Animator, Division-122 and she accepted and has given a statement for

accepting Rs.100/- from beneficiaries on the instruction of Tmt.Ramya, Conservancy Inspector and a statement was recorded from her. The District Inspection Cell Officer further made enquiry with the persons present there, namely Tmt.S.Revathy, Tmt.D.Kapana, Tr.P.Guru, Tr.M.Dinesh Kumar, Tr.V.Santhana Krishnan, and Tr.V.Gopala Krishnan and their statements were also recorded from them.

Further the amount of Rs.1,300/- was seized from Tmt.R.Ramya, Rs.1,300/- from Tmt.S.Revathy, Rs.500/- from Tmt.D.Kalpana, Rs.1,800/- from Tr.M.Dinesh Kumar, Rs.1,200/- from Tr.V.Santhana Krishnan, Rs.1,100/- from Tr.V.Gopala Krishnan and Rs.2,900/- from Tr.P.Guru, totally Rs.10,100/- were seized by the District Inspection Cell Officer in the presence of DVAC officials since they did not give valid reasons for possession of above amount and suspected to have been received as undue advantage amount as bribe from the beneficiaries of Below Poverty Line. To that effect, a proceeding was drawn and signatures were obtained from the officials who were present there. The District Inspection Ceil Officer, Chennal District, handed over the proceeding, documents and seized cash of Rs.10,100/- with a complaint letter to the Additional Superintendent of Police, Vigilance and Anti-Corruption, City Special Unit-III, for taking necessary action according to law on 19,02,2019 at 21,45 Hrs.

Hence, a case in V&AC Crime No.4/AC/2019/CC-II u/s.102 Cr.P.C. and 7 of Prevention of Corruption (Amendment) Act, 2018 was registered on 20.02.2019 at 16.30 hrs. against 1) Tmt.R.Ramya, Conservancy Inspector,
