Submitted Sir, On 05.03.2019 at 09.00hrs while I was on duty in the office of the Vigilance and Anti-Corruption, Tirunelveli Detachment as per the memorandum of Director of. Vigilance and Anti-Corruption, Chennai in PE.108/2018/MED/TI dated 17.04.2018 in pursuance of the complaint of Dr.E.Syed Ibrahim, S/o.Ahamed Nahoor, Royal Hospital, No.2 Saron Theru, NGO. 'A' Colony, Tirunelveli-7, a Preliminary Inquiry was conducted. As per the Preliminary Inquiry, the Director of Vigilance and Anti-Corruption, Chennai through its memorandum PE.108/2018/MED/TI on 01.03.2019 order to registered case and accordingly this case is registered. The complaint of the above said Dr.E.Syed Ibrahim unfolded as follows: Respected Deputy Superintendent of Police Avl.,Vigilance and Anti-Corruption wing, Tirunelveli District.

13. Action taken : Since the above report reveals commission of offence(s) u/s as mentioned at item No.2 registered the case and took up the investigation / directed Subbiah Rank Deputy Supdt to take up the investigation / Refused Investigation / transferred to PS..... on point of jurisdiction.

Dr.E.Seyed Ibrahim, MBBS., DCW, MRCP. U.K., S/o.Ahammed Nahoor, Royal Hospital, No.2, Saran Theru, N.G.O. 'A' Colony, Tirunelveli-7: Petitioner/ Complainant /Vs/ Dr.P.G.Elangovan, Joint Director (Health Services), Thenkasi, Tirunelveli District :Counter-Petitioner/Accused. Subject : Regarding action against Counter-Petitioner for taking Scanning Machine kept in the hospital with the permission as bribe for granting administrative permission to another WIPRO GE LOGIO P-3 scanning machine and denying to return the SONOSCAPE S6 scanning machine. I am running a Children hospital in the above mentioned address in a name and style "Royal Hospital" with a facility for staying of inpatients and treatment with 60 beds. In the said hospital with proper permission from 30.04.2008 onwards a Scan Centre is also been conducted as per Government rules with condition that the permission granted has to be renewed once in 5 years. On 06.04.2011 onwards after duly applying and obtaining permission from the said Joint Director office, I am using the first SONOSCAPE S6 scanning machine worth of Rs.9.75 lakhs in my Scan Centre. Likewise from 21.09.2017 onwards I am using WIPRO GE LOGIO P3 the Second machine after obtaining permission from the above said office of the Joint Director while so, the above said second machine WIPRO GE LOGIO P3 got faulted and I submitted application on 23.10.2017 to grant permission to sell the said above machine and to purchase a new machine SONOSCAPE S22 worth of Rs.12 lakhs and to use the same. In absence of any reply from the O/o.the Joint Director office, I again sent a reminder letter on 14.12.2017 consideration emergent necessity. But even then no action was taken. Considering the essential necessity and emergency SONOSCAPE S22 new machine in which already order was placed was delivered in the hospital on 12.02.2018. In this circumstances on 03.03.2018, the Counter-Petitioner as usual came to our hospital for Inspection purposes and showing the (SONOSCAPE S22)

machine and told us to come to his office the next day and obtain the permission for the said SONOSCAPE S.22 scanning machine and told that he is taking away the 1st machine (SONOSCAPE S6) kept with due permission. He wrote something in a paper and obtained my signature without even furnishing copy of the same and the Counter-Petitioner and his assistant Tr.E.Swamynathan took away the machine in their Government Innovo car. This event is recorded in our CCTV Camera kept in the hospital. He even did not give the paper in which he obtained signature even for reading the same. When I questioned regarding the same he did not answer anything and told me to meet him in the office. As told by him, on 05.03.2018 when I went to his office, permission to sell the 2nd WIPRO GP LOGIO P3 and permission to use 3rd machine SONOSCAPE S22 was issued to me as applied by me. While so, I asked to return the seized SONOSCAPE S6 machine, he told that, that machine is the reward for this permission. The present value of this machine is Rs.6,00,000/-. Thereafter myself and the manager of my hospital made several calls to him through phone to return the machine, but till date he is refusing to return. (Conversation regarding the same is recorded in the phone)

In continuance of the same, on 12.03.2018 on my instruction, my manager Tr.R.Chidambaram and my friend Tr.Sheik Sinda Mathar met Dr.P.G.Elangovan, Joint Director, Health Services at Tenkasi and asked to return the SONOSCAPE S6, scan machine taken from my hospital, he had refused to return by saying that SONOSCAPE S6, Scan machine is necessary to a person known to him.

Again on 14.03.2018, when my hospital manager and my friend Tr.Shek Sidha Madar directly met Dr.P.G.Elangovan, Joint Director Health and asked to return SONOSCAPE S6 Scan Machine, he had refused by saying that it is necessary for a person known to him.

Finally, upon my instruction, my Manager Tr.R.Chidhambaram and my friend Tr.Sheik Sindha Madar met the Counter-Petitioner, Joint Director, Health at the o/o, Joint Director of Health Service, Tenkasi, Tirunelveli District. on 20.03.2018 at 18.00 hrs evening and asked to return the scan machine but he refused to do the same. Therefore, I request to take action against the Counter-Petitioner for taking away illegally by force and as bribe my SONOSCAPE S6 Scanning machine duly registered, used after due permission for granting Government permission to SONOSCAPE S22 scanning machine on the application after perusal. S/d.Signature Royal Hospital, NGO 'A' Colony, Tirunelveli-7. Phone 0462-2854237, dated 26.03.2018. Based on this complaint a Preliminary Inquiry was conducted on due permission from the Directorate, Vigilance and Anti-Corruption, Chennai. In the course of Preliminary Inquiry, witnesses have been examined orally and documents have been collected in this regard. The inquiry reveals that the act of the said Dr.P.G.Elangovan in forcibly and illegally taking away the old SONOSCAPE S6 machine as reward which was earlier installed legally after obtaining due permission of Joint Director Health Services constitutes offence punishable u/s.7 of the Prevention of the Corruption Act, 1988, as amended by the Prevention of Corruption (Amendment) Act, 2018. Hence, I am registering the case based on the information relating to cognizable Offence punishable under section 7 of the Prevention of corruption Act 1988 as amended by the Prevention of Corruption (Amendment) Act 2018 as disclosed in the above said complainant of Dr.E.Seyed Ibrahim and the Preliminary Inquiry.

Hence, I am registering a case in Tirunelveli Vigilance and Anti-Corruption Cr.No.04/2019 u/s. 7 of the Prevention of Corruption Act, 1988, as amended by the Prevention of Corruption (Amendment) Act, 2018 on 06.03.2019 at 17.00 hrs.

Original F.I.R is sent to the Special Judge, Special Court for Trial of Cases Under Prevention of Corruption Act, Tirunelveli and a copy of F.I.R is sent to the DVAC Headquarters and I took a copy of F.I.R for investigation.
