Continuation of the F.I.R. in the Nilgiris District Vigilance and Anti-Corruption Cr.No.5/2019/AC/NI.

It is submitted that, a confidential enquiry was conducted against Tr.R.Selvan formerly Assistant Director of Agriculture (Quality Control) Udhagamandalam, The Nilgiris District now under suspension and not allowed to retirement. The enquiry revealed the following informations:

2) The accused Tr.R.Selvan(A1) was working as Assistant Director of Agriculture (Quality Control), Udhagamandalam, the Nilgiris District from 07.07.2017 to 31.03.2019. He joined in to the Government service on 04.11.1981 as Village Extension worker. Then, he elevated as the Assistant Agriculture Officer on the year 1984 and elevated as Agricultural Officer on 08.12.1990. He was working at Soil Testing laboratory, Aduthurai from 08.12.1990 to 26.07.1993. Then he worked as Agricultural Officer, Soil survey and land use organization, Thanjavur from 02.08.1993 to 10.03.1995. Then he worked at Coimbatore as Agricultural Officer, Soil Survey and land use organization from 13.03.1995 to 10.06.1997. After that, he worked as Agricultural Officer, Fertilizer control laboratory, Udhagamandalam from 06.10.1997 to 25.07.2011 and he worked at Bio- fertilizer production unit, Avinashi from 25.07.2011 to 30.06.2015. Then he worked as Agricultural Officer, O/o the Assistant Director of Agriculture, Palladam from 08.07.2015 to 28.06.2016. And he was working at Government seed farm, Pongalur, Tiruppur District from 06.07.2016 to 06.07.2017. Then, he elevated to present rank i.e., Assistant Director of Agriculture on 07.07.2017. He is a public servant under section 2 (c) of the Prevention of Corruption Act 1988. Hatchigh H

- 3) His wife Tmt.R.Lakshmi (A2) is a house wife. They have two sons by name Selvan.Sudharson and Selvan.Gowtham. Both of them are school going children. His wife and his two sons have no independent sources of income. They living together and depending upon the accused.
- 4) On the basis of credible information, A1 by adopting corrupt and illegal means acquired properties in his name and his wife Tmt.R.Lakshmi. He had accumulated maximum assists during the period from 01.03.2008 to 28.02.2018 and hence, the check period is taken from 01.03.2008 to 28.02.2018 for calculating disproportionate assets acquired by him. During the check period between 01.03.2008 to 28.02.2018. The accused Tr.R.Selvan (A1) had acquired assets/pecuniary resources in his name and his wife Tmt.Lakshmi's name who had no independent sources of income.
 - 5) The accused Tr.R.Selvan and his wife having the asset for the value of Rs. 5,40,000/- as on 01.03.2008 i.e., at the beginning of the check period (Statement-I). The accused Tr.R.Selvan acquired assets in the name of himself and his wife Tmt.R.Lakshmi for the value of Rs. 1,14,80,627/- as on 28.02.2018 i.e., at the end of the check period (Statement -II).
- 6) During the check period i.e., from 01.03.2008 to 28.02.2018, the accused Tr.R.Selvan and his family members earned income of Rs. 69,46,130/- from his salary and other lawful sources (Statement-III). And the accused Tr.R.Selvan and his family members incurred the expenses during the check period was Rs.38,76,026/-(Statement-IV).

- 7) Hence, asset acquired by the accused Tr.R.Selvan in his name and in the name of his wife Tmt.R.Lakshmi during the check period was Rs.1,09,40,627/- i.e. Rs.1,14,80,627 Rs.5,40,000. (Statement V)
 - 8) Likely savings of the accused Tr.R.Selvan and his family members during the check period was Rs. 30,70,104/- i.e. Rs.69,46,130 Rs.38,76,026. (Statement-VI).
 - 9) Hence, the accused Tr.R.Selvan acquired disproportionate assets in the name of himself and his wife was Rs. 78,70,523/- (Statement V Statement –VI) during the check period between 01.03.2008 and 28.02.2018.

Percentage of disproportionate asset = $\frac{78.70,523}{69,46,130}$ \times 100 = 113.30%.

- 10) The above information discloses commission of cognizable offences of criminal misconduct committed by public servant punishable u/s 13(2) of Prevention of Corruption Act, 1988 which requires detailed investigation.

- 12) Thus there are prima facle material available for taking investigation against AT for the commission of offences punishable u/s 13 (2) 1/w 13 (1) (e) of Prevention of Corruption Act, 1988 A2 had committed offences punishable u/s 109 of IPC r/w 13 (2) 1/w 13 (1) (e) of Prevention of Corruption Act, 1988. Thence, Today 30.04.2019 at 15.30 hrs, 1 am registering a case in Niligiris detachment crime No./2019/AC/NI, u/s 13 (2) r/w 13 (1) (e) of Prevention of Corruption Act, 1988 against A1 Tr.R.Selvan and u/s 109 IPC r/w 13 (2) r/w 13 (1) (e) of Prevention of Corruption Act, 1988 against A2 TmL.Lakshmi for the aforesaid offences for the purpose to investigation.
 - 13) The original FIR is submitted to the Court of Assistant Sessions cum Special Judge for cases under the Prevention of Corruption Act 1988 and a copy of it is being sent to the Superintendent of Police, Western Range, Vigilance and Anti-Corruption, Chennal for Issuing authorization u/s 17 &18 of the Prevention of Corruption Act, 1988 to take up investigation in this case.
