Continuation to column No.12 of FIR in V&AC Crime No.06/AC/2019/CC-II dated 19.03.2019.

I am serving as Additional Superintendent of Police, Vigilance and Anti-Corruption, City Special Unit-III, Chennai-16. Based on the approval orders u/s.17 A of Prevention of Corruption (Amendment) Act, 2018 issued by the Additional Chief Secretary to Government, Rural Development and Panchayat Raj (E2) Department, Government of Tamil Nadu vide G.O. (3D) No.7 dated 11.01.2019, the Directorate of

Vigilance and Anti-Corruption, Chennai-16 vide Memorandum No.DE.76/2017/RDP /CSU-III dated 07.02.2019 had instructed me to register a Regular Case against the above noted accused.

Based on the Vigilance Report which was initiated in pursuance of the confidential information received from source regarding the allegations against the accused Tr.Kanniappan, formerly Vice President of Sirumangadu Village Panchayat, Sriperumpudur Taluk, Kancheepuram District, during the period 2015-16 and 2016-17 committed irregularities in connivance with the officials of Sirumangadu Village Panchayat, contractors and private individuals during the execution of general, maintenance and electrical development works of Sirumangadu Village, has falsely created records and made entries in village registers fraudulently and cheated and swindled money of Sirumangdu Village Panchayat Fund by abusing and misusing the official position and caused undue pecuniary advantage to private individual who are not entitled for. The facts revealed are as given hereunder:

The Accused-1 Tr.Kanniappan, formerly Vice-President and formerly Incharge President of Sirumangadu Village Panchayat, Sriperumpudur Taluk, Kancheepuram District, during his tenure as Vice-President and Incharge President of the Sirumangadu Village Panchayat during the period 2015-16 and 2016-17 is alleged to have created false bills and manipulated records as if various works towards maintenance in the village like new drainage canal, new bore wells, tar road works, water line repairing, street light work, high mass light erection etc. were carried out, with the connivance of A-2 Tr.C.Velmurugan, formerly Panchayat Secretary, Sirumangadu Village Panchayat,

now serving at Ramanujapuram Panchayat, A-3 Tr.S.Mariaselvam, Panchayat Assistant, Gunduperumpedu Panchayat, A-4 Tr.R.Siva, formerly Ward Member, Ward No.5, Sirumangadu Village Panchayat, A-5 Tmt.D.Prema, Union Overseer, Sirumangadu Panchayat, A-6 Tmt.T.Ramya, Assistant Engineer/Union Engineer, Sirumangadu Village Panchayat, Sriperumpudur Block, A-7 Tr.D.Sundaravadanam, Assistant Executive Engineer, Rural Development Department, Kancheepuram Sub Division, Kancheepuram District, A-8 Tr.R.Elumalai, Zonal Deputy Block Development Officer, Block No.12, Sirumangadu Village Panchayat, Sriperumpudur Block, Kancheepuram District, A-9 Tmt.K.Jayanthi, formerly Block Development Officer, Sriperumpudur Block, Kancheepuram District, now Block Development Officer/Superintendent, Directorate of Rural Development, Saidapet, Chennai-15, A-10 Tr.M.Anusuya, Zonal Deputy Block Development Officer, Sriperumpudur Block, Kancheepuram District, A-11 Tr.S.Srinivasan, Deputy Block Development Officer (Audit), Rural Development Department, Kancheepuram District, A-12 Tmt.P.Prasanna Vasanthi, formerly Block Development Officer, Sriperumpudur Block, Kancheepuram District, now serving at Kattangulathur Block, Kancheepuram District, A-13 Tmt.V.T.Leema Rose, formerly Block Development Officer, Sriperumpudur Block, Kancheepuram District, now serving at Kattankulathur Block, and Private Individuals A-14 Tr.S.Harikrishnan, working Staff, Bharath Enterprises, Chennai-26, A-15 Tr.D.Dhanasekaran, Septic Tank Cleaner, Sirumangadu Village, A-16 Tr.K.Vishwanathan, Civil Work Contractor, Sirumangadu Panchayat, A-17 Tr.M.Silambarasan, Proprietor, A.M.Enterprises, Kancheepuram, A-18 Tr.D.Jayachandran, Proprietor, Vijai Electricals, Sriperumpudur, A-19 Tr.B.Beema

Ram, Proprietor, Ganesh Electricals, Sunkuvarchathiram, A-20 Tr.C.Velumani, Civil Work Contractor, Sirumangadu Panchayat, A-21 Tr.C.Sabapathy, Civil Work Contractor, Sirumangadu Panchayat, and A-22 Tr.B.Srinivasa Rao, Proprietor, Srinivasa Electricals, Sunguvarchathiram, Kancheepuram District, and misappropriated the village funds to the tune of Rs.46,55,406/-.

The Accused-1 to 13 during the period of 2015-2016 and 2016-17 are/were public servants as defined u/s.2 (c) of Prevention of Corruption Act, 1988 during the relevant period of offence.

The above facts constitutes the commission of offences of criminal misconduct,, criminal breach of trust by public servants, cheating, forgery, forgery of public records valuable security, forged document used as genuine and its possession, falsification of accounts by above mentioned public servants and private individuals.

Hence, I register a case against Accused-1, 2, 3 and 4 during their tenure being public servants are liable to be prosecuted for the offences of 13 (2) r/w.13 (1) (d) of Prevention of Corruption Act, 1988 and under Sections 409, 420, 465, 466, 467, 471, 474, 475 and 477-A of IPC. Accused-5, 6, 7, 8, 9, 10, 11, 12 and 13 being public servants are also liable to be prosecuted u/s.13 (2) r/w.13 (1) (d) (III) of Prevention of Corruption Act, 1988 and under Sections 420, 409, 465, 466, 467, 471, 474, 475 and 477-A IPC r/w.109 IPC and Accused-14 to 22 who are the Private Individuals in the capacity contractors, suppliers of materials, the claimants who have not executed the work or supplied the materials, are liable to be prosecuted for sections 420, 471, 474,

477-A, 465, 466, 467 IPC r/w.109 IPC in V&AC Crime No.06/AC/2019/CC-II on 19.03.2019 at 10.30 hrs. The original FIR is sent to the Hon'ble Chief Judicial Magistrate and Special Judge, Chengalpattu, and the copy of the FIR is forwarded to the Superior Officers for further action.
