Based on a report sent by one Tr.Gnanadesikan, S/o Karuppan, Rajiv Nagar 6th Street, Kovilpatti, Thoothukudi District, against Tr.Balasubramani formerly Assistant Reforms, Tirunelveli а Preliminary Commissioner Land PE.17/2016/MISC/TK was conducted into the allegations against the marginally noted accused 1.Tr.E.Appasamy, formerly Inspector of Boodhan Board, Tirunelveli. 2.Tr.A.Karuppasamy, Formerly VAO, Appaneri Village, Thoothukudi District and 3.Tr.E.Karuppasamy, Formerly VAO, Subrmaniapuram Village, Thoothukudi District, into the allegations that the accused created false records and allotted lands to the ineligible persons under Boodhan Scheme after obtaining bribe from the said persons and recommended for issuing pattas and the pattas were issued in false address to the mediators who sold the plots and further pattas were also issued to the deceased persons etc., and the Preliminary Enquiry so far conducted reveals the following facts;

Continuation of Thoothukudi Vigilance and Anti-Corruption FIR in Cr.No.06/2019. U/s 120-B. 167, 468, 420 and 409 IPC and 13(1) (d) r/w 13(2) of Prevention of Corruption Act 1988.

Accused:

- 1. Tr.E.Appasamy, aged 67/2019, S/o Tr.S.Enamuthu, No.1B, South Street, Kailasapuram, Tirunelveli Junction, (Rtd. Assistant, Palayamkottai Union Office, Rural Development) Tirunelveli District. Formerly worked as Inspector of Boodhan Board, Tamil Nadu Boodhan Board, Tirunelveli.
- Tr.A.Karuppasamy, aged 63/2019, S/o Tr.Ayyanu Senaiyar, Formerly VAO, Appaneri Village, Near Kovilpatti bus stand, Kovilpatti Taluk, Thoothukudi District.
- 3. Tr.E.Karuppasamy, aged 64/2019, S/o Tr.Erulandi Thevar, Formerly VAO, Subramaniapuram Village, Near Kalugumalai Firka, Kovilpatti Taluk, Thoothukudi District.

revealed that the is It Tr.E.Appasamy formerly worked as the Inspector of Boodhan Board, Tamil Nadu Boodhan Board, Tirunelveli, from 01.08.2007 to 16.08.2010. The A2 Tr.A.Karuppasamy, S/o S.Ayyanu Senaiyar, formerly worked as Village Administrative Officer, Kovilpatti, Thoothukudi District from 05.02.2009 and the A3 to 23.09.2010 Tr.E.Karuppasamy, S/o Tr.Erulandi Theyar, Formerly worked as Village Officer. Administrative Thoothukudi Subramaniyapuram, District from 12.08.2013 to 30.11.2013 and as such A1 to A3 are all public servants within the meaning of Section 2(c) of the Prevention of Corruption Act 1988 during the relevant period of occurrence.

It is revealed that the Boodhan movement was launched in 1951 and its main object is to give land to the eligible landless persons. One Tr.Duraisamy Nadar, Ayan Boommayapuram, Kovilpatti Taluk gifted his land on 21.12.1953 to an extent of 12.69 acres in Pandavarmangalam Village Survey No.537/2 (Patta No.31) Kovilpatti Taluk to Government of Tamil Nadu, Boodhan Board with a view to issue it to poor people. As per the criteria, based on the certificates issued by concerned VAOs and on the recommendation of Inspector of

Boodhan Board the Member/Secretary of Boodhan Board and Director of Land Reforms Department, Chennai has allotted lands to 203 beneficiaries and on 19.02.2011, these 203 house plots were distributed by Tr.Sivagnanam, formerly Boodhan Board Inspector.

It is revealed that, between the year 2010 and 2011, the A1 who was working as special R.I conspired with A2 and A3 who have issued false certificates without verifying the genuineness of the beneficiaries and without verifying the details based on which the A1 recommended 17 applications for the Boodhan Board plots in Pandavarmangalam village, Survey No.537/2 by violating the rules, norms and regulations to the said 17 ineligible beneficiaries 1.Tr.Rajamarthandam. 2.Tr.Kanagarai, 3.Tr.Kandasamy, namely. 4.Tmt.Shenbagavalli, 5.Tr.Muniyasamy, 6.Tr.T.Elangovan, 7.Tr.Gowthaman, 8.Tr.K.Gururaj, 9.Tr.S.Gurusamy, 10.Tr.M.Chelladurai, 11.Tr.S.Chelladurai 13.Tr.R.Subramanian, 14.Tr.Senthilkumar, 12.Tr.Mareeswaran, 15.Tmt.N.Padma, 16.Tr.T.Raja and 17.Tr.Sakthivel, whose annual income is more than Rs.25,000/- or having houses and caused loss to the government and wrongful gain to them and cheated the Government. The A2 and A3 issued false certificates as if they have verified the applications which resulted in the allotment of plot Nos. 18, 24, 26, 36, 39, 40, 41, 43, 62, 109, 114, 143, 144, 159, 172, 178 and 186 of Pandavarmangalam Village Survey No.537/2 (Patta No.31) Kovilpatti Taluk, to the ineligible persons.

It is revealed that in pursuance of the above said criminal conspiracy the A2 framed incorrect documents with intent to cause injury in order to convert the Government property for the benefit of ineligible persons without public interest, issued false certificate and recommended for 16 persons as eligible beneficiaries even though they were not eligible, by dishonestly concealing the fact that they were either having more than Rs.25,000/- as annual income or having house and other properties.

It is revealed that in pursuance of the above said criminal conspiracy A3 framed incorrect documents with intent to cause injury in order to convert the Government property for the benefit of ineligible persons without public interest,

issued false certificate and recommended one Mareeswaran of Pudur village as an eligible beneficiary under the Boodhan scheme stating that he has no land and doing cooly work and earning only Rs.18,000/- per annum by dishonestly concealing the fact that the above mentioned Mareeswaran has house and other properties.

It is further revealed that the A1 to A3 having control over the land under the Boodhan scheme and were responsible for proper selection of beneficiaries for allotment of lands, have entered into criminal conspiracy to do an illegal act of cheating, framed an incorrect document with intent to cause injury and facilitated the conversion of the Government property for the benefit of ineligible persons without any public interest.

The above information so far collected discloses suspicion of commission of cognizable offences punishable u/s 120-B, 167, 468, 420, 409 of IPC and section 13(1)(d) r/w 13(2) of Prevention of Corruption Act 1988.

Therefore, I am registering a case in Thoothukudi Vigilance and Anti-Corruption Cr.No.06/2019, u/s 120-B, 167, 468, 420 and 409 of IPC and section 13(1) (d) r/w 13(2) of Prevention of Corruption Act 1988 at 16.00 hrs today (07.06.2019) against the aforesaid the A1 to A3 for a thorough investigation of the matter.

The Original FIR is sent to the Hon'ble Chief Judicial Magistrate cum Special Judge for cases under Prevention of Corruption Act, Thoothukudi and copies of the FIR are sent to the officers concerned, and as per instructions I am sending a copy of FIR to Tr.A.Annamalai, Inspector of Police, Vigilance and Anti-Corruption, Thoothukudi Detachment for taking up further investigation.
