Based on the petition of Tmt. M. Sasikala, No.77/G, Dharmaraja Koil Street, Pazhampettai Village, Chetpet Taluk, Tiruvannamalai District levelling allegation of forgery and used the forged documents as genuine thereby provided excess marks to the undeserved candidate in the interview conducted for the post of Cook Assistant in the Noon Meal Centre to fill up the vacancy in Government Girls High School, Kozhappalur Village, Peranamallur Panchayat Union, Tiruvannamalai Distirict, a Preliminary Enquiry was conducted which revealed the following facts.

The Accused Officers 1. Tr. S. Sundararajan, worked as Assistant Director (Audit), Cheyyar, Tiruvannamalai District for the period from 25.10.2011 to 24.10.2016, 2. Tr. K. Balakrishnamurthy worked as the Block Development Officer (Block Panchayat), Peranamallur from 13.04.2015 to 04.03.2016, and 3. Tr. R. Mathivanan worked as the Deputy Block Development Officer (Noon Meal Scheme), Peranamallur Panchayat Union from the month of September 2015 to September 2016.

As per the Government Order No.163 of Social welfare and Nutrition Meal Programme Department, dated: 18.08.2010 regarding the selection for the appointment to fill up the existing vacancies for the post of Noon Meal Organizer, Cook Assistant in the Noon Meal Centres in all the Districts throughout the State, the District Collector, Tiruvannamalai District, ordered in C. No.10791/14/Noon Meal Scheme-1, dated: 27.01.2016, C. No.10791/14/Noon Meal Scheme-1, dated: 02.02.2016 and C. No.10791/14/Noon Meal Scheme-1, dated: 21.02.2016, to conduct interview on 26.02.2016 for the post of Cook Assistant to fill up the existing vacancies in all the Panchayat Unions throughout the District.

As per C. No.10791/2014/Noon Meal Scheme-1 of District Collector, Tiruvannamalai District dated: 08.02.2016, regarding marks to be provided by the selection committee to the candidates is as follows:

The candidate 1. Tmt. N. Sumathi, W/o G. Sekar, No.140, Mettu Street, Vinayagapuram Village, Chetpet Taluk, Tiruvannamalai District, applied for the post of Cook Assistant in the existing vacancy in Government Girls High School, Kozhappalur Village. The call letter was sent to attend the interview on 26.02.2016 for the candidate Tmt. N. Sumathi by the Block Development Officer (Block Panchayat), Peranamallur, Tiruvannamalai District.

The District Collector, Tiruvannamalai ordered in the Proceedings in C. No. 10791/2014/Noon Meal Scheme-1 of District Collector, Tiruvannamalai District dated: 02.02.2016, the accused officers A-1 Tr. S. Sundararajan, formerly Assistant Director (Audit), Cheyyar Division, Tiruvannamalai District has been nominated as Zonal Officer of the selection committee, comprising Block Development Officer (Block Panchayat), Panchayat Union, Peranamallur and Deputy Block Development Officer (Noon Meal Scheme), Panchayat Union, Peranamallur, as the members of the selection committee, to conduct the interview at Panchayat Union Office, Peranamallur and complete the selection process without leaving any room for complaints.

The accused officers A-1 to A-3 conducted the interview as instructed by the District Collector, Tiruvannamalai District on 26.02.206 at Panchcyat Union Office, Peranamallur.

The accused officers A-1 to A-3 provided maximum marks -10 in respect of the category of age group to the candidate Tmt. N. Sumathi, W/o G. Sekar, Vinayagapuram Village, Chetpet Taluk, Tiruvannamalai District. According to the documents produced by Tmt. N. Sumathi, as a proof of her age, she had completed 35 years only. In addition to that the accused officers A-1 to A-3 provided maximum marks 10 to the candidate Tmt. N. Sumathi, W/o G. Sekar, in respect of the category of destitute widow, but the candidate has been living with her husband Tr. G. Sekar in Vinayagapuram Village. And also she had not produced any proof of document as destitute widow.

As per the instructions of District Collector, Tiruvannamalai District in C. No. 10791/2014/Noon Meal Scheme-1, dated: 08.02.2016, maximum 10 marks to be provided to the candidates who are all come between the age group of 36 – 40 and 10 marks to the candidate belongs to Deserted Woman / Widow / Destitute Widow.

The Accused Officers A-1 to A-3 have committed forgery by providing maximum marks to the undeserved candidate and submitted the forged documents before the District Collector as genuine documents and not performed their duties scrupulously as instructed by the District Collector, Tiruvannamalai and provided 12 marks excess to the benefit of a particular candidate and they prevented the chance of getting the appointment to the deserved candidates by providing the marks to ineligible candidate with intent to have undue advantage. Hence there is credible information which gives a suspicion of commission of cognizable offence against the accused officers A-1 Tr. S. Sundararajan, formerly Assistant Director (Audit), Cheyyar Division, Tiruvannamalai District, 2. Tr. K. Balakrishnamurthy, formerly Block Development Officer (Block Panchayat), Panchayat Union, Peranamallur, 3. Tr. R. Mathivanan, formerly Deputy Block Development Officer (Noon Meal Scheme), Panchayat Union, Peranamallur.

As per the order of the Directorate of Vigilance and Anti-Corruption, Chennai-16, Preliminary Enquiry was ordered in PE 110/2017/RDP/TVM, Dated 17.03.2017.

Hence for the purpose of investigation, based on the outcome of the enquiry, I am registering a case in Tiruvannamalai Vigilance and Anti-Corruption Cr. No. 07/2019 u/s 465, 469, 471 of IPC and sec 7 of the Prevention of Corruption Act-1988 as amended by the Prevention Corruption (Amendment) Act-2018 today on 20.03.2019 at 1800 hrs.
