While, I am Officer in-charge of Pudukkottai Vigilance and Anti Corruption Detachment, I have perused the Preliminary Enquiry Report in PE 8/2017/RDP/PK which contains the facts as follows:-

Based on the petition sent by Tr.K.Vetriselvan, S/o.Alagu, Ammaiyappatti, Kadaiyakudi(Post), Kavinadu East, Pudukkottai District a Preliminary Enquiry was ordered and the Preliminary Enquiry in PE 8/2017/RDP/PK by Tr.B.Sridhar, the then Deputy Superintendent of Police, Vigilance and Anti Corruption, Thanjavur, I/c Pudukkottai. After that Preliminary Enquiry report was sent him.

The Preliminary Enquiry report reveals that the National Rural Employment Guarantee Act 2005 (or NREGA No.42) was later renamed as the "Mahatma Gandhi National Rural Employment Guarantee Act",

(or, MGNREGA), is an Indian Labour Law and Social Security measure that aims to guarantee the "right to work". It aims to enhance livelihood security in rural areas by providing at least 100 days of wage employment in a financial year to every household whose adult members volunteer to do unskilled manual work and as per the Government order in G.O.(Ms) No.83 Rural Development and Panchayat Raj (CGS-1) Department, dated 19.07.2013, the Hon'ble Minister (Municipal Administration, Rural Development, Law, Courts and Prisons) announced on the floor of the Legislative Assembly on 02.04.2013 that 4000 Village Panchayat Service centres at an estimated cost of Rs.10 lakhs each and 120 Block Panchayat Service Centres at an estimated cost of Rs.25 lakhs each will be constructed under Mahatma Gandhi National Rural Employment Guarantee Scheme for the year 2013-14 in the first instance. During the allegation period Tmt.D.Periyanayagi was worked as work site Organizer for the construction of VPSC building at Kavinadu Panchayat and she is a private individual and Tr.G.Rajendran was working as Panchayat Secretary at Kavinadu East Village Panchayat in Pudukkottai from the year 2012 to till date is a public servants as defined U/s 2(c) of the Prevention of Corruption Act -1988.

It is revealed that the construction of VPSC building at Kavinadu East Panchayat was entrusted to Village Panchayat Secretary, Kavinadu East and work order was issued by erstwhile BDO, Pudukkottai Tr.Mahalingam vide proceedings No.1554/2015 in the name of Panchayat Secretary, Kavinadu East Panchayat for the estimated cost of Rs.17,00,000/-. The basic materials such as cement and steel were supplied by the Department on the recommendation of Assistant Engineer and construction work was executed through skilled workers (Mason and skilled manual labourers) instead of NMR wage workers. The accused Tmt.D.Periyanayagi and Tr.G.Rajendran, Panchayat Secretary colluded with each other and created the false NMR records in the name of job card holders and claimed the wages. The wages was credited to the NMR

Workers (Having Job Card) bank account through ECS. After that Tmt.D.Periyanayagi and Tr.G.Rajendran collected the amount from the concerned NMR wage workers and they utilized the amount to skilled and unskilled labourers for the construction of VPSC building. But actually the NMR workers having the job card have not worked in the construction of VPSC building at Kavinadu Panchayat. In such a manner Tmt.D.Periyanayagi and Tr.G.Rajendran entered the name of one job card holder Balaji, S/o.Malayappan, Prasannaregunathapuram, Pudukkottai in the NMR Record as wage earner in the construction of VPSC Building, Kavinadu East Panchayat during the period from 19.12.2015 to 15.01.2016. But the said Balaji went to Malaysia in the aforesaid period.

It is revealed that Tmt.D.Periyanayagi, and Tr.G.Rajendran colluded and abetted each other and created the false NMR records in the construction of VPSC building at Kavinadu East Panchayat, Pudukkottai District under Mahatma Gandhi National Rural Employment Guarantee Scheme and claimed the wages by forging signatures in the NMR Roll and by using the same as genuine collected the amount after crediting the amount through ECS and misappropriated the same. In pursuance of their criminal conspiracy the accused Tmt.D.Periyanayagi and Tr.G.Rajendran created the false NMR records in the name of job card holder Balaji, S/o.Malayappan (who was in abroad), as if he was wage earner in the construction of VPSC building at Kavinadu East Panchayat during the period from 19.12.2015 to 15.01.2016 and claimed the wages for 23 days (per day Rs.183/-) totally Rs.4,209/- and misappropriated the same.

The information revealed the enquiry as stated above discloses commission of offences punishable u/s 120-B, 167, 409, 465, 466, 467, 468, 471 and 477A IPC r/w 109 IPC and u/s 13(1) (c) r/w 13(2) of Prevention of Corruption Act-1988 r/w 109 IPC and u/s 13(2) r/w 13 (1) (a) of Prevention of Corruption (Amendment) Act- 2018 r/w 109 IPC.

Therefore, I am a registering a case in Pudukkottai Vigilance and Anti-Corruption Cr.No.08/2019 u/s 120-B, 167, 409, 465, 466, 467, 468, 471 and 477A IPC r/w 109 IPC and u/s 13(1) (c) r/w 13(2) of Prevention of Corruption Act-1988 r/w 109 IPC and u/s 13(2) r/w 13 (1) (a) of Prevention of Corruption (Amendment) Act-2018 r/w 109 IPC on 22.05.2019 at 17.00 hrs against the above said accused for the thorough investigation of the matter.

The original FIR is submitted to the Hon'ble Special Judge/ Chief Judicial Magistrate in Pudukkottai and the copies were sent to the concerned higher officials.
