Continuation of Thoothukudi Vigilance and Anti-Corruption FIR in Cr.No. 08/2019 u/s 120(B), 420, 465, 468, 471, 167 of IPC & 13(2) r/w 13(1)(c) & 13(1)(d) of Prevention of Corruption Act 1988

## Accused:

- 1. Tr. Chinnadurai, 41/19, s/o Rajendran (Late), North Street, Savalaperi. Former President, Alanda Village Panchayat, Karungulam Panchayat Union, Thoothukudi District.
- 2. Tmt. Petchiammal, w/o Murugesan, North Street, Savalaperi Colony.
- Tr.Subbarao,
   S/o. Ayiramkathan (Late),
   North Street,
   Savalaperi Colony.
- 4. Tr.Paramasivan,43/19, S/o. Subramanian (Late) 3/260. South Colony, North Street, Savalaperi.
- 5. Tmt.Jeya, 40/19, W/o. B.Velmurugan, 4/50.East Street, Savalaperi.

The accused Tr.Chinnadurai (A1) formerly worked as the President. Alanda Village Panchayat, Karungulam Panchavat Union, Savalaperi, Thoothukudi, district from 2011 to 2016 is a public servant within the ambit and purview of Section the Prevention of 2(c)Corruption Act 1988, during the relevant period of occurrence, A2 Tmt. Petchiammal, Murugesan, A3 Tr.Subbarao, S/o. Ayiramkathan (Late), A4 Tr.Paramasivan, 43/19, S/o. Late. Subramanian, A5 Tmt.Jeya, 40/19, W/o. B.Velmurugan, who are beneficiary under the housing schemes are private individual.

- 2. On a petition sent by Tr.Balamurugan of Kailasapuram Village, leveling certain allegations against one Tr.R.Chinnadurai formerly Panchayat President, Alanda Panchayat, Karungulam Panchayat Union was received at DVAC from CBI., Chennai and a Preliminary Enquiry was conducted into the allegations and the enquiry revealed the following facts.
- 3. Enquiry revealed that A1 recommended for allotment of houses under Indira Awaas Yojana (IAY) Scheme and Chief Minister's Solar Powered Green House Scheme (CMSPGS) to the persons who are not alive and for ineligible persons by violating the norms laid down by the Government for the above schemes, by abusing his official position as public servant, colluded and conspired with A2 to A5, forged, cheated and misappropriated the Govt. fund, in the following manner.
- 4. The accused A1 colluded with A2 to A5 recommended to allot houses in the name of 1. Tr. Ayiramkathan, 2. Tr. Thangasamy Nadar and 3. Velammal who were not alive and died before allotment order.
- 5. In the year 2012-2013, the A1 had recommended for constructing a house under CMSPGH scheme in the name of one Tmt. Velammal w/o Kasi, North Street, Savalaperi Colony who was no more and died on 07.02.2004 itself, colluded with A2, who is the daughter in law of the late Velammal, cheated and misappropriated the amount of Rs. 1,50,000/-knowing very well that Tmt. Velammal was not alive.
- 6. In the year 2013-2014, the A1 had recommended to construct a house under CMSPGH scheme in the name of one Tr.Ayiramkathan, s/o Sivanu, Savalaperi who was no more and died several years before, colluded with A3, cheated and misappropriated the amount of Rs. 1,80,000/- knowing very well that Tr. Ayiramankathan was not alive.

- 7. In the year 2013-2014, the A1 had recommended to construct a house under CMSPGH scheme in the name of one Thangasamy Nadar, s/o Periasamy Nadar, North Street, Savalaperi who was no more and died several years before, colluded with A4, cheated and misappropriated the amount of Rs. 1,80,000/-, knowing very well that Tr. Thangasamy Nadar was not alive.
- 8. In the year 2013-2014, A1 recommended for allotting a house under IAY to one Tmt.Bavani, W/o.Murugan, (Driver, TNSTC, Srivaikumdam Depot) Savalaperi. After getting allotment order, A1 colluded with A5, allowed to construct a house by A5 by using the order pertaining to Tmt. Bavani, cheated, and misappropriated the amount of Rs. 1,20,000/-, knowing very well that the allotment was pertaining to Tmt. Bavani.
- 9. A1 recommended to allot a house under CMSPGH Scheme during the year 2014-2015 to one Tmt.Santhi W/o. Dhanapaul, (whose husband is a Government Servant) Savalaperi by violating the norms.
- 10. A1 recommended to allot a house to one Tr.Rajapandi, S/o.Komban, whose wife Maheswari (working as a Bench Clerk at Sub-Court, Kovilpatti) under IAY scheme during 2014-2015.

Thus A1 colluded with A2 to A5, entered into criminal conspiracy to commit and abet by each other by abusing his official position, recommended to allot houses under the above mentioned schemes and to the persons who were not alive and ineligible persons committed the offences of cheating, forgery for the purpose of cheating and using forged documents as genuine and cheated, criminal misappropriation and criminal misconduct by public servant for undue pecuniary advantage and for the benefit of A2 to A5 accused.

The above information discloses the commission of offences punishable u/s. 120(B), 420, 465, 468, 471, 167 of IPC & 13(2) r/w 13(1)(c) & 13(1)(d) of Prevention of Corruption Act 1988.

Therefore, I am registering a case in Thoothukudi Vigilance and Anti-Corruption Cr.08/2019 u/s 120(B), 420, 465, 468, 471, 167 of IPC & 13(2) r/w 13(1)(c) & 13(1)(d) of Prevention of Corruption Act 1988 at 14.30hrs today 26.07.2019 against the A1 Tr. Chinnadurai, A2 Tmt. Petchiammal, A3 Tr.Subbarao, A4 Tr.Paramasivan and A5 Tmt.Jeya before the Hon'ble Chief Judicial Magistrate Cum Special Judge for cases under Prevention of Corruption Act, Thoothukudi.

The original FIR is forwarded to Hon'ble Chief Judicial Magistrate Cum Special Judge for cases under Prevention of Corruption Act, Thoothukudi and the copies of the FIR are sent to the officers concerned and as per instructions I am sending a copy of FIR to Tr. G.Hector Dharmaraj, Deputy Supdt. of Police, Vigilance and Anti-Corruption, Thoothukudi Detachment for taking up further investigation.
