## Continuation of FIR in SI.No.12 in Namakkal Vigilance and Anti-Corruption, Cr.No.9/AC/2019, u/s. 7(a), 7-A of the Prevention of Corruption Act 1988 as amended by the Prevention of Corruption (Amendment) Act 2018 and 102 Cr.P.C.

It is submitted that, a surprise check conducted with the assistance of two official witnesses and police officials at the Office of No.1 Joint Sub-Registry, Namakkal on 01.11.2018 between 13.00 hrs and 17.00 hrs. On the outcome of surprise check, a report was submitted to the Director, Vigilance and Anti-Corruption, Chennai on 19.11.2018 for getting prior approval from the Head of the Department u/s. 17(A)(1) of the Prevention of Corruption 1988 as amended by the of the Prevention of Corruption (Amendment) Act 2018 for accused-1 Tmt.P.Padmini, Sub Registrar Grade-I, No 1 Joint Sub-Registry, Namakkal. The Directorate of Vigilance and Anti-Corruption, Chennai with the concurrence of Tamil Nadu Vigilance Commission vide its order VC's U.O.Note No.53/VC-I/2019-1, dated: 11.01.2019 and along with prior approval of the Inspector General of Registration, Chennai-28 vide Proceedings No.49280/VI/2018, dated: 07.03.2019 was ordered to register a Regular Case vide its memorandum in SC No.42015/18/REGN/NK, dated: 11.06.2019 against the accused concerned were received from the Directorate of Vigilance and Anti-Corruption, Chennai through post on 17.06.2019. The gist of the allegation is as follows:-

The 1<sup>st</sup> accused Tmt.P.Padmini was working as No 1 Joint Sub-Registrar at No.1 Joint Sub-Registry, Namakkal from 01 09 2016 to 05.03.2019. She is a public servant as defined u/s. 2 (c) of the Prevention of Corruption Act, 1988. The 2<sup>nd</sup> accused Tr.P.Raja, 3<sup>rd</sup> accused Tr.P.Sathishkumar, 4<sup>th</sup> accused Tr.H.Mabubasha are unlicensed document writers/ private individuals / brokers and 5<sup>th</sup> accused Tr.P.Ramasamy is a retired watchman.

On credible information that the officials of No.1 Joint Sub-Registry Office, Namakkal are getting bribe from public, through document writers / brokers for registering the documents, issuing of encumbrance certificates and certified copy of documents during office hours, I have conducted surprise check with the assistance of two official witnesses and police officials at the Office of No.1 Joint Sub-Registry, Namakkal on 01.11.2018 between 13.00 hrs and 17.00 hrs. During the surprise check, the officials namely Tmt.P.Padmini, Sub-Registrar Grade-1, Tmt A.Sugam, Superintendent, Tr.S.Chandramohan, Assistant, Tmt.K.Jeyachitra, TCS Computer Operator and Tr.P.Ramasamy, Private individual who retired from service as Watchman at the District Registrar Office, Namakkal and unlicensed document writers / brokers / private individuals namely Tr.H.Mabubasha, Tr.P.Sathishkumar, Tr.P.Raja, Tr.V.Deenadhayalan, Tr.R.Anbuchezhiyan and public were present and enquired. Prior to the surprise check the document Nos.3046/2018, 3047/2018 and 3048/2018 had been registered.

During the surprise check, the A, B, C, D, G & H account registers of the No.1 Joint Sub-Registry, Namakkal were perused and found tallied with receipts and records. With regard to the Registration of Documents in the head of 'A' account a sum of Rs.20,880/- through online, Rs.36,100/- in Demand Draft and a sum of Rs.215/- in cash had been collected towards

Government fee. In the head of 'D' Account, a sum of Rs.3,942/- through online and a sum of Rs.6,344/- in cash had been collected. The fee collected through online, Demand Draft and in cash were compared with the receipts and in cash boxes found tallied. The relevant pages of Account Registers except D-Account were signed by the Deputy Superintendent of Police and official witnesses at the relevant pages for having perused and attested copies of such pages were also seized. The Government Cash Chest was checked and found Rs.6,126/- was tallied with the concerned register and handed over to A-1 Tmt.P.Padmini since she told that amount had been given by District Registrar Office, Namakkal.

Further, the seat of No.1 Joint Sub-Registrar and officials of the No.1 Joint Sub-Registry were searched and found nothing. The hand bag of Tmt.P.Padmini, Sub Registrar Grade-I was searched and found Rs.500/-. The hand bag of Tmt.A.Sugam, Superintendent was searched and found Rs.1,430/- and Rs.2,500/- was found with Assistant Tr.S.Chandramohan. During the enquiry they are told that they were their personal amount. The amount was compared with Personal Cash Register, found tallied and returned to them. The personal cash register of the staff was perused and found that it was maintained as on 01.11.2018. The hand bag of Tmt.K.Jeyachitra, TCS Computer Operator was searched and found Rs.1,430/-. During the enquiry, Tmt.K.Jayachitra told that she had kept the money for purchase of Diwali sweets. So that, amount was returned to her.

Register were perused. All the above registers were signed by the Deputy Superintendent of Police and official witnesses at the relevant pages for having perused and attested copies of such pages were also seized.

The amount of Rs.2,670/- was found with A-5 Tr.P.Ramasamy during the search. The amount of Rs.270/- was returned since he had brought with him. He did not give proper explanation in respect of Rs 2,400/- and purportedly being the amount obtained from the general public for giving to the officials of sub registry to induce the officials to do public duty and so that amount was seized from him. The amount of Rs.13,750/- was found with A-4 Tr.H Mabu Basha during the search. The amount of Rs.1,750/- was returned to him since it was his personal amount. He did not give proper explanation in respect of Rs.12,000/- and purportedly being the amount obtained from the general public for giving to the officials of sub registrar to induce the officials to do public duty and so that amount was seized from him, Rs.2,960/- was found with A-3 Tr.P.Sathishkumar during the search. The amount of Rs.460/- was returned to him since it was his personal amount. He did not give proper explanation in respect of Rs.2,500/- and purportedly being the amount obtained from the general public for giving to the officials of sub registrar to induce the officials to do public duty and so that amount was seized from him. Rs.850/- was found with A-2 Tr.P.Raja during the search. That amount was returned to him since it was his personal amount. Tr.V.Dheenathayalan who accompanied with A-2 Tr.P.Raja was found with Rs.27,410/-. The amount of Rs.2,410/- was returned to him since it was his personal amount. During the

enquiry Tr.V.Dheenathayalan told that Raja had instructed him to bring Rs.25,000/- to give the officials of No.1 Joint Sub-Registry and so he kept that amount. The amount of Rs 25,000/- was seized from Tr.V.Dheenathayalan The amount of Rs.770/- was found with Tr.Anbuchezhiyan, document writer and returned to him, since it was his personal amount.

The unaccounted money totally sum of Rs.41,900/- was seized from the accused No.2 to accused No.5 in the presence of official witnesses Proceedings was prepared on 01.11.2018 between 13.00 hrs and 17.00 hrs and signed by the Deputy Superintendent of Police, two official witnesses and accused-1 Tmt.P.Padmini. The accused-1 Tmt.P.Padmini had allowed the unlicensed document writers/brokers inside the office premises and attempted to obtain an undue advantage from them to perform a public duty. The accused-2 to accused-5 were accepted gratification for themselves as a motive or reward to induce accused-1 to perform a public duty. Therefore, prima facie case is made out against the accused-1 to accused-5 u/s. 7(a), 7-A of the Prevention of Corruption Act 1988 as amended by the Prevention of Corruption (Amendment) Act 2018 and 102 Cr.P.C.

Hence, I registered a case in Namakkal Vigilance and Anti-Corruption, Cr.No.9/AC/2019, u/s. 7(a), 7-A of the Prevention of Corruption Act 1988 as amended by the Prevention of Corruption (Amendment) Act 2018 and 102 Cr.P.C., against the accused A-1 to A-6 noted in the margin today on 17.06.2019 at 15.00 hrs and further investigation of this case was entrusted to Tmt.M.Nallammal, Inspector of Police, Vigilance and Anti-Corruption,

Namakkal detachment as per the orders of the Directorate of Vigilance and Anti-Corruption, Chennai. The original F.I.R was sent to the Hon'ble Court of Special Judge/Chief Judicial Magistrate, Namakkal and copies were sent to the officers concerned.
