

I state that on 11.02.2019 a joint surprise check was conducted at the O/o. the Senior regional Manager, Tamil Nadu State Marketing Corporation Limited, Chennai Region, along with the Deputy Superintendent of Police, V&AC, CC - I Detachment, Chennai -16 and his team between 12.30 hrs and at 17.30 hrs. During the joint surprise inspection an amount of Rs.2,40,380/- was seized. I herewith sent the proceeding drawn during the time of Joint Surprise Inspection conducted on 01.11.2018 and the properties namely Rs.2,40,380/- (Rupees Two Lakhs Forty Thousand Three Hundred and Eighty Only) for further course of action. Today on credible information that the officials working in the office are indulging in high level of corruption by collecting illegal gratification (bribe) from the staff of retail TASMAC shops through the Shop Supervisors/Sales Man of the TASMAC Shop functioning in Chennai Region for doing favour by way of not conducting frequent surprise inspection at the TASMAC Shops and also allow them to sell liquors in higher rates than the prescribed rates fixed by the Government. Further it is gathered that the Senior Regional Manager, TASMAC, Chennai Region is also indulging in collecting bribe for the transfer and posting of the TASMAC Staff in Chennai Region. Hence it was proposed to conduct a Joint Surprise check involving officials of District Inspection Cell, O/o District Inspection Cell, Chennai District and officials of Vigilance & Anti-Corruption, Chennai City - I Detachments, Alandur, Chennai - 16. On the request of Tr.S.Sankar, Deputy Superintendent of Police, Vigilance & Anti-Corruption, Chennai City - I Detachment, Alandur, Chennai - 16, Tr.V.Sumathi, Inspection Cell Officer, O/o District Inspection Cell, Chennai District reported at the Vigilance & Anti-Corruption, Chennai City - I Detachment, No. 293, MKN Road, Alandur, Chennai - 16 at about 11.15 hrs. The following team with their assistance proceeded to O/o. the Senior regional Manager, Tamil Nadu State Marketing Corporation Limited, Chennai Region, NO.735, 4th Floor, LLA Buildings, Anna Salai, Chennai – 600002 and reached at about 12.15 hrs.

Apart from the office staff attached to this office, the other TASMAC officials came to this office to meet Thiru.R. Muthukumarasamy, Senior Regional Manager, Chennai Region were present inside the room of Senior Regional Manager, TASMAC, Chennai Region. The office incharge Thiru.R. Muthukumarasamy, Senior Regional Manager, Chennai Region and their staff, the other official attached to retail TASMAC Shop coming under his region came to this office and their details are given below:-

During the surprise check the petty cash register maintained in the O/o.the Senior regional Manager, Tamil Nadu State Marketing Corporation Limited, Chennai Region is being handled by Selvi. Valli, Accountant (Daily Wages Staff) O/o. the Senior Regional Manager, Chennai Region was checked. In this register, the entries were made up to 01.02.2019 and Rs.231 was cash book closing balance as on 01.02.2019. Further Cash Register is also being maintained by Selvi. Valli, Accountant (Daily Wages Staff). In this register entries were made up to 31.12.2018 and as on 31.12.2018 the cash book balance Rs.7,41,085.50/- was shown as closing balance. Further Receipts and Payment Statement computerized details produced by Selvi. Valli tallied with the cash book closing balance as on 31.12.2018. She stated that all the transactions are being made by way of issuing cheques. All the copies of document were collected as part of this proceeding. Further the said Selvi. Valli was in possession of Rs.7100/-. During enquiry, she furnished the details of receipt and expenditure and connected vouchers from 08.02.2019 onwards. The same is tallied with the balance amount of Rs.7100/-. Hence the amount was returned to her custody.

During the Surprise Check the following TASMAC Staff were found inside the room of Thiru.R. Muthukumarasamy, Senior Regional Manager. Chennai Region with the cash and the details are given below:

During this search out of the above staff, three TASMAC Sales Men namely 1) Tr.Raja, S/o.Munniyappan 2) Tr.Ramu, S/o.Swaminathan 3) Siva, S/o.Ganesan have accounted satisfactorily for the amount in their possession. Hence after thorough verification the amount possessed by them were returned under acknowledgement.

During this surprise check one Tr.Kanniyappan formerly Sales Man of Shop No. 4338, Madipakkam under suspension was also present in the room of the Senior Regional Manager, Chennai Region found with cash Rs.52,500/-. When questioned he stated that he came to this office to submit his request petition before the Senior Regional Manager, TASMAC, Chennai Region to re-instate him into service. During enquiry about the huge amount of Rs.52,500/- in his possession, he averred that he brought the said about to purchase tiles for his new house owned by his mother, which is under construction at his hometown Kovindavadi Agaram, Kancheepuram District and the said amount was given by his mother Sivakami. In this regard verification was made and as the statement given by Tr.Kanniyappan was found to be true and genuine, the said amount Rs.52,500/- was returned to Tr.Kanniyappan.
