ATTACHMENT TO COLUMN NO. 12 OF FIRST INFORMATION REPORT IN TIRUPPUR V & AC CR.NO.10/2019/AC/TPR.

It is submitted that, an enquiry was conducted against Tr.P.Chinnadurai, formerly Village Administrative Officer, Kolumam Village, i/c Kumaralingam Village, Madathukulam Taluk of Tiruppur District now retired and his wife Tmt.Saraswathi, formerly Sales Manager, Sarvodaya Sangam, Udumalpet, Tiruppur District now retired (VRS). The enquiry revealed the following information:

2) The accused Tr.P.Chinnadurai (A1) was working as Village Administrative Officer Kolumam Village i/c Komaralingam Village, Madathukulam Taluk, Tiruppur District from 01.07.2010 to 31.01.2015. He joined in to government service on 20.05.1985 as Village Administrative Officer and got training at Taluk office Coimbatore from 20.05.1985 to 31.07.1985. Then, he was working as Village Administrative Officer at the following places:

He retired from service on 31.01.2015.

- 3) His wife Tmt.Saraswathi (A2) was working as Sales Manager at Sarvodaya Sangam, Udumalpet and retired on 31.05.2005 (VRS). She had joined as a helper at Sarvodaya Sangam Office at Kolumam during the year 1975 and after that, she elevated as helper, Assistant Sales Manager and Sales Manager in Sarvodaya Sangam and working at Kolumam, Kaniyur and Udumalpet.
- 4) They have a son by name Tr.C.Vigneshkumar. He completed his BE(EEE) degree at VLB Janaki Ammal College of Engineering, Coimbatore during the year between 2004 and 2008.
- 5) The enquiry revealed that, during the period between 01.10.2010 and 31.12.2014, A1 Tr.P.Chinnadurai while working as Village Administrative Officer at Kolumam of Madathukulam Taluk by adopting corrupt activities, acquired movable and immovable properties in his name and his wife Tmt.Saraswathi which are disproportionate against their known sources of income. During the period between

- 1.10.2010 and 31.12.2014, A1 Tr. P.Chinnadurai was a Public servant under section 2(c) of Prevention of Corruption act 1988 and his wife Tmt.Saraswathi was a house wife and she was a private individual.
- 6) As A1 had accumulated maximum assets during the period from 01.10.2010 to 31.12.2014, the check period is taken from 01.10.2010 to 31.12.2014 for calculating disproportionate assets acquired by him.
- 7) The accused Tr.P.Chinnadurai and his wife having assets for the value of Rs. 6,89,662/- as on 01.10.2010 i.e., at the beginning of the check period (Statement-I). The accused Tr.P.Chinnadurai acquired assets in the name of himself and his wife Tmt.Saraswathi for the value of Rs. 75,05,314/- as on 31.12.2014 i.e., at the end of the check period (Statement –II).
- 8) During the check period i.e., from 01.10.2010 to 31.12.2014, the accused Tr.P.Chinnadurai and his family members earned income of Rs.34,26,282/- from his salary and other lawful sources (Statement-III). And the accused Tr.P.Chinnadurai and his family members incurred the expenses during the check period was Rs.8,42,318/-(Statement-IV).
- 9) Hence, asset acquired by the accused Tr.P.Chinnadurai in his name and in the name of his wife Tmt.Saraswathi during the check period was Rs.68,15,652/- i.e. Rs.75,05,314/- Rs.6,89,662/-. (Statement-V)

- 10) Likely savings of the accused Tr.P.Chinnadurai and his family members during the check period was Rs. 25,83,964/- i.e. Rs.34,26,282/- Rs.8,42,318/-. (Statement-VI).
- 11) Hence, the accused Tr. P.Chinnadurai acquired disproportionate assets in the name of himself and his wife was Rs. 42,31,688/- (Statement V Statement –VI) during the check period between 01.10.2010 and 31.12.2014.

- 12) The above information discloses commission of cognizable offences of criminal misconduct committed by public servant punishable u/s 13(2) r/w 13 (1) (e) of Prevention of Corruption Act, 1988.
- 13) Hence, A1 being a public servant, while working as Village Administrative Officer at Kolumam Village i/c Komaralingam Village from 01.07.2010 to 31.12.2014, committed the offences punishable under section 13(2) r/w 13(1) (e) of Prevention of Act, 1988. A2 being wife of A1, abetted and persuaded in commission of offence of criminal misconduct.
- 14) Thus there are prima facie material available for taking investigation against A1 for the commission of offences punishable u/s 13 (2) r/w 13 (1) (e) of Prevention of Corruption Act, 1988 and A2 for the

commission of offences punishable u/s 109 of IPC r/w 13 (2) r/w 13 (1) (e) of Prevention of Corruption Act, 1988. Hence, Today 11.11.2019 at 13.30 hrs, I am registering a case in Tiruppur V & AC crime No.10/2019/AC/TPR, u/s 13 (2) r/w 13 (1) (e) of Prevention of Corruption Act, 1988 against A1 Tr.P.Chinnadurai and u/s 109 IPC r/w 13 (2) r/w 13 (1) (e) of Prevention of Corruption Act, 1988 against A2 Tmt. Saraswathi for the aforesaid offences for the purpose to investigation.

15) The original FIR is submitted to the Court of Chief Judicial Magistrate cum Special Judge, Chief Judicial Magistrate Court, Tiruppur and a copy of it is being sent to the Superintendent of Police, Western Range, Vigilance and Anti-Corruption, Chennai for issuing authorization u/s 17 & 18 of the Prevention of Corruption Act, 1988 to take up investigation in this case.
