ATTACHEMENT TO COLUMN NO.12 OF FIRST INFORMATION REPORT IN DVAC HQRS CRIME NO.12/2019

The accused Tr.P.V.Saravanan is working as a Junior Engineer, Municipal Corporation, Coimbatore and he is a public servant within the purview of 2 (c) of the Prevention of Corruption Act, 1988 as amended by the Prevention of Corruption (Amendment) Act 2018.

It was reported by the Chief Electoral Officer & Secretary to Government that a search was conducted on 27/28.03.2019 by the DGIT (Investigation wing) in the residence of the accused situated at Door No.303, 'B' Block 19/147 Santhome High Road, M.R.C.Nagar, R.A.Puram, Chennai-28 and reported that Rs.77,50,000/- was seized from the possession of the above said accused.

Upon this information, an enquiry was conducted by the competent authority to unearth the movable and immovable assets and other pecuniary resources in his name and in the name of his family members which are disproportionate to the known sources of his income and it disclosed the following information.

For the purpose of quantifying the disproportionate assets, the check period has been fixed to run from 01.04.2015 to 31.03.2019.

At the beginning of the said check period i.e, on 01.04.2015, the accused Tr.P.V.Saravanan was having only the inherited land property at Valasaravakkam, Chennai in his name and the value of the said property has been considered as Notional.

The accused Tr.P.V.Saravanan was in possession of pecuniary resources and properties to the tune of Rs.1,26,07,563/- in his name and in the name of his dependents as on 31.03.2019, i.e at the end of the check period.

The accused Tr.P.V.Saravanan received lawful sources of income in the form of salary from the Government and income through Bank loans to the tune of Rs.48,49,286/- during the said check period.

The accused Tr.P.V.Saravanan incurred expenses (in the form of living expenses, Repayment of loans, payment towards registration charges etc.) to the tune of Rs.8,53,244/- during the check period.

Thus the accused Tr.P.V.Saravanan acquired pecuniary resources and properties to the tune of Rs.1,26,07,563/- during the check period.

Further, the accused Tr.P.V.Saravanan has saved Rs.39,96,042/-(Rs.48,49,286 – Rs.8,53,244) only as excess fund and could have acquired pecuniary resources and properties to the tune of Rs.39,96,042/- only during the check period only by making use of his likely savings.

But the accused Tr.P.V.Saravanan has acquired assets in his name and in the name of his wife to the tune of Rs.86,11,521/- (Rs.1,26,07,563 (-) 36,96,042) in excess of the likely savings, during the check period.

Thus the accused Tr.P.V.Saravanan as on 31.03.2019, being a public servant, was in possession of pecuniary resources and properties to the tune of Rs.86,11,521/- which is disproportionate to his known sources of income.

The above information discloses the commission of the offence of Criminal Misconduct by a Public Servant by intentionally enriches himself by unknown sources as defined u/s 13(1)(b) punishable U/s 13(2) of Prevention of Corruption Act 1988 as amended by the Prevention of Corruption (Amendment) Act 2018.

Hence, on the basis of the above credible information and on the outcome of enquiry, I am registering a case in Vigilance and Anti-Corruption Head quarters Cr.No.12/AC/2019/HQ, U/s 13(2) r/w 13(1)(b) of the Prevention of Corruption Act 1988 as amended by the Prevention of Corruption (Amendment) Act 2018 at 12.30 hrs today 08.05.2019 against the accused

Tr.P.V.Saravanan for the purpose of investigation into the afore stated offence.

The Original FIR is submitted to the Hon'ble Special Court for cases under PC Act, Chennai and a copy of it is going to be sent to the Superintendent of Police, Special Investigation Cell, Vigilance and Anti-Corruption, Chennai for issuing order U/s 17 and for issuing authorization U/s 18 of the act, to the competent Police Officer to take up investigation in this case.
