U/s. 167, 420, 468, 471, 409 IPC, U/s. 7, 13 (2) r/w 13 (1) (d) OF PREVENTION OF CORRUPTION ACT, 1988.

Based on reliable source of information that the marginally noted accused Tr.R.Rajasekar, formerly working as Assistant Training officer (wireman) Industrial Training Institute, Ambattur, Chennai now working in Industrial Training Institute, Chengalpattu into the allegation that the accused had committed malpractices and irregularities and by taking illegal gratification recommended to issue Electrical Helper / Electrician License to ineligible candidates who had submitted false experience certificates. From the credible information, it reveals that the Accused Tr.R.Rajasekar, who was formerly working Assistant Training officer (wireman) Government Industrial Training Institute, Ambattur, Chennai from 26.5.2013 to 15.6.2017 and now working in Asssitant Training officer, Government Industrial Training Institute, Chengelpattu is a public servant under the purview of sec 2 (c) of Prevention of Corruption Act 1988 during the relevant period of occurrence. From the credible information, it reveals that Electrical Helper / Electrician License Examination for November 2015 was announced by the Director, Employment and Training, Guindy, Chennai vide letter No 32733/TE1/2015-1 dated 29.09.2015. It was instructed to all Principals of the Government ITI to collect the applications with Annexure for the Electrical Helper/ Electrician License Examination. Application was sold from 6.10.2015 to 5.11.2015. Last date for submission of application was 05.11.2015. The same was published in daily news paper with approval of The Collector, Thiruvallur. The Director, Employment and Training,

Guindy, Chennai vide Letter. No. 32733/TE-1/2015-1 27.10.2015 instructed to submit the filled up applications of the eligible candidates before 16.11.2015 to the office of the Director Industrial Training Institute. The Assistant Director/ Principal Vide Cr.No.5824/P2/2015 dated 04.11.2015, formed "the applications of Tr.Ramarai Assistant principal scrutinizing team" (1) Tr.K. Veerabadran, Office Manager (2) Tr.R. Rajasekar, Assistant Training Officer/ Accused (4) Tmt.V.P.Sujatha, Junior Training officer, (5) Tmt.K.Chandra, Junior Training officer and instructed them to complete the scrutinizing process. From the credible information, it reveals that the accused Tr.R.Rajasekar neither acted as a selection Authority nor as recommendation authority. He was only, one among the application scrutinizing team. The team scrutinized 147 applications submitted by candidates for Electrical, Helper license Examination November 2015. From the credible information further reveals that when Tr.Rajesh, Tr.A.Sundaramoorthy and Tr.A.Ramesh who proposed to apply for Electrical Helper / Electrician License Examination for November 2015, approached the Tr.R.Rajasekar the accused Tr.R.Rajasekar demanded a sum of Rs.10,000/- each for arranging the experience certificate to be produced by them, and on their request, he reduced the amount to Rs.6,500/- each, Tr.A.Sundaramoorthy and Tr.A.Ramesh paid Rs.13,000/- in cash to Tr.R.Rajasekar /Assistant Training Officer, Government ITI, Ambattur / accused and enclosed forged experience certificate which were falsely created by some fictitious persons bearing forged signature of Tr.Baskaran proprietor of M/s.Balaji Electricals and logo of M/s.Balaji Electricals as if the experience

entrusted with the duty of application scrutinizing team member and thereby allowed ineligible candidates to be selected for Electrical helper Licence by taking undue pecuniary advantage knowing well that the above certificates were falsely created and forged documents and had committed criminal misconduct by public servant. The act of the accused will lead to hazardous to the life of the public in general. In the above circumstances the accused has committed cognizable offences of cheating, creating false documents for the purpose of forgery, using forged documents as genuine, criminal breach of trust and criminal misconduct by public servant punishable u/s 167, 420, 468, 471, 409 IPC, 7, 13 (2) r/w 13 (1) (d) of PC Act, 1988.Hence I am registering a case in V&AC, HQRS in Cr.No.13/AC/2019/HQ against the accused Tr.R.Rajasekar, S/o.D.Rajadurai who was formerly working as Assistant Training Officer, Government Industrial Training Institute, Ambattur now working in Assistant Training Officer, Government Industrial Training Institute, Chengalpettu U/s 167, 420, 468, 471, 409 IPC, U/s. 7, 13 (2) r/w 13 (1) (d) of prevention of corruption Act, 1988. The original FIR is submitted before the Hon'ble Chief Judicial Magistrate/Special Judge, Thiruvallur and the copies are forwarded to the superintendent of Police Special Investigation Cell, Chennai for permission and for further action.
