it is separate what a prefibility and been conducted by the I spector of Police, Tirunelveli on the orders of DVAC vide PE 265 2016/RDP/TI on the petition of Tmt.M.Pitchammal, Formerly President Thirumalay oppapuram Village lanchayat, Kadayam Union, Tirunelveli District. The Preliminary Enquiry conduct id against A.O.Tr.S.Paramasivan Public servant as per section 2 (c) of Prevention of Corruption Act 1988 reveals that A.O.Tr.S.Paramasivan in anorcise of his offici I duty as Panchayat Secretary of Thirumaliappa uram village Panchayat, with dishonest intention of cheating had collected excess amount of Rs.37,568/- without any public interest from the tax payers (General Public) of the above said Village Pa chayat by framing incorrect records false entries in original and counterfoil mis ellaneous receipts and thereafter fraudulently misappropriated the above money for his own purpose. The preliminary enquiry further disclose that inconnection with the same charges already the District Collector, Tirunelveii District had framed charge memodated 12/11/2015 and issued the same to A.O. Tr.Paramasivam on 11.11.2015.

Against lie said charges Tr.Paramasivom had obtained stay as per W.M.P. (MD)No.3 26/2016 in W.P.(MD) No.4298/2016.

The M.Pitchammal who was the former Parchayat President during the year 2011-201 had filed another W.P.(MD)No.20472/20 6as petitioner with prayer Writ of Mandamus to direct the District Collector of initiate a thorough enquiry regarding all the allegations against the accused Tr.Paramasivem as per the charges raised by her in her refresentation dated 08/09/2016 sunt through registered post to the District Collector to initiate proper and suitable Dyparamental and criminal action apart from taking suitable recovery proceedings. Accordingly inspection had been ordered as per file No.M. J/5409/2016 Dt:16/12/2016 and P.D. Village as inspection Officer.

The Inspection Officer had filed his Inspection report on 30/01/2017 as per Na.Ka N .B3/1245/2014 Dated 30/01/2016 Based on the above said report Collector had pase ad proceedings in M2/45540/2016 Dated 14/02/2017 for effecting recovery of the excess money collected from the tap payee by way of cheating the public of Thirumal yappapuram village Panchayat.

A cording to the above said order of the Collector for recovery an amount of Rs.50,37 3/- had been recovered in three in stalment from salary of Tr.Paramasivam on 30/05/2017, 30/12/2017 and 03/01/2018 respectively. The Preliminary investigation revealed that an amount Rs.37.568/- had been misappropriated by the accused.

The details in the above fabular column reveals that the accused high entered the original tax payees name and actual amount received in the original receipt without using the carbon beneath the original receipts, so as enablethe er ries to be recorded in the counterfoil of the original receipts. There after by using the plain counterfoil receipts the accused had entered imaginary persons name at dientered lesser amount than what actually collected by way of cheating from the public under the colour of official duty and higher tax amount has been collected, as amount due to the panchayat by way of tax. Considering the above facts disclosed in preliminary enquiry prima facie case against the A.O.T. Paramasivam is substantiated.

The A.O. Tr. Paramasivam had not soluntarily realized his illegal act cocheating and misappropriation. Only after long legal battle as stated above, recovery of misappropriation money had been effecte. The above information disclose! criminal liability attracting offence of dishonest intention of cheating, framing of incorrect records by public servant criminal breach of trust by public servant punishable under section 420,167 and 409 of Indian Penal Code and for criminal misconduct by public servant u/s 13(2) r/w 13(1)(c) and 13(1)(d) of the Prevention of Corruption Act 1988 against the accused Officer Tr.Paramasivam and it require detail investigationtherefore registered a case in Crime No.13/2019 u/s 420, 167, 409 IPC and 13 (2) r/w 13 (1) (c) and 13 (1) (d) of he Prevention of Corruption Act 988 was registered on 14.11.2017 at 11.00hrs or the orders of DVAC, Chennal vide PE 265/2016/RDP/TI dated 01.11.2019 against the above accused for the above said offence for the above said offence for the purpose of investigation in this case
