Today on 25.10.2019 while I was on duty in my office I received the endorsement order of the Deputy Superintendent of Police, Vigilance and Anti -Corruption, Chennai City Unit-III Detachment consequent to the tapal containing the complaint and the proceedings of the Joint Surprise Check from Tmt.B.Sarala, District Deputy Inspection Cell Officer, O/o the District Cell Office, Chennai-1. பிரிவு-III காவல் துணைகண்காணிப்பாளர் தலைமையில், சென்னை-104, தீயணைப்பு மீட்பு பணிகள் துறை, வடசென்னை மாவட்டம், உயாநீதிமன்ற வளாகத்தில் இயங்கும் மாவட்ட அலுவலர் அலுவலகத்தில் 24.10.2019 மாலை 13.00 மணிமுதல 19.30 மணிவரை மேற்கொள்ளப்பட்ட திடீர் கூட்டுத் ஆய்வின் நடவடிக்கைகள் Proceedings of the Deputy Inspection Cell Officer O/o the District Cell Office, Collectorate Chennai Inspection and the Deputy Superintendent of Police, Vigilance and Anti-Corruption, Chennai City-III conducted Joint Surprise Check at the O/o the District Office, Fire and Rescue Services, North Chennai District, Chennai-600104 on 24.10.2019 between 13.00 hrs and 19.30 hrs. On credible information that the officials and the District Officer of the District Fire Office, O/o the District Officer, Fire and Rescue Services, North Chennai District, Chennai-600104 located in the High Court campus indulged in corrupt activities by utilizing the festival season in issuing temporary crackers license (NOC) to the retail shop vendors. Further the information that the District Officer had permitted the temporary shop owners to possess excess quantity of crackers by deviating the license procedures and thereby benefited illegal gain also the information that today (24.10.2019) the retail owners proposed to meet the officials in this office and giving huge amount of money as bribe with gifts for the support rendered by these officials in selling crackers during Diwali. Hence it was proposed to conduct joint Surprise Check on 24.10.2019 at the O/o the District Office, Fire and Rescue Services, North Chennai District, Chennai-600104 located in the High Court campus by the team headed by DSP, CC-III, V&AC along with the Deputy Inspection Cell Officer. In continuation of this proposal Tmt.B.Sarala, Deputy Inspection Cell Officer and Tmt.P.Revathy, Assistant O/o the District Inspection Cell, Collectorate, Chennai came to office of the Deputy Superintendent of Police, Vigilance and Anti-Corruption, Chennai City-III, Alandur, Chennai-16 at about 11.30 hrs on 24.10.2019 on receiving intimation. The joint surprise check team left V&AC office on 24.10.2019 at 11.45 hrs. and reached at the District Office, Fire and Rescue Services, North Chennai District, Chennai-600104 located in the High Court campus on 24.10.2019 at 12.45 hrs. The following officials attached to V&AC, CC-III Detachment and District Inspection Cell officials are in the team.

O/o the District Officer, Fire and Rescue Services is situated inside the High Court of Madras campus, Chennai. The team entered into the office room of the District Office on 24.10.2019 at 13.00 hrs. The District Officer, Tr.K.Rajesh Kannan was present in his position inside his room. Tr.K.Rajesh Kannan, District Officer (Fire and Rescue Services), North Chennai District is overall incharge of the fire stations namely,1) Esplanade, 2) Washermanpet, 3) Korukkupettai, 4) Vyasarpadi, 5) V.O.C.Nagar, 6) Royapuram, 7) Sembium, 8) Secretariat and 9) Tondiyarpet is also incharge of Fire Prevention Team I and II. In his room a person later ascertained his name that Tr.P.Arumugam who stood before the District Officer, Tr.K.Rajesh Kannan and spoke with him. On the table of District Officer a sweet box with the brand name Adyar Ananda Bhavan was found. Tr.K.Rajesh Kannan District Officer was informed by the Deputy District Inspection Cell Officer and the Deputy Superintendent of Police informed about the surprise check. When enquired the person Tr.P.Arumugam, he stated that, he came to hand over the sweet box and cash to the District Officer, Tr.K.Rajesh Kannan. Besides, he stated that the money was given by his friend one Tr.Subbiah Pandian (in 3 separate covers) who requested him to hand over it, as the same was entrusted to him by 3 retail crackers shop owners 1) Tr.Parthiban, Royapuram, 2) Tr.Sankar Ganesh, Esplanade and 3) Tr.Lakshmanan, Vyasarpadi in 3 separate covers. He stated that as he previously did not know the District Officer Tr.K.Rajesh Kannan, when he entered into the premises of this Fire Service Office, he asked a fire service official was in uniform to show the office of the District Officer. The Fire Service officer was in uniform enquired him about the reason to meet the District Officer. In reply he told him that he wanted to hand over the sweet box with cash to him which was entrusted by his friend on behalf of the 3 retail crackers shop owners. Then the fire service personnel was in uniform permitted him to enter into the room of the District Officer. While handing over the money cover to the District Officer, Tr.K.Rajesh Kannan, the Officers of Vigilance and Anti-Corruption came inside the room. Further on request he produced 3 covers containing cash. In the outer surface of the covers, in 2 covers it was mentioned as "ராஜேஸ் கண்ணன் திரு.மாவட்ட அலுவலா. தீயணைப்பு துறை" and in one cover it was mentioned as "திரு.மாவட்ட அலுவலர் தீயணைப்பு துறை". On checking these covers, first cover containing Rs.50,000/- (500x100=50,000/-) second cover containing

Rs.50,000/- (2000x5= Rs.10,000 and 500x80 = Rs.40,000/-) and the third cover contains (500x100=Rs.50,000/-). When enquired the District Officer, Tr.K.Rajesh Kannan stated that, he did not know the person who stood before him previously and he did not know who has given this amount to that person for handing over the same to him. Further the District Officer stated that after entering to his room the said person kept the sweet box on his table and requested him to say the procedure to get a temporary license for Adyar Ananda Bhavan at Mylapore and hence explained him the procedure for getting the temporary license since, Mylapore is not coming under the jurisdiction of North Chennai in which the District Officer, Tr.K.Rajesh Kannan is the authority to issue license. Further Tr.K.Rajesh Kannan stated that, being the authority he visited temporary crackers shops regularly whether they have violated the license rules in this festival season also today morning between 11.30 and 12.30 hrs. he attended the inspection and demonstration in the Island ground at Chennai, in this place the government has permitted to function the retail crackers shop on the direction of the Hon'ble High Court of Madras. After completion of this demonstration he returned back to the office at 12.45 hrs. Further on examining the above witnesses and on seeing the circumstances it is strongly presumed that the person Tr.Arumugam had attended this office to hand over the bribe amount to the District Officer, Tr.K.Rajesh Kannan. Hence the amount of Rs.1,50,000/- with 3 covers were seized for the purpose of further enquiry/investigation. Further a sweet and snacks box with brand name Adyar Ananda Bhavan "Diwali Batchanam Box" found on the table of District officer, Tr.K.Rajesh Kannan handed over by Tr.Arumugam was seized after identifying the same by Tr.Arumugam. During the course of this Joint Surprise Check an amount of Rs.16,000/- i.e., Rs.6,000/- from his wallet and Rs.10,000/- from his separate red colour pouch which was in his laptop bag owned by Tr.K.Rajesh Kannan were found. On enquiry the explanation given by Tr.K.Rajesh Kannan in respect of the above amount Rs.6,000/- in his wallet was satisfactory. Hence the same was returned to him and the remaining amount Rs.10,000/- was seized a part of this proceedings as he could not give proper explanation for this said amount. In this Joint Surprise Check, the office of the District Officer, (Fire and Rescue Services) attached to his office room was also searched. The following officials were present,
