conducted House search was on with 11.09.2018 in connection Cr.No.18/2018/AC/VPM in the house of A-1 S.Babu, formerly Motor Vehicle Inspector, Kallakurichi and incriminating evidences were unearthed against the A-1 to suspect that he had accumulated and possessed assets and pecuniary resources for the period from 08.08.2006 to 03.10.2018 in his name and also in the name of A-2, A-3 and A-4 which was beyond their known sources of income. This information was verified through documents and upon getting concurrence from the competent authority, I am registering this case against the marginally noted accused. The information disclosed the following:

The accused S.Babu, S/o Subramanian, as Motor Vehicle Inspector, Kallakurichi, Viluppuram District was a public servant u/s 2 (c) of The Prevention of Corruption Act, 1988 as amended by The Prevention of Corruption (Amendment) Act, 2018 at the relevant period. During the check period from 08.08.2006 to 03.10.2018 A-1 held the post of

Motor Vehicle Inspector, Kallakurichi and at other places. The A-2 Tmt.Mangaiyarkarasi is wife of S.Babu (A-1) who is a house wife and does not have sufficient independent resources to buy properties as found in her name and is dependent on A-1. The A-3 B.Shobika is daughter of S.Babu (A-1) who is a student and does not have independent sources to acquire and possess the cash in her bank account as found in her name.

The A-4 Miss.B.Rasika is daughter of S.Babu A-1 who is student and does not have independent sources to acquire and possess the cash in her bank accounts as found in her name.

The check period is fixed from 08.08.2006 to 03.10.2018 for calculating Disproportionate Assets acquired by him. During the beginning of the check period i.e., as on 08.08.2006 the assets and pecuniary resources possessed by A-1 both in his name and in the name of his wife and daughters was 43,44,718/-.

Assets and pecuniary resources held by the A-1 S.Babu in his name and in the name of his wife and daughters at the end of the check period i.e., as on 03.10.2018 was Rs.6,01,32,899/-.

Income earned by the A-1 S.Babu, his wife and their daughters during the check period between 08.08.2006 to 03.10.2018 was Rs.87,60,000/-.

Expenditure incurred by the A-1 S.Babu, his wife and their daughters during the check period between 08.08.2006 to 03.10.2018 was Rs.40,00,000/-.

Assets acquired and possessed by the A-1 S.Babu, his wife and their daughters during the check period in their name Rs.5,57,88,181/- (6,01,32,899 – 43,44,718).

Likely savings made by them was Rs.47,60,000/-.

Hence on this day 09.10.2019 at 16:00 I am registering a case in Viluppuram V&AC detachment Cr. No.17/2019, u/s 13 (2) r/w 13 (1) (b) and 12 r/w 13 (2) r/w 13 (1) (b) of The Prevention of Corruption Act, 1988 as amended by The Prevention of Corruption (Amendment) Act, 2018.

The original FIR is submitted to the Honourable Court of the Special Judge for Cases under The Prevention of Corruption Act, Viluppuram and a copy of it is being sent to the Superintendent of Police, Western Range, Vigilance and Anti-Corruption, Chennai.

Disproportionate assets acquired and processed by A-1 during the check period was Rs.5,10,28,181/- which was calculated to be 583% over his known sources income.

The above information discloses suspicion of commission of cognizable offence of criminal misconduct committable by Public Servant u/s 13 (2) r/w 13 (1) (b) of The Prevention of Corruption Act, 1988 as amended by The Prevention of Corruption (Amendment) Act, 2018 and against A-2 to A-4 u/s 12 r/w 13 (2) r/w 13 (1) (b) of the Prevention of Corruption Act, 1988 as amended by The PC (Amendment) Act, 2018.

A-1, being public servant, u/s 2 (c) of The Prevention of Corruption Act by holding the post of the Motor Vehicle Inspector in the department of Transport, Kallakurichi and at other places during the check period is reasonably suspected to have committed the offences punishable under section 13 (2) r/w 13 (1) (b) of The Prevention of Corruption Act, 1988 as amended by The Prevention of Corruption (Amendment) Act, 2018.

A-2, A-3 and A-4 being wife, daughters of A-1 respectively, reasonably suspected to have abetted A-1 in the commission of offence of criminal misconduct by aiding in acquiring and possessing the said assets and properties in their name.

Thus there are prima facie materials available for taking up investigation against the marginally noted accused A-1 for the commission of offences punishable u/s 13 (2) r/w 13 (1) (b) of The Prevention of Corruption Act, 1988 as amended by The Prevention of Corruption (Amendment) Act, 2018 and against A-2, A-3 and A-4 for offences punishable u/s 12 r/w 13 (2) r/w 13 (1) (b) of The Prevention of Corruption Act, 1988 as amended by The Prevention of Corruption (Amendment) Act, 2018.
