Continuation of F.I.R in Krishnagiri V&AC Cr.No.1/AC/2020 u/s 13(2) rw/ 13(1)(b) and 12 of the Prevention of Corruption Act 1988 as amended by the Prevention of Corruption (Amendment) Act. 2018

Accused

- 01. Tr.P.Natarajan, S/o Perumal, Inspector of Police, Formerly Uthangarai PS, Krishnagiri District.
- 02. Tmt.N.Dhanalakshmi, W/o Natarajan, D.No.8/180-1, Lakshmi Nagar, Dhasanaickkanpatty, Salem Taluk.

The following information was gathered during the collection of information against the accused noted in the margin.

A-1 Tr.P.Natarajan was working as Inspector of Police, in Uthangarai Police Station. Krishnagiri District from 13.03.2019 to 22.05.2019. Prior to that, he served in Attayamaptti P.S (Salem District), Mathikonpalayam P.S (Dharmapuri District), Karumalaikkoodal P.S (Salem District) and Barur Circle (Krishnagiri District).

A-1 is a public servant as defined u/s 2(c) of the Prevention of Corruption Act 1988. A-2 Tmt.N.Dhanalakshmi is wife of A-1. She is a housewife and she is not the earning member of the family.

Collection of sources reveals that A-1 Tr.P.Natarajan hails from a middle class family. He is native of Thirumalaippatty Village, Namakkal District. A-1 and A-2 have two kids. Their daughter Selvi.N.Sindhuja is a B.E graduate and their son Selvan N.Kavinkumar is doing 3rd year M.B.B.S in Stanley Medical College, Chennai.

It is gathered that A-1 Tr.P.Natarajan, intentionally enriches himself illicitly in his name and in the name of his wife A-2 Tmt.N.Dhanalakshmi during the period of his office in various places. Most of the acquisitive activities of A-1, falls between 01.01.2013 and 21.06.2019 as detailed below. Hence, it was taken as tentative check period.

- Value of assets found in possession of A-1: Rs.4,76,380/Tr.P.Natarajan and his wife A-2
 Tmt.N.Dhanalakshmi and their dependents in form of house sites, agricultural lands and bank balances etc., at the beginning of the check period i.e as on 01.01.2013.
- O2. Value of assets found in possession of A-1: Rs.1,40,57,806/-Tr.P.Natarajan and his wife A-2 Tmt.N.Dhanalakshmi and their dependents in form of house sites, houses, vehicles, jewels, agricultural lands and bank balances etc., at the end of the check period i.e on 21.06.2019.
- O3. Income derived by A-1 Tr.P.Natarajan and his wife: Rs.77,44,051/-A-2 Tmt.N.Dhanalakshmi through their known of income in form of monthly salary, agricultural income and rental income during the check period between 01.01.2013 and 21.06.2019
- 04. Expenses incurred by A-1 Tr.P.Natarajan and his : Rs.38,31,562/-wife A-2 Tmt.N.Dhanalakshmi during the check period between 01.01.2013 and 21.06.2019
- 05. Value of the assets acquired by A-1 Tr.P.Natarajan : Rs.1,35,81,426/-and his wife A-2 Tmt.N.Dhanalakshmi during the check period between 01.01.2013 and 21.06.2019 (02-01)
- 06. Likely savings of A-1 Tr.P.Natarajan and his wife A-2 : Rs.39,12,489/-Tmt.N.Dhanalakshmi during the check period between 01.01.2013 and 21.06.2019 (03-04)
- 07. Value of the Disproportionate Assets of A-1: Rs.96,68,987/-Tr.P.Natarajan and his wife A-2 Tmt.N.Dhanalakshmi during the check period between 01.01.2013 and 21.06.2019 (05-06)

The available information makes out a prima facie case that A-1 Tr.P.Natarajan and his wife A-2 Tmt.N.Dhanalakshmi were in possession of pecuniary resources and properties to the tune of Rs.96,68,937/- during the period between 01.01.2013 and 21.06.2019, which is disproportionate to their known sources of income. Thereby, A-1 had committed the offence of Criminal Misconduct by intentionally enriching themselves illicitly during the period of his office and his wife A-2 Tmt.N.Dhanalakshmi had abetted A-1 to commit criminal misconduct.

Therefore, today 06.01.2020 at 18.00 hrs, I registered a case in Krishnagiri V&AC Cr.No.1/AC/2020 u/s 13(2) r/w 13(1)(b) of Prevention of Corruption Act 1988 as amended by the Prevention of Corruption (Amended) Act 2018 against A-1 Tr.P.Natarajan and u/s 12 of the said Act A-2 Tmt.N.Dhanalakshmi,

The original F.I.R is sent to the Hon'ble Court of the Special Judge/Chief Judicial Magistrate, Krishnagiri and a copy of the F.I.R is sent to the Superintendent of Police, Vigilance and Anti-Corruption, Western Range, Chennai for issuing order u/s 17 of the Prevention of Corruption Act 1988 as amended by the Prevention of Corruption (Amended) Act 2018 to investigate the case by Tr.S.Murugan, Inspector of Police, Vigilance and Anti-Corruption. Krishnagiri with authorization u/s 18 of the said Act to inspect bankers books in relation to the accounts of A-1 Tr.P.Natarajan and A-2 Tmt.N.Dhanalakshmi.
