ACCUSED:

A-1 Tr.R.Ashok Kumar, S/o Ranganathan Selection Grade Executive Officer, Formerly Selection Grade Town Panchayat, Omalur, Salem District.

A-2 Tmt.Thamaraikodi @ Sree Thamarai, W/o Tr.R.Ashok Kumar. The following information was gathered during the collection of information against the accused noted in the margin. A-1 Tr.R.Ashok Kumar was working as First Grade Executive Officer, Yethapur Town Panchayat, Salem District from 15.03.2010 to 14.02.2014, Gangavalli Town Panchayat

Salem District from 15.02.2014 to 30.04.2015 and working as Selection Grade Executive Officer in Kolathur Selection Grade Town Panchayat, Salem District from 01.05.2015 to 07.09.2016, Veeragalputhur Selection Grade Town Panchayat, Salem District from 08.09.2016 to 02.04.2017 and Omalur Selection Grade Town Panchayat, Salem District from 03.04.2017 to till date, during the period of commission of offence.

The A-1 is a public servant as defined u/s 2 (c) of the Prevention of Corruption Act, 1988 during the period of commission of offence. The A-2 Tmt.Thamaraikodi @ Sree Thamarai is the wife of A-1, and she is a private individual.

It is gathered that A-1 Tr.R.Ashok Kumar, intentionally enriches himself illicitly in his name and in the name of his wife A-2 Tmt.Thamaraikodi @ Sree Thamarai, during the period of his office in various places. Most of the acquisitive activities of A-1 and his wife falls between 01.04.2011 to 31.03.2017and hence it was chosen as tentative check period and during that period the A-1 and his wife were found in possession of assets as detailed below:

1)	Assets found in the name of A-1 and in the name of his wife in form of house sites, jewels, household articles, movables, Bank balances and etc. at the commencement of the check period (i.e.) on 01.04.2011	Rs.9,55,639/
11)	Assets found in the name of A-1 and his family members (wife) in form of house sites, agricultural lands, construction of house, household articles, gold jewels, movables, bank deposits, Insurance policies and etc. at the end of the check period (i.e.) on 31.03.2017	Rs.1,02,08,032/
III)	Income of A-1 and his wife from known sources in form of monthly salary, pay and allowances, income received through the sale of house site, Bank Deposit interest etc. during the check period between 01.04.2011 and 31 03.2017	Rs.26,66,334/-
IV)	Expenditure incurred by A-1 and his family members during the check period between 01 04.2011 and 31.03.2017	Rs.6,40,658/-
V)	Value of Assets acquired by A-1 and his wife during the check period between 01 04.2011 and 31 03 2017	Rs 92,52,393/-
VI)	Likely Savings of A-1 and his family members during the check period between 01.04.2011 and 31.03.2017	Rs 20,25,676/-
VII)	Disproportionate Assets acquired by the A-1 during the check period between 01.04.2011 and 31.03.2017	Rs.72,26,717/-

The available information makes out a prima facie case against A-1 Tr.R.Ashok Kumar and his wife Tmt.Thamaraikodi @ Sree Thamarai, that they were in possession of pecuniary resources and properties to the tune of Rs.72,26,717/- during the check period, which is disproportionate to their known sources of income. Thereby, A-1 had committed the offence of criminal

misconduct by intentionally enriching himself illicitly during the period of his office and others had abetted him to commit the said offence by acquiring the assets through the resources of A-1.

Therefore, today 15.04.2020 at 12.00 hrs, I registered a case in Salem V&AC Cr.No.01/AC/2020 against A-1 Tr.R.Ashok Kumar for commission of the offence u/s 13 (2) r/w 13 (1) (e) of the Prevention of Corruption Act, 1988 and his wife A-2 Tmt.Thamaraikodi @ Sree Thamarai for commission of offence u/s Sec 109 IPC r/w Sec 13 (2) r/w 13 (1) (e) of the Prevention of Corruption Act, 1988.

The original FIR is submitted to the Hon'ble Special Judge, Special Court for Trial of Cases under Prevention of Corruption Act, Salem District and a copy of the FIR is submitted to the Superintendent of Police, Vigilance & Anti-Corruption, Western Range, Chennai for issuing order u/s 17 of the Prevention of Corruption Act, 1988 to investigate the case and authorization u/s 18 of the said Act to inspect bankers books in relation to the accounts of A-1 and his family members.
