

The following information was gathered during collection of information against the accused noted in the margin.

Tr.R.Sundara Baskar was working as Block Development Officer, Shoolagiri Block, Krishnagiri district from 02.05.2017 to 4.12.2018. A-2 Tr.V.Santhanam was working as Block Development Officer (VP), Thally Block, Krishnagiri District from 03.09.2016 to 17.11.2017. A-3 Tr.S.Saravanabava · was working as Block Development Officer (VP), Kelamangalam Block, 05.08.2016 Krishnagiri from to 30.06.2017 and after that he was working in Thally Block from 01.07.2017 to 17.11.2018. A-4 Tr.Ramachandran was working as Block Development (VP), Veppanapalli Officer Krishnagiri District from 22.09.2016 to 22.03.2017. A-1 to A-4 are public servants as defined u/s 2(c) of the Prevention of Corruption Act 1988.

A-5 Tr.A.N.Sarvanan is Proprietor of Priya Art and Printers, Actual Tr.R.Prabu is Proprietor of Shri Vaari Agencies and A-7 Tmt.Hema is Proprietor of Hema Enterprises. A-5 to A-6 are private individuals.

The Government of India have introduced a scheme Swachh Bharath Mission (Gramin) on 2.10.2014 which aims to achieve Swachh Bharat by 2019, as fitting tribute to the 150th Birth Anniversary of Mahatma Gandhi, which in rural areas shall mean improving the levels of cleanliness in rural areas through Solid and Liquid Waste Management activities and making Gram Panchayats Open Defecation Free, Clean and sanitized. Solid and Liquid Waste Management activity is one of the key components of the programme, being implemented with 75% of contribution by the Government of India and 25% of contribution by the State Government. As a part of the above programme, steel boards containing Photographs, slogan regarding rural sanitation, hygiene such as washing hands with soap and water, are being installed to improve awareness on Open Defecation Free villages. The scheme is being implemented by the Rural Development department in the Districts under three phases and the expenses are to be made from IEC head under this scheme.

In G.O.Ms.No.47, Rural Development and Panchayatraj (CGS.1) Department, dated 26.03.2015, a sum of Rs.110 Crores was sanctioned for 2000 Village Panchayats in 31 districts, in which the scheme was proposed to be implemented in Krishnagiri District in 30 Village Panchayats, covering 10 Blocks In the year 2016-17. In this connection, the District Collector, Krishnagiri had obtained a Detailed Estimate on 06.02.2017 from Assistant Executive Engineer, Rural Development Department, Krishnagiri, in which the cost of the board has been fixed to Rs.8900/- with the other detailed specifications and the board should be in the size of 6"X4". A copy of the detailed estimate was circulated to all the Block Development Officers along with the administrative sanctions issued by the District Collector and further it has been specifically instructed in the administrative sanction that the work should be done by following all legal formalities and technical specification mentioned in the detailed estimate.

It is gathered that while implementing the scheme, A-5 to 7 hatched a criminal conspiracy separately with A-1 to A-4 of their respective block with fraudulent and dishonest intention to defraud the funds of the Government and dishonestly misappropriated the funds of the Government towards the installation of awareness boards under the component Solid Wastage Management System under the scheme Swachh Bharath Mission (Gramin) as detailed below.

The District Collector, Krishnagiri District issued administrative sanction to 84 Village Panchayats in Shoolagiri Block for installing 194 numbers of awareness boards under 3 administrative orders as detailed below.

It is gathered that during the period between 01.01.2017 and 31.07.2017 in course of execution of works by A-5 to A-7, A-1 and A-5 to A-7 hatched a criminal conspiracy with fraudulent and dishonest intention to defraud the funds of the Government towards the installation of awareness boards under the component Solid Wastage Management System under the scheme Swachh Bharath Mission (Gramin) in a substandard manner against the cost of detailed estimate of Rs.8900/- per board. In pursuance of the criminal conspiracy, a sum of Rs. 46,785/- was dishonestly misappropriated by A-1 and A-5 with respect to the installation of 15 numbers of boards out of 75 in a substandard manner at the cost of Rs.3119/- per board, Rs.43,342/- by A-1 and A-6 with respect to the installation of 26 numbers of boards out of 88 in a substandard manner at the cost of Rs.1667/- per board and Rs.27,648/- by A-1 and A-7 with respect to the installation of 12 numbers of boards out of 31 in a substandard manner at the cost of Rs.2304/- per board.

The District Collector, Krishnagiri District issued administrative sanction to 100 Village Panchayats in Thally Block for installing 227 numbers of awareness boards under 3 administrative orders as detailed below.

It is gathered that during the period between 01.01.2017 and 31.07.2017 in course of execution of works by A-5 to A-7, A-2 and A-5 to A-7 hatched a criminal conspiracy with fraudulent and dishonest intention to defraud the funds of the Government towards the installation of awareness boards under the component Solid Wastage Management System under the scheme Swachh Bharath Mission (Gramin) in a substandard manner against the cost of detailed estimate of Rs.8900/- per board. In pursuance of the criminal conspiracy, a sum of Rs. 62,380/- was dishonestly misappropriated by A-2 and A-5 with respect to the installation of 20 numbers of boards out of 87 in a substandard manner at the cost of Rs.3119/- per board, Rs.33,180/- by A-2 and A-6 with respect to the installation of 20 numbers of boards out of 101 in a substandard manner at the cost of Rs.1659/- and Rs.34,470/- by A-2 and A-7 with respect to the installation of 15 numbers of boards out of 39 in a substandard manner at the cost of Rs.2298/-.

The District Collector, Krishnagiri District issued administrative sanction to 56 Village Panchayats in Kelamangalam Block for installing 138 numbers of awareness boards under 3 administrative orders as detailed below.

It is gathered that during the period between 01.01.2017 and 31.07.2017 in course of execution of works by A-5 to A-7, A-3 and A-5 to A-7 hatched a criminal conspiracy with fraudulent and dishonest intention to defraud the funds of the Government towards the installation of awareness boards under the component Solid Wastage Management System under the scheme Swachh Bharath Mission (Gramin) in a substandard manner against the cost of detailed estimate of Rs.8900/- per board. In pursuance of the criminal conspiracy, a sum of Rs.49,904/- was dishonestly misappropriated by A-3 and A-5 with respect to the installation of 16 numbers of boards out of 50 in a substandard manner at the cost of Rs.3119/- per board, Rs.48,111/- by A-3 and A-6 with respect to the installation of 29 numbers of boards out of 67 in a substandard manner at the cost of Rs.1659/- and Rs.22,980/- by A-3 and A-7 with respect to the installation of 10 numbers of boards out of 21 in a substandard manner at the cost of Rs.2298/-.

The District Collector, Krishnagiri District issued administrative sanction to 54 Village Panchayats in Veppanappalli Block for installing 109 numbers of awareness boards under 3 administrative orders as detailed below.

It is gathered that during the period between 01.01.2017 and 31.07.2017 in course of execution of works by A-5 to A-7, A-4 and A-5 to A-7 hatched a criminal conspiracy with fraudulent and dishonest intention to defraud the funds of the Government towards the installation of awareness boards under the component Solid Wastage Management System under the scheme Swachh Bharath Mission (Gramin) in a substandard manner against the cost of detailed estimate of Rs.8900/- per board. In pursuance of the criminal conspiracy, a sum of Rs.62,380/- was dishonestly misappropriated by A-4 and A-5 with respect to

the installation of 20 numbers of boards out of 50 in a substandard manner at the cost of Rs.3119/- per board, Rs.46,256/- by Λ -4and Λ -6 with respect to the installation of 28 numbers of boards out of 45 in a substandard manner at the cost of Rs.1652/- and Rs.20,628/- by Λ -4 and Λ -7 with respect to the installation of 9 numbers of boards out of 14 in a substandard manner at the cost of Rs.2292/-.

Thereby, the above information makes out a prima facie case against the accused in which, A-1 to A-4 being public servants, by entering in to a criminal conspiracy with A-5 to A-7 with fraudulent and dishonest intention to commit fraud on the funds of the government and in pursuance of the conspiracy, they derived pecuniary advantages by corrupt or illegal means by abusing their official function in course of discharging their duties and willfully allowed A-5 to A-7 to commit dishonest misappropriation on the funds while execution of the works and hence A-1 to A-4 each committed the offences u/s 120B IPC and 13(2) r/w 13(1)(c) & (d) of the Prevention of Corruption Act 1988 and A.O-5 to A.O-7, being private individuals, who were entrusted with the works of installation of boards, committed the offence of criminal breach of trust with the active assistance of A-1 to A-4 and abetted them to commit criminal misconduct and hence A-5 to A-6 committed the offences u/s 120 B IPC, 406 IPC and 13(2) r/w 13(1)(c) & (d) of the Prevention of Corruption Act 1988 r/w 109 IPC.

Therefore, today 03.02.2020 at 15.00 hrs, I registered a case in Krishnagiri V&AC Cr.No. 2/AC/2020, u/s 120B, 406 IPC and 13(2) r/w 13(1)(c) and (d) of the Prevention of Corruption Act 1988 r/w 109 IPC. The original FIR is sent to the Hon'ble Court of Special Judge/Chief Judicial Magistrate, Krisnnagiri and a copy of the F.I.R is sent to the Officer concerned.
