When I was in Sivagangai, Vigilance and Anti-Corruption Detachment, on 23.09.2020 at 14.30 hrs, As per the Memorandum noted in PE/145/2018/BCW/SG, Directorate of DVAC., a case was registered by me in Sivagangai Vigilance and Anti-Corruption, in Cr.No.02/2020, U/s. 167,409,468,471,477A IPC and 13(2) r/w 13(1)(c) and (d) of Prevention of Corruption Act 1988 against the accused Tr.Azhagu, Warden, Boys Hostel, Sivagangai, I/C of Idayamelur Hostel. The Accused P.Azhagu worked as Warden, Backward Classes and Minorities Welfare Hostel, Sivagangai from 01.06.2015 and also holding additional charge of Backward Classes and Minorities Welfare Hostel, Idayamelur from 05.10.2015 and sub his a public servant as defined u/s 2 (c) if Prevention of Corruption Act, 1988. On credible information as to the commission of malpractices in claiming the amount paid by the Government towards food and other allowances to the students, who stayed in Backward Classes and Minorities Welfare Hostel, Idayamelur, Sivagangai District, a Preliminary enquiry was conducted as per the orders of the Directorate of Vigilance and Anti-Corruption in P.E.145/2018/BCW/SG, dated 15.05.2018 and the following facts were brought to light. As per letter

No.B2/3298/2016, Dated 19.06.2017 of the Commissioner of Backward Classes and Minorities Welfare Department, it is stated that the Government has increased the food allowance from Rs. 755/- and provided Rs. 900/- to the hostel students from June 2017 and the minimum standard of food prescribed by the Governments should be provided to the hostel students. The provisions such as Vegetables, Egg. Milk, Sundries, Mutton, Chicken, etc., are provided by PAMCO and rich was provided by TNCSC to the concerned hostel and the purchase cost of the above said provisions were paid by the Backward Classes and Minorities Welfare Department to PAMCO and TNCSC through ECS. Oil and Soap are directly purchased by the Warden of the hostel and the Warden would prepare the bill for the same and send it to the Sivagangai District Consumer Cooperative Wholesale Store Ltd., and the Backward Classes and Minorities Welfare Department will provide Rs.50/- for Oil and Soap to each student through ECS. Every year students are admitted in the Backward Classes and Minorities Welfare Hostel. Every academic year the filled in application form from an eligible student should be obtained through the Schools situated near by the hostel concerned and sent to the District Welfare Officer through the Warden. The students are admitted against vacancies in each BC, MBC and DNC hostels after selection made by the Selection Committee. On the basis of the proceedings of the District Collector, the eligible students will be allowed to joint in the hostel. There is reliable information that the Accused had falsified the Attendance Register, Purchase Register, Daily Meals Issue not and Monthly Abstract Note as if 50 students were stayed in the Backward Classes and Minorities Welfare Hostel, Idayamelur and had used them as genuine and misappropriated the provision, viz., Rich, Dhal, Sundries, Milk, Gas, Vegetables, Soap, Egg etc., provided to the students by the Government to the extent of Rs. 74,840/-. Further the Accused Officer had not obtained the signature of the cooks in the Daily Meals Issue note and forged the signatures of the cooks in the above said register. According to the attendance register of Idayamelur Hostel, it is shown that 38 Students were stayed in the hostel in the month June 2017 and vacancy is shown as 12 by the warden. It is evident from the attendance register: the Accused Officer had falsely shown

the names of 9 students, who have left Idayamelur Government Higher Secondary School by obtaining their Transfer Certificates. Since they have left the school, they could not be stayed in the Idayametur hostel. Among the 9 students, one student joined in Thamarakki Government Higher Secondary School and stayed in Thamarakki Hostel from 12.07.2016 to March 2018. Similarly another student joined in Karpoora Sundharanar Higher Secondary School and stayed in Sivagangai Hostel. But the Accused officer had falsely claimed Rs. 43.340/- as food and other allowances for the said 9 students during the relevant period. Further the Accused Officer had falsely claimed Rs. 31,500/- for food and other allowances for 10 months from June 2017 to March 2018 for another 9 students as if they were stayed in Idayamelur hostel. Thus, the above said facts would disclose the fact that Tr. V. Alagu as a public servant and by using his official position and by corrupt and illegal means during the year 2017 and 2018, committed criminal breach of trust of the Government funds to the extent of Rs. 74,840 by making forgery, falsification of records, using the forged documents as genuine, which would disclose the prima facie offence Cr.No. 02/2020, u/s 167, 409, 468, 471, 477A IPC and 13 (2) r/w 13 (1)(c) and (d) of Prevention of Corruption Act 1988. I am therefore registering a case in Cr.No. 02/2020, u/s 167, 409, 468, 471, 477A IPC and 13 (2) r/w 13 (1)(c) and (d) of Prevention of Corruption Act 1988 against the accused for the purpose of investigation.

The Original FIR is submitted to the Special Judge (Prevention of Corruption Act 1988). Sivagangai, one copy was sent to Tr.I.Manimannan, Deputy Superintendent of Police, Vigilance and Anti-Corruption, Sivagangai Detachment for further investigation and other copies forwarded to the concerned officers.
