Based on a Vigilance Report, a detailed enquiry was conducted against Tr.K.Murugesan, formerly commissioner / Block Development Officer, (Block Panchayat), Avinashi Panchayat Union, Tiruppur, now Assistant Project Officer (Infra), District Rural Development Agency, Collectorate Campus, Coimbatore-18 and he is a public servant as defined u/s.2(c) of Prevention of Corruption Act, 1988. The enquiry revealed the following information:

- 1. The accused No.1 Tr.K.Murugesan was working as commissioner cum Block Development Officer (Block Panchayat) of Avinashi Panchayat Union from 01.03.2016 to 06.02.2018.
- 2. The accused No.2 Tr.M.Saravanan is a private individual who is running a photocopier machine sales and service company under the name and style of Q Tech Sales and services situated at Door No.101, 24, Anna Nagar, 1st Opposite to Sixer Complex, College Road, Salem.
- 3. During the accused No.1's service in Avinashi BDO office he is an executive authority of Avinashi Panchayat Union office, Tiruppur District and also a competent authority to purchase equipments for the aforesaid office from the Union fund/General fund with the resolution of the Panchayat union counsel. The G.O.Ms.203 dated 20.12.2007 of Rural Development and Panchayat Raj (PR-I) department empowered the Accused No.1 to purchase equipments for his office.
- 4. In the case of purchasing equipments to his office, it is essential to follow the GO Ms.No.392 dated 18.8.2009 of Finance (Salaries)

 Department and also to adhere the clause (d) of section 16 of The Tamil Nadu Tender Transparency Act 1998 and Rule 33 of the Tamil Nadu Transparency in Tender Rules, 2000. Further more in Article 125

 The Tamil Nadu Financial Code Volume–I revealed that the Limited

Tender has to be called-for in the case of the Procurement which is exceeding Rs.5,000/-. Later the pecuniary limit of Rs.5,000/- stipulated in Article 125 of TamilNadu Financial Code extended to the procurement of Rs.10,000/- to Rs.10,00,000/- vide GO Ms.No.206 Finance (Salaries) Department dated 04.07.2017. Thereby it is clear that the GOs, Acts and Rules existed during the year of 2016 directed the executive authority who is going to purchase goods would be personally satisfied with the goods purchased is with requisite quality, specification and also the rate is reasonable and to ensure the supplier's reliability.

- 5. But the accused No.1 in connivance with accused No.2 violated the Government orders, Tender Transparency Rule and Act and in order to obtain wrongful gain for himself and A2, ignored the price of the machinery prevailing in the market at the relevant time, failed to ensure the suppliers reliability, has not obtain a proper invoice from A2 (received the invoice without proper description).
- 6. In continuance of the criminal conspiracy between A1 & A2, the A2 submitted his quotation with an inflated rate, and in order to select his quotation he purposively submitted two other fabricated quotations in the name of non-existing companies.
- 7. Without public interest and abused the official position of accused 1 decided to purchase the machinery from A2's company, passed a proceeding for the release of fund on 09.09.2016 itself.
- 8. Whereas the A2 purchased a Photocopier machine with brand name 'Xerox' WC 5325 at the rate of Rs.1,31,250/- including 5% VAT from Supertron Electronics Coimbatore on 10.09.2016 and installed the same in the A1's office on the same day for inflated a rate of Rs.2,35,000/- and thereby the accused -1 caused wrongful loss of

- Rs.1,03,750/- to the Government Exchequer and A2 obtained wrongful gain of Rs.1,03,750/-.
- 9. For the above said transaction, the accused 1 had received Rs.15,000/-as illegal gratification in order to purchase the photo copier machine from A2 Tr.M.Saravanan's company.
- 10. Thus there are prima facie material available against A1 Tr.K.Murugesan for the commission of offences punishable u/s.120(B), 420 IPC and section 13(2) r/w. 13 (1)(d) of the Prevention of Corruption Act, 1988 and against A2 Tr.M.Saravanan for the commission of offences u/s. 120(B), 465, 468, 471 and 420 IPC and 109 IPC r/w. 13(2) r/w. 13 (1)(d) of the Prevention of Corruption Act, 1988. Prior permission for the registration of the case against A-1 was obtained from the competent authority. Hence today 13.07.2020 at 17:30hrs. I am registering a case in Tiruppur V&AC Cr.No.02/2020/AC/TPR, u/s. 120(B), 420 IPC and section 13(2) r/w. 13 (1)(d) of the Prevention of Corruption Act, 1988 against A1 and u/s. 120(B), 465, 468, 471 and 420 IPC and 109 IPC r/w. 13(2) r/w. 13 (1)(d) of the Prevention of Corruption Act, 1988 against A2 for the purpose of investigation.
- 11. The original FIR is submitted to the court of Chief Judicial Magistrate cum special Judge, Chief Judicial Magistrate Court, Tiruppur.
