Attachment to column No.12 of First Information Report in Vigilance and Anti-Corruption, Coimbatore detachment crime No.02/2020/AC/CB u/s 13 (2) r/w 13 (1) (e) of the Prevention of Corruption Act, 1988.

It is submitted that on a credible information that accused Tr.S.Vijayasekar, Age-56/2020, S/o. C. Sundaramoorthy(Late), Joint Director, Fire-Rescue Services Department, Coimbatore while he was working as Divisional Fire officer, Deputy Director and holding a full additional charge of Joint Director of Fire-Rescue Services Department had acquired movable and immovable assets in his name and in the name of his family members, which are disproportionate to the known sources of his income, during the period from 01.01.2006 to 31.12.2010.

A Preliminary Enquiry was taken up and that was made into the following allegation against the above accused and the enquiry disclosed the prima facie of cognizable offence of the following information.

A Preliminary Enquiry was taken up and the same was revealed that the accused Tr.S.Vijayasekar, Joint Director of Fire-Rescue Services Department, Coimbatore. Accused Tr.S.Vijayasekar is a native of Kanjeeपुरam and he was born on 02.07.1964 at Chetpet, Polur Division. He hails from middle class family background, his father Late C.Sundaramoorthy retired from Deputy collector in revenue service and he expired on 05.04.2007. The accused Tr.S.Vijayasekar was born with 1 younger brother Tr.S.Panneer selvam, he is working in central government as Superintendent of Central Excise Executive cadre(tax) at Pondicherry.

The accused Tr.S.Vijayasekar has studied M.Sc(Maths), B.L., A.Dip., NFSC., The accused Tr.S.Vijayasekar was selected by the TNPSC Group-I Service and joined in Government service on 12.05.1995 as Divisional Fire Officer in Fire-Rescue Services Department, Vellore. The accused Tr.S.Vijayasekar married Tmt.G.Mangayarkarasi, her father Late Gnanasekaran retired from Deputy collector and who died on Feb-2011 residing in the house at Door no.10/48,3rd street, Anna nagar, Thiruvannamalai and Tmt.G.Mangayarkarasi is born with 2 sisters and 1 brother as per birth order namely 1)Tmt.G.Lakshmi, 2) Tr.G.Vasudevan, 3)Tmt.G.Mangayarkarasi and 4)Tmt.G.Padmavathy. All are married, Tmt.G.Lakshmi married with Tr.K.M.Viswanathan he is working in Hindustan Petroleum Corporation Limited and living at Visakapatnam, her brother Tr.G.Vasudevan working in the Fork lifters (P)Ltd, Chennai, Tmt.G.Padmavathy married with her husband's younger brother Tr.S.Panneer selvam, he is working in central government as Superintendent of Central Excise Executive cadre(tax) at Pondicherry. The accused Tr.S.Vijayasekar wife Tmt.G.Mangayarkarasi is a house maker. They have blessed with 2 daughters namely V.Indira, age-26, now she is working as part time Medical practitioner at Ramachandra medical college, Chennai and younger daughter namely V.Ishwarya, age-20, she is studying 3rd year MBBS at Central Government controlled Employed State Insurance Medical College, K.K. Nagar, Chennai and they are residing in Block no.97 A-F, Sowbagya colony, Ashok pillar road, K.K.Nagar,Chennai-600078.

The accused Tr.S.Vijayasekar was selected by the TNPSC Group-I Service and joined in Government service on 12.05.1995 as Divisional Fire Officer in Fire-Rescue Services Department, Vellore from 12.01.1996 to 20.04.1999 and served in Coimbatore from April 1999 to January 2003, Kancheepuram from 02/2003 to

18.09.2006 and he was promoted as Deputy Director of Fire-Rescue Services Department and served in Vellore from 19.09.2006 to 17.12.2009 and he was holding a full additional charge of Joint Director from January 2010 to 03.10.2013 and he was promoted as Joint Director of Fire-Rescue Services Department on 03.10.2013 and served in North Chennai from 03.10.2013 to September 2016 and transferred to Western region, Coimbatore from 26.09.2016 and worked in the same office till date. He is public servant as defined under Section 2(c) of the Prevention of Corruption Act, 1988.

For the purpose of quantifying the disproportionate assets, the check period has been fixed to be from 01.01.2006 to 31.12.2010.

Assets in the name of the accused Tr.Vijayasekar and family members at the beginning of the check period i.e., on 01.01.2006 to the tune of Rs.4,39,071/- (Rupees four lakhs thirty nine thousand seventy one only) in the form of Tamil Nadu Housing Board house plots and in the form of Four Wheeler etc.

Assets in the name of the accused Tr.S.Vijayasekar and his family members at the end of the check period i.e. on 31.12.2010 to the tune of Rs.42,58,008/- (Rupees Forty two lakhs fifty eight thousand eight only) in the form of purchased plots and purchased apartment and in the form of additional construction of house (ancestral property) without getting permission etc.

Income of the accused Tr.S.Vijayasekar from lawful sources such as Salary from the Government, house rent and interest from banks etc., to the tune of Rs.38,53,353/- (Rupees Thirty eight lakhs fifty three thousand three hundred and fifty three only) during the check period from 01.01.2006 to 31.12.2010.

Expenditure of the accused Tr.S. Vijayasekar and his family members during the check period from 01.01.2006 to 31.12.2010 to the tune of Rs.24,87,562/- (Rupees Twenty four lakhs eighty seven thousand five hundred and sixty two only) in the form of living expenses, repayment of house loans, educational expenses of his daughters etc.

Thereby the assets acquired by the accused Tr.S.Vijayasekar during the check period from 01.01.2006 to 31.12.2010 to the tune of Rs.38,18,937 (Rs.42,58,008 – Rs.4,39,071 = Rs.38,18,937) (Rupees Thirty eight lakhs eighteen thousand nine hundred and thirty seven only).

Likely savings of the accused Tr.S. Vijayasekar during the check period from 01.01.2006 to 31.12.2010 to the tune of Rs.13,65,791/-(Rs.38,53,353 – Rs.24,87,562=Rs.13,65,791) (Rupees Thirteen lakhs sixty five thousand seven hundred and ninety one only).

But, the accused Tr.S. Vijayasekar acquired Disproportionate Assets during the check period 01.01.2006 to 31.12.2010 to the tune of Rs.24,53,146/- (Rs.38,18,937 – Rs.13,65,791 = Rs.24,53,146) (Rupees Twenty four lakhs fifty three thousand one hundred and forty six only) in excess of the likely savings and its percentage is 63.66%.


Thus, the accused Tr.S. Vijayasekar, Joint Director, Fire-Rescue Services Department, Coimbatore while he was working as Divisional Fire officer, Deputy Director and holding a full additional charge of Joint Director of Fire-Rescue Services Department had acquired movable and immovable assets in his name to the extent of Rs.24,53,146/- during the period from 01.01.2006 to 31.12.2010 which are disproportionate to the known sources of his income.

The above information discloses the commission of the offence of "Criminal Misconduct by a Public Servant" defined u/s 13 (1) (e) punishable u/s 13 (2) of prevention of Corruption Act, 1988.

The Tamilnadu Vigilance Commission Letter No.369/VC-III/2020-1, Dated 20.02.2020, have accorded permission to register a regular case against accused Tr.S.Vijayasekar, Joint Director of Fire-Rescue Services department, Coimbatore District in the above matter.

Hence, I am registering a case in Coimbatore V&AC Cr.No.02/2020 u/s 13 (2) r/w 13 (1) (e) of the Prevention of Corruption Act, 1988 on 26.03.2020 at 1300 hrs against accused Tr.S.Vijayasekar, Joint Director of Fire-Rescue Services department, Coimbatore District for the purpose of investigation into the aforesaid offence.

The Original F.I.R. is submitted to the Hon'ble Special Court for cases under the Prevention of Corruption Act, Coimbatore and a copy of the F.I.R. is going to be sent to the Superintendent of Police, Western Range, Vigilance and Anti Corruption, Chennai, for issuing order u/s 17 of the Prevention of Corruption Act, 1988 to investigate the case and authorization u/s 18 of the said Act to inspect bankers books to Tr.C.Rajesh, Deputy Superintendent of Police, Vigilance and Anti-Corruption, Coimbatore.
