VIGILANCE AND ANTI CORRUPTION

Submitted

Based on a petition of Tr.M.P.Parthiban, S/o Padavettan, Pump Operator (Retd), Tamil Nadu Housing Board, Vellore Unit, Vellore (Residential address: No.3/62, Mariyamman Koil St., Virudhampet, Vellore-6), a Preliminary Enquiry was taken up against, AO-1 Tr.D.Prabakaran (61/2020), Executive Engineer (Not allowed to retire), Tamil Nadu Housing Board, Vellore Housing Unit, Vellore, AO-2 Tr. Jayaprakash (56/2020), Assistant, Tamil Nadu Housing Board, Vellore Housing Unit, Vellore and AO-5 Tr.S.Gurusami @ Tr.S.Kuthusi Gurusami (58/2020), Assistant (Not allowed to retire), Tamil Nadu Housing Board, Vellore Housing Unit, Vellore and during the enquiry the involvement of AO-3 Tr.G.Sekaran (60/2020), S/o Govindasamy, formerly Superintendent, Tamil Nadu Housing Board, Vellore Housing Unit, Vellore and AO-4 Tr.G.Nagarajan (54/2020) S/o Govindasamy, being the Office Assistant, i/c Record Clerk, Tamil Nadu Housing Board, Vellore Housing Unit, Vellore were came into light and they were included as additional AOs after getting prior approval from the Competent Authorities. AO-1 to AO-5 are Public Servants as defined in Sec.2(c) of Prevention of Corruption Act, 1988.

It is reliably learnt that AO-1 Tr.D.Prabakaran, Executive Engineer (Not allowed to retire) in connivance with AO-2 Tr.K.Jayaprakash, Superintendent, TNHB Vellore Unit, AO-3 Tr.G.Sekaran, Superintendent, TNHB Vellore Unit (now under suspension), AO-4 Tr.G.Nagarajan, Office Assistant, TNHB Vellore Unit and AO-5 Tr.S.Kuthusi Gurusami, Assistant (Now under suspension), Tamil Nadu Housing Board, Vellore Housing Unit, Vellore had illegally created forged sale deed documents of TNHB Vellore Unit in Seekarajapuram Plots system and also not following the TNHB manual procedures, falsely created a file in No.A9/4436/2005 and the information's were falsely entered in Page No.305 of Allottee Ledger and registered the above said plot No.B-240 in the name of AO-4 Tr.G.Nagarajan's son Tr.N.Lokesh for the cost of Rs.1,94,816/- vide Document No.2302/2015, dt:05.03.2015. Again, the above said Plot was sold to one Tr.T.Rajendran S/o Thulasiraman for the cost of Rs.12,00,000/- vide sale deed document

No.5579/2015, dt:16.07.2015 and cheated the TNHB and caused loss the Government exchequer.

It is learnt that the AO-1 Tr.D.Prabakaran also involved in the forgery activities in Vellore Phase-III Survey No.135/3P and 135/3L measuring about 0.10 acre and individually sold to one Tmt.P.Sumathi D/o Arjuna Naicker, Rangapuram, Vellore-9 vide Reconveyance deed document No.2741/2015, dt:13.3.2015 without any TNHB witnesses signatures and also without adhering the TNHB rules and regulations and cheated the TNHB and caused loss the Government exchequer.

Further the Plot No.158 in Vellore Phase-I was actually allotted to one Tmt.Santha D/o. Govindasamy, vide letter No.VR-2/4606/73, dt:06.07.1973 for Rs.3,100/-, but, AO-1 Tr.D.Prabakaran connived with AO-3 Tr.Sekaran and AO-5 Tr.S.Kuthuci Gurusami @ S.K.Gurusami, created false and forged documents and sold the above plot to one Tmt.Santhi @ Santha, W/o Subramani, Salavanpet, Vellore vide Sale Deed Document.2015/2016, dt:25.2.16 without following any TNHB rules and cheated the TNHB and caused loss the Government exchequer.

The AO-1 Tr.D.Prabakaran connived with AO-3, Tr.Sekaran and AO-5, Tr.S.Kuthuci Gurusami @ S.K.Gurusami by creating false and forged documents and sold the unsold Plot No.1230 in Vellore Phase-II to one Tr.R.Suresh, S/o Ravanan, Sathuvachari, Vellore vide Sale Deed Document.3491/2016, dt:7.4.16 for the cost of Rs.6,900/-, without any allotment procedures of TNHB manual and cheated the TNHB and caused loss the Government exchequer for pecuniary gain.

Thus, AO-1 Tr.D.Prabhakaran, Executive Engineer (Not allowed to retirement) in connivance with AO-2 Tr.K.Jayaprakash, Superintendent, AO-3 Tr.G.Sekaran, Superintendent (Not allowed to retirement), SO-4 Tr.G.Nagarajan, Office Assistant i/c Record Clerk, AO-5 Tr.S.Kuthuci Gurusami @ S.K.Gurusami, S/o Selvaraji (Now under suspension) created false and forged documents, entered false entries in the Government registers and without following any proper allotment rules and procedures cheated the TNHB and caused loss the Government exchequer for pecuniary gain.

There is sufficient material to go for a Regular Case against AO-1 to AO-5, the registration of FIR is necessary to investigate and to unearth further facts and hence I am registration a Regular Case against AO-1 to AO-5 u/s. 420, 463, 464, 465, 467, 468, 471, 474, 477A IPC and 13(2) r/w 13(1)(a) of Prevention of corruption Act 1988 as amended by Prevention of Corruption (Amendment) Act 2018.

The prior permission for the registration of case against AO-1 to AO-5 were obtained from the Competent Authorities.
