In pursuance of the memorandum of the DVAC Vide VR No.10928/2019/RDP/NI, Dated:02.11.2020, a case is registered in the information against Tr.M.Nagarajan, Block Development Officer, Village Panchayat, Panchayat Union Office, Udhagamandalam, the Nilgiris District (A1) and Tr.P.Appadurai, Overseer, Panchayat Union Office, Udhagamandalam, the Nilgiris District (A2).

- 2) The accused A-1 and A-2 are public servants as described section 2(C) of Prevention of Corruption (Amendment) Act 2018.
- 3) A-1, was working as Block Development Officer, Village Panchayat at Udhagamandalam Panchayat Union office from 09.05.2018 to 07.03.2019 and is the leader of a team of development workers in the block. In Swachh Bharat Mission (Gramin) Scheme, A-1 is entrusted with the quality of work and the payment of incentives either in cash or in the form of construction materials or credit vouchers for such materials to the beneficiaries. He has exercise his duties with due diligence in respect of any financial activity.
- 4) A-2, was working as Overseer from 07.04.2017 to 04.03.2019 under the supervision of A-1. He has to prepare estimate works, visit the sites to ensure the quality of works carried out and to report to the Block Development Officer then and there.
- 5) During the year 2018-2019, administrative sanction was accorded for construction of Individual Household Latrines (IHHL) under

Swachh Bharat Mission (Gramin) scheme in the Nilgiris District with a Central share of incentive of 75% and state share of incentive of 25% and payment of incentives may be either in cash or in the form of construction materials or credit vouchers for such materials. In case of individuals being paid the incentive, if required, states may decide to provide incentives to household in two phases, one at the preconstruction stage and the other on completion of construction and usage to the beneficiaries account through ECS.

- 6) A-1 and A-2 were entrusted to motivate the public of Thuneri, Ebbanadu, Kookalthorai and Nanjanadu Panchayats to adopt sanitation for overall cleanliness by constructing latrines under this scheme using the incentives.
- 7) During the year 2018-2019, administrative sanction was accorded for construction of Individual Household Latrines (IHHL) under Swachh Bharat Mission (Gramin) scheme to the beneficiaries from Thuneri, Ebbanadu, Kookalthorai and Nanjanad Panchayats of the Nilgiris District. The incentive amunt sanctioned for each beneficiary was Rs.12,000/-. A-1, Tr.M.Nagarajan and A-2, Tr.P.Appadurai entered into a conspiracy at Udhagamandalam Panchayat Union Office for misappropriating the Government funds and misappropriating the funds by preparing false documents and false entries in the registers maintained in the Udhagamandalam Panchayat Union Office.
- 8) A-2 knowing that the actual works carried out are to be measured and entered in the measurement book had created false entries in the concerned office records and A-1, knowing that, the works thus carried out should be super-checked had accepted the false entries

as if the beneficiaries had completed the work and transferred the funds through ECS to IDBI Bank, Udhagamandalam Branch in one Account No.1097104000098324. This account belongs to one Tr.S.Prabhakaran, who works as NMR at Panchayat Union, Udhagamandalam under the supervision of A-2. The Government funds of Rs.29,28,000/- was transferred by A-1 from the Government Account "BDO VP SWACHH BHARAT MISSION GRAMIN" to Tr.S.Prabhakaran's account during 2018-2019. On the request of A-1 and A-2, the amount was inturn paid to A-1 and A-2 by Tr.Prabhakaran.

- 9) A-1, Tr.M.Nagarajan and A-2, Tr.P.Appadurai had entered false entries in connected office records, created false documents and misappropriated a sum of Rs.29,28,000/- and caused wrongful loss to Udhagamandalam Panchayat Union which constitute offences punishable u/s 13(2) r/w 13(1) (a) of Prevention of corruption (Amendment) Act 2018 and sections 120(B), 409, 465, 468, 471 and 477 (A) IPC and substantive offences thereof.
- 10) The competent authority accorded prior permission for the registration of case against A-1, Tr.M.Nagarajan, BDO and A-2 Tr.P.Appadurai, Overseer of Panchayat Union, Udhagamandalam, the Nilgiris District.
- 11) On the above information, today on 09.11.2020 at 14.00 hrs, I am registering a case in Vigilance and Anti Corruption, Udhagamandalam Cr.No.4/2020 u/s 13(2) r/w 13(1) (a) of Prevention of Corruption (Amendment) Act 2018 and sections 120 (B), 409, 465, 468, 471 and 477 (A) IPC and FIR along with DVAC Memorandum is sent to the Hon'ble Special Court and a copy to the officers concerned.
