Based on a vigilance report, a detailed enquiry was ordered by DVAC and after enquiry DVAC ordered to register a regular case against A.O-1 Tr.Mahendra Pratap Dixit (57/20) S/o. Sri Ramagya Dixit, Assistant Director of Agriculture, formerly of Arcot Block, Vellore District, A.O-2 Tr. S. Venkatesan (43/20), S/o. Tr. C. Sampath, Assistant Agriculture Officer, Chakramallur, Arcot Taluk, Vellore District, A.O-3 Tr.C.Ramesh (43/20) S/o. Late. Tr. Chinnakutty, Assistant Agriculture Officer, Aayilam, Arcot Taluk, Vellore District, A.O-4 Tr. K. Mohan (38/20), S/o. Tr. A. Krishnan, Assistant Agriculture Officer, Ladavaram, Arcot Taluk, Vellore District, A.O-5 Tr. Dhananchezhiyan (47/20), S/o. Tr. L. Kuppusamy, Assistant Agriculture Officer, formerly of Ladavaram, Vellore District and A.O-6 Tr. Vijayakanth (49/20), S/o. Arumugam, residing at No.260, Srinivasan Nagar, Puliyanthangal, Erikodi, Walaja Taluk, now working as Office Assistant, at the office of the Assistant Director of Agriculture, Arcot Block, Vellore District. AO-1 to AO-6 are Public Servants as defined in Sec.2(c) of Prevention of Corruption ACT 1988.

While implementing the National agricultural development programme (NADP) 2012-13 & 2013-14 — transplantation in redgram in Vellore district, the Agricultural Department had given the farmers a new variety of seeds - LRG-41 in the years 2012-13 & 2013-14 along with several inputs such as micro nutrient mixture, bio-fertilizers, chemical fertilizers and DAP for spraying under the integrated nutrition management. A subsidy of Rs. 7500/- per hectare was granted to farmers taking up the transplanted red gram cultivation.

It is reliably learnt that, in the implementation of the red-gram scheme under National Agricultural Development Programme Scheme, A.O-1 Tr.Mahendra Pratap Dixit Assistant Director of Agriculture, formerly of Arcot Block, Vellore District, conspired with A.O-2 Tr. S. Venkatesan, Assistant Agriculture Officer, Chakramallur, Arcot Taluk, Vellore District, A.O-3 Tr. C. Ramesh, Assistant Agriculture Officer, Aayilam, Arcot Taluk, Vellore District., A.O-4 Tr. K. Mohan, Assistant Agriculture Officer, Ladavaram, Arcot Taluk, Vellore District, A.O-5 Tr. Dhananchezhiyan, Assistant Agriculture Officer, formerly of Ladavaram Vellore District. and A.O-6 Tr. Vijayakanth, Office Assistant, at the office of the Assistant Director of Agriculture, Arcot Block, Vellore district in connivance with each other and by abusing their official position, conspired together to misappropriate the fund allotted to beneficiaries under implementation of the redgram scheme under NADPS.

In furtherance of the said conspiracy, A.O.-2 Tr. S. Venkatesan, Assistant Agriculture Officer, Chakramallur, Arcot Taluk, Vellore District obtained the signatures/thumb impression of Tr. Bakthavachalam A/54/17, S/o.Late Munusamy, Esaiyanur Village, Arcot Taluk and S.Ganesan A/39/17, S/o.Settu, Esaiyanur Village, Arcot Taluk in blank cash receipts.

Further, A.O-3 Tr. C. Ramesh, Assistant Agriculture Officer, Aayilam, Arcot Taluk, Vellore District obtained the signatures/thumb impression of Tr.P.Perumal, A/40/17, S/o.Pachaiappan, Kilanthangal Village, Arcot Taluk and Tr.D.Ravi, A/42/17, S/o.Dharmalingam, Thennandhiyalan, Walaja Taluk in blank cash receipts.

A.O-4 Tr. K. Mohan, Assistant Agriculture Officer, Ladavaram, Arcot Taluk, Vellore District obtained the signatures/thumb impression of Tr.V.Sanker, A/50/17, S/o.Vilwapathy, Chakkramalur, Arcot Taluk and Tmt.S.Geetha, A/42/17, W/o.V.Sanker, Chakkramalur, Arcot Taluk in blank cash receipts.

A.O-5 Tr. Dhananchezhiyan, Assistant Agriculture Officer, formerly of Ladavaram Vellore District, obtained the signatures/thumb impression of Tmt.Sharmilla, A/42/17, W/o.Baskaran, Esaiyanur Village, Arcot Taluk and K.Perumal, A/40/17, S/o.Krishtappan, Kilanthangal Village, Arcot Taluk in blank cash receipts.

And A.O-6 Tr. Vijayakanth now working as Office Assistant, at the office of the Assistant Director of Agriculture, Arcot Block, Vellore District, in connivance with A.O-2, Tr. S. Venkatesan, Assistant Agriculture Officer, Chakramallur, Arcot Taluk, Vellore District obtained the signatures/thumb impression of Tr.C.Settu, A/69/17, S/o.Late Chinnapa, Esaiyanur Village, Arcot Taluk & J.Madan, A/34/17, S/o.Janakiraman, Esaiyanur Village, Arcot Taluk in blank cash receipts and had received self cheques and subsidy amount was drawn, as if subsidy was disbursed to them and made the higher officials and the Government to believe that the subsidy amount had actually be credited to the account of the farmers.

Further, A.O-1 Tr.Mahendra Pratap Dixit, Assistant Director of Agriculture, formerly of Arcot Block, Vellore district through four self cheques had drawn subsidy amount Rs.9,84,181/- and misappropriated, as if subsidy was disbursed to the farmers and made the higher officials and the Government to believe that the subsidy amount had actually be credited to the account of the farmers. In altogether Rs.10,44,401 was withdrawn and generated false entries in the UDR register as if the same was disbursed to the beneficiaries. Thus AO-1 conspired with AOs-2 to 6 and cheated the farmers by obtaining signature in blank receipts as if subsidy amount

Rs.10,44,401(Rs.60,220/- (disbursed by self cheque) + Rs.9,84,181 (disbursed by cash) = Rs.10,44,401) was disbursed to them and generated false entries in the UDR register and made the higher officials and the Government to believe that the subsidy amount had actually been credited to the accounts of the farmers and misappropriated the subsidy amount of Rs.10,44,401/- and caused loss to the Government.

In this regard, prior permission for the registration of case against AO-1 to AO-6 was accorded as per section 17A(1)(b) of Prevention of Corruption Act 1988; as amended by the Prevention of Corruption (Amendment) Act,2018 by the Government in G.O(D)No:217 dated:25.09.2019 of Agriculture (AA2) Department.

There is sufficient material to go for a Regular Case against AO-1 to AO-6, the registration of FIR is necessary to investigate and to unearth further facts and hence, on 26.06.2020 at 11.00 Hrs, I am registering a Regular Case against AO-1 to AO-6 in Vellore Vigilance and Anti-Corruption Detachment Cr.No.4/2020, u/s.120(B), 409, 420, 467, 468, 471 IPC and 13(2) r/w 13(1)(c) of Prevention of Corruption Act-1988.
