

Based on a complaint by Tr.J.Ramachandra Rao, residing at new No.31/2, Appasamy Kovil Street, Mylapore, Chennai-600 004, forwarded to the DVAC by State general Secretary Anti- Bribe movement Chennai at 26/03/2018 a preliminary enquiry was conducted against the marginally noted accused for acceptance of bribe as pecuniary advantage and failure to do their official duties and caused prejudice to the complainant. The preliminary enquiry reveals that the Accused-1).Tr.G.Saravanan, A2) Tr.T.Baskar, A3)Tr.T.Premnath and A4) Tr.P.Aravindhan are Public Servants u/s. 2(c) of Prevention of Corruption Act, 1988 during the relevant period of occurrence. Originally the property belongs to one Subbulakshmi, who purchased from Bucckingham & Carnatic mills Employees Co-operative Housing construction Society Limited, Housing Society represented by Mohanram and Ponniah Power agent and from him Tr.SuryaNarayanaRao brother of Tr.Ramachandra Rao had purchased the land vide Document No.5792/1994. Since Suryanarayana Rao expired and had no issues and his wife also expired, Ramachandra Rao was the only legal heir for the said property. In the meantime, one Kaja Mohideen and his sons have fabricated documents by falsely producing patta in Town Survey No.74/1, old Survey No.246/4 and attempted to grab the piece of land of the complainant. The District Munsif Court, Ambattur has delivered Judgment observing the fabrication of documents held that the property in issue belongs only to the complainant Ramachandra Rao. The preliminary enquiry reveals that for property 3600 sq.ft., land in Survey No.256/4, Plot No.269, 370 and 371 at Mugappair Village, Ward No.4, Block No.8, Town Survey No.0241.0, Ambattur Circle, Thiruvallur District, Tr.Ramachandra Rao, being the legal heir of the document holder of the property in issue and also civil dispute was of settled in favour of him as per the verdict of Ambattur Munsiff Court, for issuance of Patta to the said land, he being octogenarian, has taken assistance of his family friend, one Tr.Sathyakumar alias siva, to obtain Patta at Ambattur Taluk Office. On 06/07/2017 Tr.Ramachandra Rao petition before R.D.O, Ambattur, with the assistance given had Tr.Sathyakumar @ Siva had approached the office of Tahsildar, Ambattur on 06.07.2017 to obtain Patta for his land measuring 3600 sq.ft, which falls in old Survey No.256/4, Plot No.369, 370 and 371 at Mohapair Village, Ward No.4.

and Block No.8 Town Survey No.0.0241.0, Ambattur Circle, Thiruvallur along with true copies of relevant documents. They have approached the officials of Ambattur Taluk Office several times since 2016 and made representation for change of Patta in Tr.Ramachandra Rao's name, as there was a fake Patta issued in the name of Shaul Hameed and Raffi Ahmed, sons of Kaja Mohideen. Preliminary enquiry reveals that for issuance of patta in the name of Tr.Ramachandra Rao, the R.D.O, Ambattur, Tr.Aravindan demanded Rs.20 lakhs as bribe for Patta transfer. After bargaining with R.D.O. Tr.Aravindan through one Premnath, the demand of bribe was reduced to Rs.11,50,000/-(Rs.10 lakhs for R.D.O, Tr.Aravindan and Rs.1,50,000/- for Premnath.) During August 2017, the Tahsildar Baskar demanded bribe of Rs.50,000/-Tr.Saravanan in Survey Section demanded Rs.30,000/- as bribe. Thus a total amount of Rs.12,30,000/- was demanded as bribe by A1 to A4 And consequently the total amount was paid to A1 to A4 various dates. On 21/08/2017, Rs.5 lakhs was given to A3 on the direction of A4, at R.D.O Office Ambattur. On 28/10/2017, Rs.6.5 lakhs was given to A4 through A3 at R.D.O Office Ambattur. At Ambattur Tahsildar Office on 30/10/2017 A2 accepted Rs.50,000/- as bribe as demanded earlier. A1 accepted bribe of Rs.30,000/- on 30/10/2017. The Preliminary enquiry reveals that even though A1 to A4 received the bribe amount and they failed to take steps for issue of Patta in the name of Tr.Ramachandra Rao, in spite of the many representations made to Revenue Divisional Office, Ambattur and Tahsildar office, no action was taken by them in this regard. The above enquiry discloses that there is a prima facie case against the accused A1 to A4 for commission of offences u/s.7, 13 (2) R/W 13(1) (d) of Prevention of Corruption Act 1988.

Hence I am registering a case today in City Special Unit-III in Crime No.5/AC/2020/CC-II, u/s.7, 13(2) r/w 13 (1) (d) of Prevention of Corruption Act 1988 against AO-1 Tr.G.Saravanan, Deputy Inspector of Survey, Ambattur Taluk Office, Thiruvallur District. AO-2 Tr.T.Baskar, formerly Tahsildar, Ambattur Taluk Office, Thiruvallur District. AO-3 Tr.T.Premnath, formerly Assistant in the rank of Senior Revenue Inspector, AO-4 Tr.P.Aravindan, Formerly Revenue Divisional Officer, Ambattur Division, Thiruvallur District. The original FIR is submitted to The Hon'ble Court of the Chief Judicial Magistrate Cum Special Judge Tiruvallur and copies were forwarded to the officers concerned.
