

A-2 Tmt. M. Shaheen, W/o Tr. Mohamed Ibrahim, No.6/343, Mosque Street, Appampattu Village, Meenambur Post, Gingee Taluk, Villupuram District. Based on the outcome of the Detailed Enquiry No. DE 34/2016/RDP/TVM, dated: 25.05.2016 of DVAC, Chennai -16, a case is being registered against the marginally noted accused officers -1 Tr. A. Mohamed Ibrahim and 2. Tmt. M. Shaheen, W/o Tr. A. Mohamed Ibrahim, (Private Individual). The Detailed Enquiry reveals the following facts.

A1. Tr. A. Mohamed Ibrahim joined Government Service as an Assistant Draughtsman at the O/o Assistant Divisional Engineer (Highways Rural Work Department), Virudhachalam, 17.10.1980. He Cuddalore District on promoted as Union Overseer on 11.12.1980 and worked at different Block Development Offices in Cuddalore District till 16.09.2002. Later he was promoted as Union Engineer on 16.09.2002 and worked at Kammapuram and Nallur in Cuddalore District till 10.10.2008. Then he was promoted as Assistant Executive Engineer and posted to work in Nagapattinam and Kanchipuram Districts from 11.10.2008 to 12.04.2013. He worked as Assistant Executive Engineer in Tiruvannamalai District from 13.04.2013 to 26.02.2016. Later he worked as Assistant Executive Engineer at Panruti in Cuddalore District and District Rural Development Agency in Pudukottai District till 31.07.2017. He was not allowed to retire on the day of superannuation on 31.07.2017.

A-1 is a public servant as defined u/s 2(c) of the prevention of Corruption Act 1988.A-2 Tmt.M.Shaheen is wife of A-1. She is a house wife and she is not the earning member of the family.

Collection of sources reveals that A-1 Tr. A. Mohamed Ibrahim hails from a middle class family. He is native of Appampattu Village, Meenambur Post, Gingee Taluk, Villupuram District. A-1 and A2 have two kids one son Tr. M. Armaan Saaliqh, an Engineering Graduate and one daughter Tmt. Afshaana, studied M.B.B.S., at K.A.P. Viswanathan Government Medical College, in Trichy. Both were married

It is gathered that A-1 Tr. A. Mohamed Ibrahim intentionally enriches himself illicitly in his name and in the name of his wife A-2 Tmt.M.Shaheen during the period of his office in various places. Most of the acquisitive activities of A-1 falls between 01.01.2004 and 31.12.2010 as detailed below. Hence it was taken as tentative check period.

The available information makes out a prima facie case that A-1 Tr.A.Mohamed lbrahim and his wife A2 Tmt.M.Shaheen were in possession of pecuniary resources and properties to the tune of Rs. 22,34,060/- during the period from 01.01.2004 to 31.12.2010 which is disproportionate to their known sources of income. Thereby, A1 had committed the offence of Criminal Misconduct by intentionally enriching themselves illicitly during the period of his office and his wife A-2 Tmt. M.Shaheen had abetted A-1 to commit criminal misconduct.

Therefore today on 22.09.2020 at 11.45 hrs I registered a case in Tiruvannamaiai V&AC Cr. No. 05/2020 u/s 13(2) r/w 13 (1) (e) of the Prevention of Corruption Act 1988 against A-1 Tr. A. Mohamed Ibrahim and u/s 13(2) r/w 13 (1) (e) of the Prevention of Corruption Act 1988 r/w 109 IPC against A-2 Tmt. M.Shaheen.

The original FIR is being sent to the Hon'ble Chief Judicial Magistrate cum Special Judge, Tiruvannamalai and a copy to the Superintendent of Police, Vigilance and Anti-Corruption, Western Range, Chennai-16 for issuing order u/s 17, of the Prevention of Corruption Act 1988 to investigate the case by Tmt.G.Mythily, Inspector of Police, Vigilance and Anti-Corruption, Tiruvannamalai with authorization u/s 18 of the said Act to inspect bankers book in relation to the accounts of A-1 Tr. A. Mohamed Ibrahim and A-2 Tmt. M.Shaheen.
