Letter (D) No.11, Backward Backward Classes, Most Classes and Minorities Welfare (MWRU) Department, dated 31.01.2020 for the Tr.D.S.Dhanarai & A-2 accused A-1 No.144 Tr.R.Gopalan G.O.(D) and **Employment** Labour and (N1) Department, dated 02.03.2020 for the accused A-3 Tr.Senthilkumar to register a As per the DVAC Memorandum case. vide VR.No.5981/2019/EDN/KM. dt. 17.10.20, I register a Regular Case against the marginally noted accused-1

A-1 Tr.D.S.Dhanaraj was working as Secondary Grade Warden, Govt. Boys School Hostel, Sevilimedu, Kancheepuram District from the period 24.07.2010 to 31.01.2020. A-2 Tr.R.Gopalan was working as District Backward Classes and Minority Welfare Officer, Kancheepuram from the period from 10.05.2010 to 30.09.2010 and A-3 Tr.Senthil Kumar was working as District Employment Officer, Kanchipuram from the period from 01.02.2008 to 30.12.2010. Therefore the accused A1 to A3 are comes under the definition of 2 (c) of Prevention of Corruption Act, 1988.

Based on Vigilance Report of Inspector, V&AC, Kancheepuram, the following facts were brought to light.

A-1 Tr.D.S.Dhanaraj was enlisted in Govt. Service as Secondary Grade Warden, Govt. Boys School Hostel, Sevilimedu, Kancheepuram District in the year 2010 by furnishing fake transfer certificate (D.T.E. II year- Regular) as if issued by the Govt. of Uttar Pradesh, Certificate No.138/2000 with registration No.000295, Serial No.038/2002 dated 24.07.2002. Further the A-1 had also produced another fake certificate as if he had completed his Diploma in Teacher's Education (D.T.E) (Regular) with Roll No.000295, enrolment No.E2274, dated 24<sup>th</sup> July 2002 at Indira Gandhi Teacher Training College, Mahalakshmipuram (Nagapura), Bangalore-86 during 2002. On the contra a verification was sent by Tmt.V.Malathi, formerly District Backward Classes and Minority Welfare Officer, Kancheepuram addressed to the Karnataka Secondary Education Examination Board, Bangalore regarding the genuinenity of the educational

certificates and in turn the Secretary, Karnataka Secondary Education Examination Board, Bangalore in their reply letter addressed the District Backward Classes and Minority Welfare Officer, Kancheepuram stated that there is no such named college in Bangalore and the certificate are not concerned to their office and they are not issued by their office. In this regard, no action has been taken by the Department against the A-1.

From the above act, it is clear that A-3 Tr.Senthilkumar, District Employment officer, Kancheepuram had facilitated the A-1 by recommending his name to the appointing authority — A-2 Tr.R.Gopalan, District Backward Classess and Minority Welfare Officer, Kancheepuram to enter the Govt. Services and also the then appointing authority had not verified the genuinenity of the said education documents and had colluded with A-1 by appointing him in Government Services and thus causing the Govt. huge monetary loss since his inception in to the Govt. Services from the year 2010 (Duty Pay – Rs.29,400/-).

Also, the then appointing authority – A-2 Tr.R.Gopalan, District Backward Classes and Minority Welfare Officer, Kancheepuram, had not applied his mind in finding out the authenticity of the A-1 and his credentials and also failed in discharging his duties in a fair manner, thus facilitating the A-1 entering into the Government services through back door.

Hence, A-1 fraudulently, criminally cheated the Government by creating forged documents and there is sufficient evidence to go for a Regular Case, similarly A-3 had facilitated the A-1 by recommending his name to the appointing authority A-2 Tr.R.Gopalan to enter the Govt. Services and A-2 in turn had not evaluated the genuinenity of the said education documents and had colluded with A-1 by appointing him in Government Services and thus they are also committed offence and hence regular case may also be registered against them u/s 465, 466, 468, 471 r/w 109 IPC and 13(2) r/w 13(1)(d) of Prevention of Corruption Act 1988.

The registration of FIR is necessary to investigate and to unearth further facts and hence, I am registering a case in Crime No.6/2020 of Kancheepuram V&AC Unit against the Accused under the above sections of law for the purpose of conducting investigation.

The original FIR is submitted to the Special Judge, Chengalpattu and copies were sent to the officers concerned.
