In accordance with prior permission u/s. of Corruption the Prevention 17(A) (Amendment) Act, 2018 issued vide (1) G.O (3D) No. 50 of Rural Development and Panchayat Raj 12.09.2019 Dated: Department, (E2) Accused-2,5,10,11,12 and 13, (2) The managing Director, Tamil Nadu Transport Corporation, Villupuram Limited, Villupuram Vide letter No.141/P3/tnstc(v)/Kanchipuram/2019, dated 23.11.2019 for the Accused-3 to register a case The Accused -1 now private individual, the completed his tenure as Panchayat President, accused-4,6,7,8&9 already were got superannuation. As per the DVAC Memorandum vide DE: 4/2017/RDP/KM, dated: 07.11.2020, J register a Regular Case against the marginally noted accused-1 to 13.

Based on the Vigilance Report which was initiated on the information received from source, a Preliminary Enquiry was conducted vide No. PE 211/2016/RDP/HQ. The Investigating officer of the preliminary enquiry recommended for a Detailed Enquiry against the Accused Officers. Accordingly the Director, Vigilance and Anti-Corruption, Chennai vide memo in DE 4/2017/RDP/KM, dated 7.02.2017 has ordered for a Detailed Enquiry to be taken up against the Accused Officers and thus the Detailed Enquiry

Accused-13 Tmt.Gowri, Project Manager, Chithamur Panchayat Union, Cheyyur Taluk, Kanchipuram District. During the year between 2011 to 2016 A-1 to A-13 were public servant u/s.2(c) of The Prevention of Corruption Act-1988.

Tmt.P.Valarmathi, W/o.Punniyakotti, Panchayat President, Vedal Village, Chithamur Panchayat Union, Kanchipuram District, 2) Tr.K.Sasikumar, Pachayat Secretary, Vedal Panchayat, 3)Tr.Punniyakotti, S/o.Elumalai, colluded with the government officials of Chithamur Panchayat violated the rules and orders of the government, made irregularities and swindled amount from the beneficiaries on commission basis in implementing Indira Awaas Yojana (IAY) House Scheme, Green House Schemes and also recommended and sanctioned amount for fake beneficiaries (relatives, ward members etc. The above said A.Os misappropriated an amount of Rs.11,38,203/- (Rupees Eleven Lakhs Thirty Eight Thousand Two Hundred and Three only) in implementation of government housing scheme at Vedal Village.

The BDO (VP) (A.Os-4 to 9) did not verify whether the applicants were eligible for the above house scheme of Government and also did not check whether the persons who applied - are already benefitted in the Government housing scheme (IAY & Green housing scheme). Further the above said BDOs (A.Os-4 to 9) did not monitor the report of A.Os-10 & 11 and issue pay slip to the beneficiaries through Village Panchayat President and thus caused revenue loss to the Government. The A.Os-10 & 11 did not visit the site properly and submitted their incorrect report as the beneficiaries were completed their stage of construction of the building - for their personal gain.

Further Tmt.Padma Janaki, Present BDO (VP) Chithamur Panchayat Union, (A.O-12) did not monitor online updation work regarding Government housing scheme done by Tmt.Gowri (A.O-13), Project Manager, Chithamur panchayat Union and their staff are utilizing the Government app. by name PMAYG in a lethargic manner and giving wrong information to the beneficiaries / public through the above app. and thus caused revenue loss to the Govt. in the updation of the Govt. Scheme. The above said accused officers along with A-1 Tmt.P.Valarmathi, A-2 Tr.K.Sasikumar and A-3 Tr.Punniyakotti involved in the commission of offences punishable U/s.120B, 420,465,468,471 and 409 I.P.C and section 13(2) r/w. 13(1)(c) and 13(1)(d) of The Prevention of Corruption Act 1988.

Hence I am registering Regular Case in Kanchipuram Vigilance and Anti-Corruption Cr.No 07/AC/2020/KM u/s. 13(1)(c) 13(1)(d) r/w. 13(2) of PC Act 1988, and 120B, 420,465,468,471 and 409 I.P.C against A.O-1 to A.O-13. The original FIR is sent to the Hon'ble Chief Judicial Magistrate cum Special Judge, Chengalpattu.
