Received the information pertaining to the registration of F.I.R. as per the instruction in DVAC Memorandum No. RC.../2020/Coop/RM, dated 28.8.2020 along with copy of Vigilance Commissioner Letter No.784/VC-1/2020-1, dated 13.03.2020 and I register a case in Ramanathapuram Vigilance and Anti-Corruption Crime No.8/2020 u/s 120-B, 167, 409, 420, 465, 468, 471, 477-A IPC and under Section 13(2) r/w 13(1) (c) of Prevention of Corruption Act, 1988 and submit as under. To bring into light compendiously and concisely, the misdemeanors of the marginally noted accused, it is first and foremost to state that the A-1 Tr.R.Poovalingam is working as Secretary from 20.3.2000 in Primary Agricultural Co-operative Society, Kovilankulam, Kamuthi Taluk, Ramanathapuram District, A-2 Tr.R.Madasamy was a Co-operative Sub-Registrar, worked from 30.4.2015 to 11.6.2016 in Primary Agricultural Co-operative Society, Kovilankulam, Kamuthi Taluk, Ramanathapuram District and was placed under suspension from 31.7.2019 which is his superannuation date and not allowed to retire; A-3 Tr.S.Gnanapandi has worked as Field Work Manager in Primary Agricultural Cooperative Society, Kovilankulam, Kamauthi Taluk, Ramanathapuram District from 28.5.2015 to 7.7.2017 and now working as Assistant Manager in Keelakarai Central Branch; A-4 Tr.I.Arumugam has worked as Field Work Superintendent in the above Society from 21.5.2016 to 20.9.2019 and now working as Clerk in Chathirakudi Central Branch; A-5 Tr.G.Sundararajan, worked as Village Administrative Officer of Kovilankulam Group from 27.4.2015 to 2.8.2019 and now working as Village Administrative Officer of Kamuthi Taluk; A-6 Tr.M.Karnan worked as Village Administrative Officer of Ariyamangalam and Idivilagi Groups from 12.9.2011 to 10.8.2015 and now working as Village Administrative Officer of Pakkuvetti Village, Kamuthi Taluk. As such, A-1 to A-6 are public servants as defined under Section 2 (c) of Prevention of Corruption Act, 1988. During the confidential enquiry in Abiramam, Kamuthi East, Kamuthi West, Kovilankulam and Perunazhi Firkas of Kamuthi Taluk, Ramanathapurma District, it was found from the documents in G.O.Ms.No.209,

ABREARCE AND ANTI-CORRUPTION RAMANATHAPURAM. Agriculture (AP6) Department, dated 22.8.2017, Prime Minister's Fasal Bima Yojna Scheme, the Accused 1 to 6, created false documents and misappropriated Rs.17,99,530/- and thereby they made financial loss to Government. On verification of documents, it was found that some of land owners are residing in outer area. Accused 1 to 6 conniving with each other, mentioned the lands in Survey Nos.127/3, 295/3, 118/A2, 357/6, 306/2A, 12/3A, 197/2A, 398/2, 157/1, 315/3, 212/6, 398/3 and 257/1 as Nanja land and claimed Crop Insurance in the names of the family members and relatives of A-1 but originally all the above lands are barren and Kattukaruval and the original land owners are living in other stations who are unaware of crop insurance. Moreover, it was found during the enquiry the A-1 with the active connivance of Accused 2 to 6 by creating false records, claimed crop insurance in the names of A-1's family members and relatives and caused loss to the Government to the tune of Rs.17,99.530/- Therefore, A-1 to A-6 in order to get pecuniary advantages and thus conspired together and for that purpose each one helped each other in such a way to achieve their common design and thereby caused loss of Rs.17,99,530/- to the Government and the Accused Officers gained the amount wrongfully using the forged records as true and hence there is prima facie sufficient material both oral and documentary to go for a Regular Case. The actual loss would be more as the above loss worked out was from the documents verified in confidential enquiry and many more documents are yet to be verified. Hence, there is sufficient. The above said acts of Accused 1 to 6 would disclose the prima facie offence under Sections 120-B, 167, 409, 420, 465, 468, 471, 477-A IPC and under section 13(2) r/w 13(1)(c) of Prevention of Corruption Act, 1988.

Considering the above given materials, I registered a case in Ramanathapuram Vigilance and Anti-Corruption in Crime No.8/2020 u/s 120-B, 167, 409, 420, 465, 468, 471, 477-A IPC and under section 13(2) r/w 13(1)(c) of Prevention of Corruption Act, 1988 on 21.11.2020 at 11.45 hours.

The original F.I.R. is submitted to the Chief Judicial Magistrate/Special Judge, Ramanathapuram and copies were sent to the officers concerned.
