continuation of Tirunelveli V&AC Cr.No.10/2020: Vallam, Senkottai Taluk, Tirunelveli District (Now Tenkasi District) addressed to the Director, Vigilance and Anti-Corruption, Chennai, a Preliminary Enquiry was conducted in PE.210/2018/ADW/TI and it disclosed the following information.

Tr.Gandhi is working as Hostel Warden, Adi-Dravida Students Welfare Hostel, Atchanputhur, Tenkasi Division, Tirunelveli District (Now Tenkasi District) from 01.10.2018. He is a Public Servant within the ambit and purview of section 2(c) (1) of the Prevention of Corruption Act, 1988. He had purchased immovable properties on 12.03.2012 and 04.07.2012 to the tune of Rs.5,65,600/- in his name vide document numbers 467/2012 and 1245/2012 respectively registered in the Tenkasi Joint Sub-Registrar No.1 office. He had constructed a house at Ayan Punjai Survey No.614/1, Ilanji Village, Tenkasi Joint Sub-Registrar No.1 Range, Tenkasi Registration District, after getting building plan approval from Ilanji Town Panchayat as per Ka.ma.No.60/2008-09, dt.03.06.2008 to the tune of Rs.7,00,000/- and had constructed the house to the value of Rs.42,65,481/- without getting any prior permission from the department.

Hence, the check period has been fixed from 01.06.2008 to 30.07.2012 for the purpose of quantifying the Disproportionate Assets.

The AO Tr.Gandhi is in possession of pecuniary sources of movable and immovable such as properties two wheeler in his name, gold ornaments of his wife, bank balance in his name and the house site in his name, totally acquiring to the tune of Rs.9,17,970/- as on 01.06.2008 i.e., at the commencement of the check period.

The AO Tr.Gandhi is in possession of pecuniary sources of movable and immovable such as properties two wheeler in his name, gold ornaments of his wife, bank balance in his name and in the name of his wife, house sites and agriculture land in his name and also constructed house at Ayan Punjai Survey No.614/1, Ilanji Village, Tenkasi Sub-Registrar No.1 Range, Tenkasi Registration District to the tune of Rs.58,68,186/- as on 31.07.2012 i.e., at the end of the check period.

The AO Tr.Gandhi and his wife have received income by way of salary from the Government and from housing loan from bank acquires to the tune of Rs.36,29,674/- during the said check period.

The AO Tr.Gandhi had incurred expenses in the form of family expenditures, purchasing of lands with documents charges, paid charges in Ilanji Town Panchayat, repayment of EMI for Bank Loans, subscription amount of LIC policies in his name and his family members to the tune of Rs.12,68,027/- during the said check period.

The likely savings of the AO Tr.Gandhi is (Rs.36,29,674/--Rs.12,68,027/--Rs.23,61,647/-) only during the said check period.

The AO Tr.Gandhi had purchased agricultural lands, house sites at Ilanji village, Two Wheeler maintained balance in his account and the account of his wife, constructed a house at Ayan Punjai Survey No.614/1, Ilanji Village, Tenkasi Sub-Registrar No.1 Range, Tenkasi Registration District to the tune of Rs.49,50,216/- and purchase of immovable properties vide document numbers 467/2012 and 1245/2012 during the said check period.

The AO Tr.Gandhi had acquired assets in his name and in the name of his wife to the tune of Rs.25,88,569/- in excess against the known sources of income.

Thus the AO Tr.Gandhi from 01.06.2008 to 30.07.2012 was in possession of pecuniary resources and properties to the tune of Rs.25,88,569/- disproportionate to his known sources of income.

The above information discloses the commission and omission of the acts committed by the AO Tr.Gandhi which constitute the cognizable offence of criminal misconduct by a public servant as defined u/s 2(c) (1) of Prevention of Corruption Act, 1988.

Hence, I am registering a case in Tirunelveli Vigilance and Anti-Corruption Detachment Crime No.10/2020 u/s 13(2) r/w 13(1) (b) of the Prevention of Corruption Act, 1988, as amended by Act 2018 at 11.30 hours today (18.12.2020) against the AO Tr.Gandhi for the aforesaid offence for the purpose of investigation.

The Original FIR is submitted to the Special Court for Prevention of Corruption Act Cases, Tirunelveli and copies submitted to the concerned officers.
