## ATTACHMENT TO COLUMN NO.12 OF THE FIRST INFORMATION REPORT IN VIGILANCE AND ANTI-CORRUPTION, SALEM DETACHMENT CRIME NO.11/AC/2020

The accused A-1 Tr.P.S.Ashokan was previously working as Sub-Registrar, Valapady Taluk, Salem District during the relevant period dated from 01.06.2015 to 24.07.2018 and now working as Sub-Registrar (Admin.) OD at the office of the Assistant Inspector General of Registration, Salem West, Salem District.

The accused A-2 Tr.P.Parthiban, S/o Pandurangan is a Document Writer in the office of the Sub-Registrar, Valapady Tlauk, Salem District and having 'A' Class Document Writer License bearing No. A/1800/99/SLM.

The accused A-3 Tr.B.Lazar, S/o Bilavendran of Valapady Taluk, Salem District is the Real-Estate businessman. The accused A-4 Tr.M.Arunachalam, S/o Murugan, residing at No.78 Ganapathi Goundar Street, Valapady Taluk, Salem District.

The accused A-5 Tr.V.Ganesh was previously working as Executive Officer in Valapdy Selection Grade Town Panchayat, Salem District during the relevant period dated from 08.09.2016 to 28.02.2019 now Executive Officer, Madambakkam Special Grade Town Panchayat, Chennai.

The accused A-1 and A-5 are public servants as defined u/s 2 (c) of the Prevention of Corruption Act, 1988 and A-2 to A-4 are Private Individuals.

It is ascertained that A-1 to A-4 hatched a criminal conspiracy during the month of November 2017, to execute a false document in order to evade the stamp duty, A-3 fabricated a false document as if he was selling only the vacant plot in Plot No. 29 & 31 of Jayam Nagar Layout, Valapady with the assistance of A-2, the Document Writer and prepared incorrect document without mentioning the two storied building.

It is further ascertained that, A-4 purchased the house, knowing the fact that the existence of the two storied building as if it is a vacant site and A-1, being public servant, abused his official position, by receiving illegal gratification, registered the document in Doc. No.3843/2017 dated 30.11.2017 and thereby the accused A-1 to A-4 evaded the Stamp Duty to a sum of Rs.2,63,318/- to the government and thus caused wrongful loss to the government and cheated the government.

Further it is ascertained that, A-4 taking advantage of the sale deed, applied for approval of the building in the office of A-5 and remitted the relevant fees. Accordingly A-5 approved to construct the building in 1068 sq.ft in ground floor and 545.13 sq.ft in first floor vide his proceedings Nos. Mu. Mu. No. 609/2018 dated 17.10.2018 and Mu. Mu. No. 622/2018 dated 29.10.2018 respectively, for the already existing / constructed building and also approved the blueprints, in violation of the G.O.78, Housing Urban Development (UD4(3) Department, Chennai dated 04.05.2017 by taking illegal gratification and committed official misconduct.

The above said information discloses the commission of cognizable offences punishable u/s 120-B, 420 IPC and u/s 7, 13(2) r/w 13(1) (d) of the Prevention of Corruption Act, 1988, by A-1 and u/s 120-B, 420 IPC and u/s 7, 13(2) r/w 13(1) (d) of the Prevention of Corruption Act, 1988 r/w 109 IPC by A-2 to A-4. A-5 appears to have committed offences punishable u/s 7 (a) of the Prevention of Corruption amendment Act 2018. Prior permission for the registration of the case against A-1 and A-5 were obtained from the competent authority.

Hence, today 18.11.2020 at 11.00hrs I registered a case in Salem V&AC Cr.No.11/AC/2020 u/s 120-B, 420 IPC and u/s 7, 13(2) r/w 13(1) (d) of the Prevention of Corruption Act, 1988 r/w 109 IPC against A-1 to A-4 and u/s 7 (a) of the Prevention of Corruption amendment Act 2018 against A-5.

Original FIR is submitted to the Hon'ble Special Judge for trial of cases under Prevention Corruption Act Court, Salem and a copy of FIR is submitted to the Director, Vigilance and Anti-Corruption, Chennai.
