A-2 Tr.C.Paramasivam worked as Panchayat Secretary in Nilaiyur Bit.I Village and A.3 Tr.G.Azhagu worked as Panchayat Secretary in Perungudi Village in Thirupparankundram Panchayat Union and as such they are public servants as defined u/s 2 (c) Prevention of Corruption Act 1988 and A-4 Tr.L.Annamalai is a private individual.

On credible information, it is alleged that the above said A-1 to A-3 colluded with the A-4, has created bogus records and false bills and misappropriated the Government fund, which was allotted for the purchase of electrical goods and spare parts to carry out the repair works of electric motor, street lights, water tap connection in Nilaiyur Bit.I and Perungudi Panchayats, Thirupparankundam Panchayat Union, Madurai District. In this connection, a Preliminary Enquiry was conducted as per the orders of the Directorate of Vigilance and Anti-Corruption in PE 31/2019/RDP/MU, dated 13.6.2019 and the following facts were brought to light.

In G.O.Ms.No.157 of Rural Development and Panchayat Raj (SGS.3) Department, dated 21.12.2015, guidelines were issued as fixing the revised rate of ceiling for annual maintenance charges for hand pumps, power pumps and street lights in Village Panchayats. As per guideline, the maximum ceiling of annual maintenance expenditure for one hand pump is Rs.1,000/-, Rs.7,500/- for 2 HP Electric Motor, Rs.10,000/- for 5 HP Electric Motor, Rs.12,000/- for 7.5 HP Electric Motor, Rs.50/- for changing of tube lights and

sodium vapour lamps and Rs.25/- for changing of chokes, starters and condensers. The Village Panchayats can incur expenditure by passing a resolution in the council within the ceiling. Whenever expenditure exceeds the ceiling limits, estimate should be obtained and tender procedure should be duly followed in such cases. Separate registers should be maintained at the Village Panchayats for maintenance of hand pumps and power pumps. The date and amount spent for each hand pump / power pump should be recorded in the Register.

During the financial year 2016-2017, after the regime of Panchayat Presidents, A.2 Tr.Paramasivam, A.3 Tr.G.Azhagau and A.4 Tr.L.Annamalai (Private Individual), in connivance with A.1 Tmt.Alamelammal, prepared bogus bills and vouchers in various names of electrical shops and engineering works as if electrical goods were purchased and repair works were carried out in hand pumps, electrical motors, used the bogus bills as genuine, and misappropriated the Government funds to the tune of Rs.96,320/-in Perungudi Panchayat and Rs.3,56,580/- in Nilaiyur Bit. I Panchayat and swindled the Government fund to the tune of Rs.4,52,900/-.

Further on verification, some cash bills and vouchers were found in sanctioned bills, in fictitious names as if purchase of certain electrical materials from particular shops and withdrawn the amount from bank. Concerned shop owners informed that they have not issued the bills, but the format of bills seems to be their shops. They have issued only quotations to them, but they neither supplied materials to panchayats nor received any

cash or cheque from the panchayats. The above incident reveals that no materials were purchased and no repair works were carried out, but the Government fund was misappropriated by the Accused.

Further, the above said facts reveals that the Accused prepared bogus bills and false vouchers so as to make it as genuine and used the above said bills and false vouchers for the purpose to swindle the Government fund and committed criminal breach of trust and thereby misappropriated the amount to the tune of Rs.4,52,900/- in Nilaiyur Bit.I and Perungudi Panchayats.

Further on verification, it is learnt that 8 cheques for about an amount of Rs 2,00,000/- were deposited in the bank account of A-4 Tr.Annamalai and the same were credited in the S.B. Account of A-4 Annamalai.

Thus, the above said facts would disclose the fact that during the year 2016-2017, A-1 Tmt.V.Alamelammal, A-2 Tr.C.Paramasıvam, A-3 Tr.G.Azhagu, as public servants and by using their official positions in connivance with A-4 Tr.L.Annamalai (Private Individual) and by corrupt and illegal means, committed cheating and criminal breach of trust by swindling the Government funds to the tune Rs.4,52,900/- by making forgery, falsification of records, using the forged documents as genuine, which would disclose the prima facie offences committed u/s 109, 120-B, 406, 409, 418. 467, 468, 471 IPC and 13 (2) r/w 13 (1) (c) and (d) of Prevention of Corruption Act, 1988.

Hence, I registered this case against A.1 Tmt.V.Alamelammal, formerly Special Officer / Block Development Officer (Village Panchayat), Panchayat Union, Madurai District, Thirupparankundram Tr.C.Paramasivam, formerly Panchayat Secretary, Nilaiyur Bit-I, A-3 Panchayat Secretary, Perungudi Tr.G.Azhagu, formerly Thirupparankundram Panchayat Union and A-4 Tr.L.Annamalai, s/o Lakshmanan (Private Individual), in Madurai V&AC Cr. No. 12/2020 u/s 109, 120-B, 406, 409, 418, 467, 468, 471 IPC and 13 (2) r/w 13 (1) (c) and (d) of Prevention of Corruption Act, 1988 on 22.12.2020 at 15.00 hrs.

The original FIR is submitted to the Special Judge, Trial of Cases under Prevention of Corruption Act, Madurai and copies were sent to the officers concerned.
